That I have never made a first-class place out of the lease, and it was offered to the district under exactly the same terms and conditions it had previously enjoyed. What made Bradbury, Jacob and Thomas sore was that they did not have the opportunity to oust the old tenants and sell the lease to The Klamath News for a small sum. Speaking of men being fair and just, I wonder how Bradbury, Jacob and Thomas would like to be treated as they planned to treat our tenants. Tenants who came in and helped us when we had been ordered out of Mr. Murray's buildings and we had no other place to go.

I could go on citing and explaining the facts of a great number of the present administration statements, which they well know are absolutely wrong. No doubt, I am wrong in some of my opinions on some questions, but one thing I can assure you of is that there is little chance for you to go wrong if you will select good, honest, competent men to conduct your business.

Every one of you know that the real issue is the selection of competent men to conduct your district affairs. Think this matter over carefully. Don't be swayed by hot air.

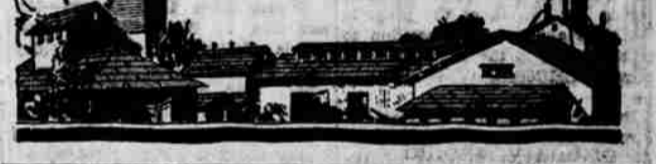
