PLAYERS-LASKY CASE REOPENED

Mary Pickford Alleged to Have Been Offered Big Sum to Quit Movies

WASHINGTON, Nov. 24.—(United News)—Methods of Adolph Zukor, head of the Famous Players-Lasky corporation, were compared to those of the western bandit by H. W. Fuller, chief counsel for the federal trade commission, in opening the government's anti-trust case against the giant movie concern.

Fuller charged Zukor is the master mind of the alleged movie monopoly, and presented evidence obtained in the commission's four-year investigation of the movies.

He asserted that Zukor has attempted to destroy First National pictures by obtaining control of theaters, and that he had offered J. B. Williams, organized of First National twice his salary to join the Zukor organization.

"Zukor reminds me of the western bandit without a mask or a pistol, who enters and says, 'stick 'em up,'" Fuller said.

Zukor controls 73 stars, Fuller said. He charged that Zukor offered Mary Pickford \$250,000 to leave the picture business.

OIL STOVE BURNS 3 PERSONS DEAD

Father, Son and Daughter Die in Fire When Home Is Destroyed

PORTLAND, Nov. 24.—(United News)—Three lives are lost because an oil stove that had been used to heat the mash in distillation of moonshine became overheated Monday night and destroyed the little home occupied by Floyd Camp, his wife and his three little children.

Police and fire marshals are trying to discover whether the still, the ruins of which were found in the charred debris, was in operation when the flames broke out.

The dead are the father, who undoubtedly lost his life in trying to rescue his terrified young son, from his fancied refuge under the bed; the son, Douglas, 4, and daughter, Elizabeth, 7.

Saved were Mrs. Camp and the youngest child, Catherine, whom she dragged from the flaming kitchen.

High Seas Prevent Search for Bodies

HONOLULU, Nov. 24.—High seas and rain are hindering the 50 enlisted men who have been detailed to search for the bodies of Capt. Karl Gorman and Lieut. Howard Brandt, drowned when their Martin bomber fell into the ocean off Waimea.

The wrecked plane was washed up on the beach Tuesday afternoon, but at sunset no success had been registered in the search for the flyers' bodies. The hunt will be continued Wednesday it was said at army headquarters.

Soldiers Saved From Drowning

HONOLULU, Nov. 24.—(United News)—While attempting to swim out from shore and recover the bodies of Capt. Karl Gorman and Lieut. Howard Brandt, aviators drowned yesterday, two enlisted men today became exhausted and were saved from drowning by a navy tug.

An aviator reported that the bodies were seen floating a short distance from the shore yesterday. Three enlisted men believed they could bring them in without assistance.

Search for the bodies was resumed at dawn, the searchers using small navy craft and airplanes. The plane in which the flyers fell has not been sighted.

REBELS BURN CITY

BEIRUT, Nov. 24.—United News Druse rebels burned Rashpeya and occupied the surrounding territory following an attack upon the French garrison in the citadel. The French shelled the attackers and held their fort.

Two thousand French reinforcements are rushing to Rashpeya from Raynk.

OLD PARTY HEADS LAUNCH FIGHT ON BOY PROGRESSIVE

LaFollette and Nye Under Attack

VALIDITY QUESTIONED

Nye May Be Given Challenge As Name Goes Up Before Congress

WASHINGTON, Nov. 24.—Regular republican leaders in the senate have begun preparations for the first important political battle in the new congress, the attempt to exclude from the majority group the two boy progressives, Robert M. LaFollette of Wisconsin and Gerald Nye of North Dakota.

Republican leaders announced Tuesday that when Nye goes to the vice-president's desk to be sworn when congress convenes December 7, his right to the seat of the late Senator Ladd, will be challenged and that the case will then go automatically to the committee on privileges and elections for inquiry. They believe that Gov. Sorlie, acted without authority in appointing Nye, holding that the North Dakota legislature never has conferred that right.

Senator Watson of Indiana, chairman of the committee on committees announced that his committee would meet in a week to decide whether the son of the late Wisconsin insurgent was entitled to a place in the regular organization in his committee assignments. Watson is collecting young LaFollette's campaign speeches and these will be studied to determine whether he has criticized President Coolidge and the regular republican policies.

RUTLEDGE FREED ON FRAUD CHARGE

Accused of offenses of various natures, several persons were arraigned in the local justice court yesterday. One of the cases, that of W. M. Rutledge, charged with obtaining money by false pretenses, was dismissed. Officers said they believed Rutledge innocent of any intent to defraud.

E. O. Lord, charged with operating an automobile on which there were void foreign license plates, entered a plea of guilty. He was fined \$15.

Harry W. Regan, accused of speeding, entered a plea of guilty and was assessed a fine of \$15. The heaviest fine of the day was paid by M. Dalala. He was accused of speeding, pleaded guilty, and paid \$25.

Twenty dollars was the assessment meted out to C. U. Vochatzer, charged with speeding. He, too, pleaded guilty.

G. W. Evans, pleaded guilty to a speeding charge and was fined \$20, while A. E. Adelsperger, admitting that he was guilty of speeding, paid \$10.

Most of the offenders were taken into custody by officers during the past week-end.

OLD-TIME DUEL FOUGHT BY MEN

Farmer Falls Mortally Hit By Bullet from Opponent In Presence of Crowd

DURANT, Okla., Nov. 24.—A pistol duel with the tinge of old-time romance resulted in the death of Charles Smith, farmer, and the arrest of Granville Todd, his slayer, on a charge of murder, here Tuesday.

The two men, accompanied by eight witnesses, were called to the farm of H. B. Ishman, to settle accusations Todd is said to have claimed that Smith made against the reputation of Ishman's daughter.

While the eight men looked on, Smith and Todd stood back to back, walked in opposite directions, and at a signal turned around and fired. Smith fell mortally wounded. Todd surrendered to police. He will be tried for murder.

SMITH BUILDING TO BE HOME OF COMMUNITY BOX

Chest Donations and Gifts To Be Carried on Under Central Depot

Plans for the community chest are rapidly taking shape with the establishment of headquarters in the new Smith building on Fifth and Klamath. Mrs. E. R. Vance will be in charge of chest headquarters, where provisions and clothing will be received and distributed. It was announced yesterday. A truck will be sent out to gather up all volunteer donations, states George Lindley of the American National bank. The truck will also receive cash contributions for chest purposes.

"We are hoping," said Mr. Lindley, "that many contributions of cash, clothing and food will be made without solicitation. None of us actually have the time to solicit these donations, and we believe that people who are interested in doing their good turn will either telephone for us to send the truck around for what they have in the way of supplies or will come in and give us what they can afford in cash. Klamath Falls has never failed when called upon and since we all believe that charity begins at home, the Community Chest fund is sure to meet with success."

TOLEDO CLUBBER KILLS 2, SLUGS 7 WOMEN IN STREET

Armed Poses Search For Murderer

CITY TAKES ACTION

Council, Newspapers and Club Offers Reward For Arrest

TOLEDO, Ohio, Nov. 24.—(United News)—Toledo set out again tonight to capture the mysterious maniac who has murdered two and bludgeoned seven of its women.

Rewards totaling \$1,600 added zest for the hunt which was being participated in by 500 armed officers and uncounted volunteers.

The favorite ambush spots of the clubber, who has struck terror into the hearts of all Toledo women and girls, were given special attention. These included dark runways between houses, pitch dark streets, the dark sides of trees and other black shadows.

Although the clubber has failed to strike since Saturday evening, when the furor against him first reached its height, several women have claimed to have seen him since that time, and the belief that he has been frightened to his lair has not slowed the search.

The city council has authorized a reward of \$1,000 for information leading to the arrest and conviction of the thug; the Toledo News-Bee had previously offered \$500 reward, and the Toledo Automobile club \$100.

WATERWAY BLOC HELD ASSURED

Definite and Final Action On 10,000 Mile Project Promised for Year

ST. LOUIS, Nov. 24.—(United News)—Definite and final action by the next congress on the proposed lakes-to-gulf waterway project" was demanded in a resolution adopted late Tuesday by the Mississippi Valley association in convention here.

Twenty-six middle western states are thus committed to back the plan, which has been handled about in congress and the midwest for more than a generation.

The resolution was adopted following an address by Congressman Newton.

Newton said a waterway bloc would be established immediately in congress to assure appropriations for the completion of the 10,000 miles of internal waterways within a short time.

Italian Election Planned for 1927

ROME, Nov. 24.—(United News)—Premier Mussolini has postponed the next Italian election to 1927, according to deputy Amicucci, an intimate friend of the premier. That would give Mussolini 62 years more in office if he lives that long.

"One cannot talk of elections until 1927, when the last cent has been paid to the United States," Mussolini is quoted as saying.

KLAMATH EXHIBIT PLANNED FOR N. Y.

Chamber of Commerce Heads Discuss Exploitation For Next Year

Klamath county may be represented when the hundreds of exhibits are ready at the Pacific Northwest Commercial & Industrial exposition, to be held at the new Madison Square Gardens, New York city, if the sentiment expressed by a number of directors of the chamber of commerce, who met yesterday noon, may be taken as indicative of the county's viewpoint.

The exposition, which is expected to be visited by many thousands of persons, many of whom have capital to invest, is to be held May 10-23, 1926.

It was suggested at yesterday's meeting that a topographical map of Klamath county be prepared, which might be displayed on such occasions. No formal action was taken at the gathering yesterday.

Resolutions which formerly had been adopted by the board of directors, favoring a world court, are to be forwarded to Oregon's United States senators, it was decided.

Members of the board all seemed to feel that every effort should be made this winter to keep the streets of Klamath Falls in better condition than they were a year ago.

Bend Will Fight Water Injunctions

BEND, Nov. 24.—Bend will fight both injunction suits filed against it last week in connection with the proposed municipal water system. It was announced Tuesday by City Attorney C. S. Benson. The validity of the charter amendment, authorizing the issuance of \$600,000 in bonds for acquiring and constructing the water system is at issue in the first of these suits, and for that reason a defense will be interposed by the city because of the bearing this question may have upon future questions.

The city is not particularly concerned with the validity of its contract with Ladd and Tilton and associates, but is concerned with the status of the charter amendment. The city has until Saturday to file an answer.

GOLET MERGER JURY FAILS ON AGREEMENT

OAKLAND, Nov. 24.—The jury in the Golet oil merger trial was discharged tonight, unable to reach an agreement after deliberating since last Friday.

The four defendants in the case were Edwin F. Reeves, his wife, Mrs. Peggy Reeves, Franklin P. Davis and C. E. Peacock.

They were charged with grand larceny and swindling bay region investors out of approximately \$600,000 by selling stock in a scheme which purported to be an \$800,000,000 merger of independent oil companies.

AMERICAN MONEY TO FINANCE RAIL LINE IN MEXICO

Sonora - Tiajuana Is Project Named

FUNDS ARE PROCURED

Proposed Road Connecting Link Between Chihuahua And West District

SAN DIEGO, Nov. 24.—United News—American capitalists will finance the construction of a new railroad from Tiajuana to the state of Sonora, Mex., according to a statement made today by governor Rodriguez, of the northern district of lower California.

Several million dollars is available for the project and American financiers have promised to furnish all funds necessary. Rodriguez stated today in a statement made public at Mexicali.

The Tiajuana-Sonora road will, if completed, be an extension of the projected railroad from Sonora to Chihuahua, for which the Mexican government is said to have appropriated 25,000,000 pesos.

President Calles, of Mexico is said to have arranged for the financing of the latter line during a conference with three American transportation heads in Chihuahua last week, it was stated.

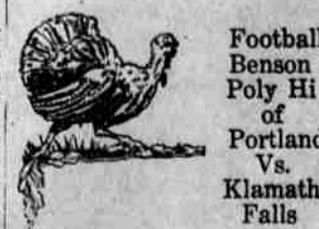
Arrested on a charge of stealing cream, Barnhill admitted that for ten years he had stolen two gallons a day and with the money realized from the sale had purchased his home and car.
