

### Klamath Forges Steadily Ahead Industrially

#### Stands Fourth in Cities of State Regarding Amount to be Expended in Providing New Buildings

Klamath Falls stood fourth in the cities of the state for the first six months of the year as regards the number of building permits issued and the total sum to be expended in construction of new buildings.

Portland, the largest city in the state, led with 6710 permits totaling \$17,257,076; Salem was second with 299 permits totaling \$1,458,026; Eugene was third with 270 permits totaling \$997,825, and Klamath Falls was fourth with 491 permits totaling \$913,437.

The above figures are furnished by S. W. Straus & Co., in the National Monthly Building Survey, Pacific coast section.

Klamath Falls should make even a better showing during the second half of the year, and which will most likely result in the city taking second place, only to be led by Portland for the year. This will be brought about as a result of the railroad construction campaign that seems assured, a permit calling for \$325,000 having been awarded last Saturday for the terminal buildings to be constructed by the Southern Pacific company.

#### DAIRY STOCK TO BE TESTED FOR TUBERCULOSIS

Nearly 400 head of dairy and stock cattle will be tested in Klamath county for tuberculosis during a three-day tour of the dairying and stock ranches. The test is under the supervision of Dr. G. H. Thompson, U. S. Bureau of Animal Industry, Portland, who is assisted by Ray Lawrence, assistant county agent under C. A. Henderson. During the period, Olene, Swan Lake, Pine Grove, Poe Valley, Bonanza, Langell Valley, Hly and Sprague River herds will be examined.

### Capt. Applegate Picture Shown in Bay City Paper

Featuring a story on the mammoth "Trail to Hall" celebration to be held in Eugene August 19 and 20, the San Francisco Examiner of July 11th tells the life history of Captain O. C. Applegate, pioneer resident of Klamath Falls. A picture of the Captain garbed in his fur hat, and famous buckskin coat which he wore in the Modoc wars is shown in which he is talking with Chief Sky, of the Klamath tribe.

Captain Applegate will participate in the Eugene celebration and will lead a band of Indians in native tribal dances. He speaks four Indian tongues and besides being elected to the Modoc and Klamath Indian tribes, the name "Blivas," meaning Golden Eagle, was bestowed upon him. This is one of the highest tokens of affection with which the Oregon Indians can honor one of their tribe.

The article tells how Applegate's father was the first Indian agent of Oregon, and of the son's military achievements in the Indian wars. It also states that commercial and industrial organizations of Eugene, Klamath Falls and Portland, will be represented by floats in the parades. Special delegations from these cities and San Francisco and Oakland will be present.

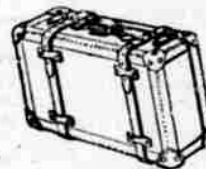
