

Pelicans Have Many Boosters Today's Battle

Intent on a decisive victory which will allow them to return home tonight tied with Medford for second place in the Southern Oregon league, the Klamath Pelicans will leave here this morning to meet the Peapickers on the latter's home green at Medford.

Under the influence of their present high spirits, gained from last Sunday's victory, the Pelicans ought to win all the rest of their games this season, was the opinion expressed by Manager Duback last night. The local boys had a good run of workouts this week, in which they exhibited the peppiest practice for many weeks, and if the old machine continues to operate in its present condition, Duback's opinion will bear lusty backing.

The line-up, so far as can be seen at present, will remain the same as last Sunday, with Gunner Peterson stopping the string of question marks which Davidson and Sanders send across the plate. The fact that all the men have full confidence in their present twirlers, as well as in their own respective abilities, gives them a good lead to start the game with today.

Administration Is Facing Criticism Mexican Situation

WASHINGTON, July 31.—(United Press)—Facing increasing criticism because of its hands off policy in the Mexican-Catholic controversy, the state department continued its neutral stand today. President Coolidge and Secretary of State Kellogg are agreed that the Mexican struggle in its present state is merely an internal affair in which the United States has neither the desire or right to interfere.

Demands of American Catholics and certain commercial concerns that the United States take a part in the controversy are beginning to bulk large in the state department and White House files.

An official statement from the summer White House that the embargo on arms to Mexico will not be lifted at this time is quoted by officials here as final so long as the religious peace of that country is threatened.

Chamber Deputies Approves Report Premier Poincare

PARIS, July 31.—The chamber of deputies tonight adopted Premier Poincare's financial project by a vote of 295 to 188, thereby expressing confidence in the coalition cabinet and authorizing the premier to increase all taxes and to legislate by decree for the effectuation of essential economies.

Warning the chamber that each minute's delay meant a loss of 11,000 francs, or approximately \$330 to the state, Poincare forced the projects through the chamber with the speed and precision of an officer maneuvering troops. The day was distinguished by a minimum of debates, booring and heckling by communists, and a statement by Poincare that there was no question of debts for "France never dreams of repudiation."

Boot to Boot Wins Homewood Derby Classic

HOMWOOD, Ill., July 31.—(United Press)—Five thoroughbreds of only average quality competed at Washington Park race track this afternoon for one of the richest stakes ever offered in America.

E. R. Bradley's Boot to Boot won and put himself only about \$2000 behind the champion, Crusader, as the leading money winner of the year. The winner's share was \$89,000 and made Boot to Boot's total \$11,950. The time was 2:30 1-5. The race was worth \$104,200 altogether. W. J. Salmon's Preakness winner Display earning \$10,000 by coming second. W. R. Coe's filly, Black Maria, ran third and won \$5000.

Uncertainty as to the date of the race, and skepticism of horsemen, about the \$100,000 purse actually being offered, kept the country's best horses from being entered. The winner paid \$6.60 and \$3.80. Display was \$3.20. There was no show betting.

CALIFORNIA WOMAN WINS WASHINGTON TOURNEY

Dempsey Departs On Eastern Trip To Begin Work

NEW YORK, July 31.—(United Press)—Jack Dempsey, en route to his training camp at Saratoga Springs, N. Y., is expected here next week. He leaves Colorado Springs tomorrow. Arrangements for his training routine, sparring partners and other matters, are in the hands of Gene Normie, Dempsey's friend and adviser, who expects to have these details completed soon, despite the fact that the license commission here has not finally passed its official approval on the Dempsey-Tunney match.

Word of another obstacle in the path of the match—an application for an injunction restraining Dempsey from fighting under a contract Rickard filed in Denver by counsel for B. C. Clements, Chicago, who is taken very lightly by Dempsey and his associates.

Madison Square Garden officials also continued with their plans. Batches of orders for tickets have been placed with Rickard's office.

MAIDSTONE TENNIS CLUB, Easthampton, N. Y., July 31.—California's two most celebrated women tennis stars, Helen Wills, national champion, and Mary K. Browne, a champion more than ten years ago, will meet in the final round of the fashionable Maidstone tournament here tomorrow.

Miss Wills survived the semi-final round today after a hard fight against Mrs. Edna Rooser, and she was pressed to win at 6-3 and 9-7. The young champion was so used up physically in the final games of the second set that it looked as if Mrs. Rooser might not only take the set, but was working into a good chance to take the match.

The usual contest of the champion's hard strokes was missing, and Mrs. Rooser, following tactics of only keeping the ball in play, took every advantage of her opponent's errors. There was much speculation here tonight about what tactics Miss Browne would pursue tomorrow. They are such close friends that some thought Miss Browne would not have the heart to discourage the youngster who is making the effort of her life to get her game back on edge to defend her title at Forest Hills.

Miss Browne, Miss Elizabeth Ryan and Mrs. Molla Mallory will give Miss Wills a most severe test at Seabright, where she goes next week.
