

### Colonel Ned Green Will Begin Today

SAN FRANCISCO, Dec. 6, (U.N.)—Trial of Colonel Ned Green, former prohibition director, who was accused of diverting seized liquors to his own use, will begin Tuesday. Mrs. Mabel Walker Willebrandt, assistant United States attorney general, is to direct the case against Green. A sudden trip to Los Angeles led to reports that she had

failed to agree with the United States attorney here on the handling of the prosecution, but it was announced late today that she would return in time for the trial, "ready to push the case to the limit."

The disclosure that Assistant Secretary of the Treasury Andrews has prepared a character deposition to be used in behalf of Green, with whom Andrews served overseas during the world war also came during the day.

### Fall-Doheny Trial Sees Blue Monday

WASHINGTON, Dec. 6, (U.N.)—Blue Monday brought more woes for the ageing defendants in the Fall-Doheny oil conspiracy.

Albert B. Fall learned that as soon as he is through being tried for conspiracy with E. L. Doheny he must stand trial on similar charges for his alleged transactions with Harry F. Sinclair. This oil

man obtained the lease on Teapot Dome oil reserve in Wyoming. He also gave extensive financial aid to Fall much as Doheny did. The cases are similar in nature, but involve totally separate transactions.

The supreme court upheld the Sinclair-Fall indictments. Government prosecutors said they would be ready for trial about the middle of January.

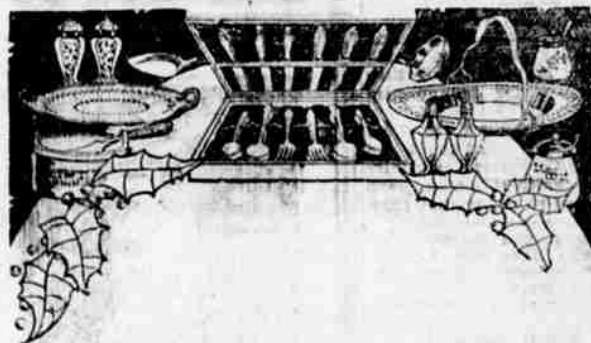
