

Maloney Trounces French Canadian

MADISON SQUARE GARDEN, New York, Feb. 18, (U.N.)—Jimmy Maloney of Boston tonight exploded the myth which has surrounded the prowess of Jack Delaney of Bridgeport, by whipping the vaunted French Canadian throughout ten rounds of disappointing fighting before 22,000 spectators in Madison Square Garden Friday night. By his victory the Boston strong man eliminated Delaney from the list of logical contenders for Gene Tunney's title and earned for himself a bout with the winner of the Mike McGuire-Jack Sharkey contest next month.

But for all the furor which surrounded the contest the customers, many of whom had paid exorbitant prices to speculate hardly got their money's worth. There was not a knockdown nor even a sign of a knockdown during the entire ten rounds.

At the end of the fight the judges decided unanimously that Maloney had earned the decision and even among a crowd in which Delaney had so many warm supporters there was not a single dissenting voice.

The Boston heavyweight, outweighing his opponent by 31½ pounds, took the aggressive at the start and held it throughout.

As for Delaney, whatever was the matter—and he entered the ring a thirteen to five favorite—many all-bits may be expected. The Bridgeport boxer never got under way. Jack said before the fight he wanted Maloney to come to him. Maloney came—and conquered.

Those among the overflow crowd who had wagered as high as three to one that Delaney would win, sat astounded as their man proved woefully unable to get a glove upon the Bostonian.

Maloney had the advantage in seven of the rounds, and in the other three Delaney earned little better than a draw.

Now for the all-bits: Pete Reilly, manager of the defeated light heavyweight champion, said after the bout that Delaney had broken his left thumb in the third round.

Certainly this was one way to account for the distressingly poor showing of the French Canadian.

Although Maloney won handily, thereby effectively disposing of Jack Delaney as a heavyweight contender for the time being, yet the big boy from Boston failed to show real class. If Maloney had been a truly great heavyweight he would have stopped the Delaney whom he met tonight.

Watching Maloney's work against Delaney it was not difficult to picture how easy a victory would have been scored over the Bostonian by the Gene Tunney who met Jack Dempsey and won the title at Philadelphia.

More than 20,000 fight fans crowded the Garden as the preliminaries of the Jack Delaney-Jimmy Maloney fight got under way.

Swarms of bluecoats kept late arrivals outside. It was apparent that the fight, which, at box office prices, could draw not more than \$200,000, had cost New Yorkers and their guests at least an additional \$100,000.

The first preliminary, that between Tracey Ferguson of Wallingford, Conn., 145, and Joe Legrey of Johnstown, Pa., 144, went four rounds. Legrey threw too many gloves for Ferguson and was adjudged winner.

In the second preliminary Helen Bell, 145½ of Los Angeles, seconded by Eddie Huffman, the lightweight contender, met Al Delagaldi, 139, of Harlem.

These boys put on a ripening slugging match, in which the bell at the end of the fourth round appeared to have saved the Californian from a knockout. The judges called it a draw, however, somewhat to the disapproval of the crowd, which had its first chance to boo lustily.

Bell was the aggressor but he was outboxed by the New Yorker.

SORDS POINTS The Browns Have at Lease One Rice-ing Young Outfielder

At the writing, Dan Howley, manager of the St. Louis Browns, is still hoping to sign Ty Cobb as a member of his Missouri bearcats. This means that his outfield plans aren't completely settled. However, he is by no means worried over the outer garden situation.

He has three sure fire men for the positions now and two or three other good ones with which to experiment, should his first lineup lack the punch he seeks.

Two men are destined to start the season, whether or not Cobb is signed. They are Harry Rice, with three years of service behind him, and the venerable Ken Williams, home run slugging war horse of the team.

To fill the other berth Howley has Cedric Durst, reformed first baseman; Bing Miller, Hershel Bennett and Fritz Schulte. One might pick a fair outfield from the latter ones.

But to get back to the sure bets. Harry Rice will help form the nucleus of the team which Dan will start building this year. He was one of the mainstays of the team last year, giving every indication of becoming one of the leading outer defense men in the game, if given his chance for a year or two.

Rice, oddly enough, played the infield in the early part of his career.

As a matter of record he played all over the infield.

Started out with Paris, Texas,

in 1922. Received a tryout by the Browns the next spring, but lacked experience and was sent to Danville. It was with that club that he played second, third and short. Late that season Tulsa in the Western league, secured his services under option and it was his batting mark of .403 in 34 games there that caused the Browns to recall him.

In 1924 he labored diligently to beat Gene Robertson out of the third basing job, but couldn't make the grade. The following year Slater moved him to the outfield and it was there he found himself. He not only fielded brilliantly, but hit .359.

Last year he played in 148 games, hit .313 and ranked eighth in fielding.

Rickard Overlooks Lot of Easy Money
