

Walter Johnson Signs to Manage Washington Club

WASHINGTON, Oct. 15. (UP)—Walter Johnson will pilot the Washington Senators for the next three years. The veteran pitcher, who left major league baseball last year after 21 years with the Senators, today signed a three-year contract to manage the team, with Clark Griffith, president.

The "Big Train," who succeeds Stanley "Bucky" Harris, said he was realizing an ambition of many years' standing. Griffith was happy at obtaining him from Paul Block, owner of the Newark International League club, which Johnson managed last season after leaving the Senators. Block permitted Johnson's two-year contract to lapse, on the ground that he did not want to stand in Walter's way if he could secure the managerial post with the Senators.

Johnson's salary for the next three years was not disclosed.

It was a dramatic moment when Griffith and Johnson signed the contract at Griffith stadium office. The veteran pitcher looked longingly out over the empty stands and dugouts and then smiled in the realization of returning to his old "battle ground."

Griffith has assured Johnson he will have complete charge of the team. Johnson has not announced whether he will pitch, but this is left optional under the contract.

cross the Atlantic as is required for the fastest ocean liners.

Sighted at 5 p. m.

But the Graf Zeppelin's flight was none the less important to aviation, and if there was any discrepancy in connection with the flight it was not at all in evidence as the ship came to earth this evening.

It was at 5 p. m. that the first glimpse of the big airship was caught from the roof of the Lakehurst hangar. It was not generally visible to the crowd on the field until 10 or 15 minutes later.

Lands at 5:08

It swung around to a broadside position, pointed its nose directly at the center of the landing field, tacked a bit with the light wind which was blowing, then dipped ever so gracefully and came slowly down to within reach of the ground crew.

At 5:38 the landing lines were thrown overboard from the Zeppelin's cabin and within two minutes the efficient ground crew had seized the lines and brought the silver bag safely to the ground.

Enthusiastic Crowd Shouts

The landing was perfect. The motors raced in a heavy roar as the vessel came down to the field. The roar seemed to loosen the enthusiasm of the large crowd which had been waiting to witness the spectacle and they joined in a shout that competed with the motors.

Police arrangements at the field proved inadequate as a mass of sightseers spent up to get a closer view of the ship. They broke through the police lines and surged close to the Graf Zeppelin.

The welcoming committee sent down by Mayor James J. Walker of New York City, headed by Grover Whalen, had to battle its way through the crowd to reach the side of the Zeppelin.

Admiral Moffatt Greets

Rear Admiral Moffatt and a party of American and German officers, with Capt. Edward J. Jackson, commandant of Lakehurst naval station, escaped the mob scene only because they were well escorted and not in the thickest of the crush.

An enormous shadow was cast across the fast darkening field as the huge dirigible settled to the ground. It seemed to be even larger than the crowd had expected and cries of amazement went up from the throng.

From the windows of the p. l. house, under the forward port of the big bag, could be seen the faces of a dozen or so passengers and members of the crew, pressed against the cabin windows.

Eckener Congratulated

There were two men in each of the five motor gondolas further back along the bag. They waved gallily to members of the ground crew.

Renewed cheers from the crowd went up when the first passenger stepped down from the forward cabin and jumped, apparently with considerable gusto, onto the solid ground.

ficers of the association, there were present H. D. Newell, project manager of the Reclamation department, Ray Steele, federal game warden, Marion Barnes, district game warden, Mike Moteschenbacher, president of the Klamath drainage district, and C. R. De Lap.

A large fire which is now burning in the bog land in Tule Lake, and another which burned through 6000 acres last summer has brought realization to members of the association that strict measures must be taken to combat the cause of these fires, which it is believed, are caused by the carelessness of hunters or people outside the association.

It was pointed out that this land is all posted and hereafter a reward of \$250 will be paid for information leading to the arrest and conviction of anyone caught starting a fire in the territory. The game wardens present at the meeting promised their cooperation in this matter.

Any men arrested by the grazing ranger will be prosecuted for trespassing and hunting.

There are about 70,000 acres of grazing land between the lake and the railroad of which about 40,000 acres is peat land which is good material for a slow-burning fire. A fire which has been burning since October 10 has already burned over 3,000 acres and is causing much expense to the association in an endeavor to get it extinguished. The fire is being fought by dikes and by plowing, and men are on duty day and night.

In order to get grass started on a large area of Tule Lake land which is practically desert Newell expressed willingness to allow enough water through the headgates to cover this land in order to soak the ground and prepare it for pasture. It is believed the water will be spread over the land during February and March. Permission to run this water from the Klamath river through ditches that drain land in control of the Klamath irrigation district was given by Moteschenbacher, stipulating, however, that none of the district's land should be damaged.

Two ordinances could not be passed through the final reading since there was not a quorum present, but inasmuch as the ordinances only authorized the signing of deeds it was not believed important enough to call an adjourned meeting this week. Councilman Lambert and Councilman Peltz were absent.

An application by Warren Hunt for a permit to operate the Park apartments to consist of two apartments, 20 rooms and table board, was referred to the police committee. L. G. Drake applied for a permit to operate the Drake Klamath Recreation parlors at Eighth and Main in the new Murray building, now under construction. Equipment is to consist of one billiard table, two snooker tables, and eight bowling alleys. This matter was also referred to the police committee.

A permit was granted to DeVee Stinton to operate the Bradburn apartments on Pine street. After inspection by the police committee of the Oregon rooms, whose manager recently asked for a permit, it was reported a permit could not be granted till safety ropes were installed in case of fire.

A request was made by 14 property holders to have a light installed at the corner of Look-out and Upham streets, where a dark corner is particularly dangerous to traffic. Five building permits totaling \$4,500 were granted.

Patrolmen Notified

Chief of Police Keith Ambrose then personally notified all officers on beats to watch out for the thief as described by Gould. The description Gould gave tallied with that of Ted Jordan, colored, former porter at the Willard hotel, who had just recently been arrested on a vagrancy charge, and after a stay in jail was told to get out of town.

Officer Ray Lyons and Jeff Fields, a special officer, immediately started searching the houses of the colored people. The first house they visited Fields went to the back door and Lyons to the front door. When Lyons knocked Jordan tried to make his escape out the back way. He was caught and brought to the city hall, where he was searched.

Property Found

The wallet stolen from Gould, with most of the money in it—lacking only a dollar or so—and with the paper and picture of Gould were found on Jordan, who officers believed was trying to get enough money to get out of town. Officers also found a cap pistol, the kind played with by kids on the Fourth of July, but which looked and felt like the real thing in the dark street.

So, 50 minutes after a hold-up a man is in jail, the property is recovered, and the peace of the city is restored.

Will Make Final Attempt to Save Hickman, Rope Set

LOS ANGELES, Oct. 15. (UP)—One more effort to save William Edward Hickman from death on the gallows was planned by his attorneys late today. Governor C. C. Young will be asked to appoint a board of psychiatrists to examine the youth for evidence of insanity. It was announced.

Jerome Walsh, Kansas City attorney, will make the appeal to Governor Young, according to Richard Cantillon of defense counsel.

Little Hope Held

The step was taken as an indication that the attorneys have little hope of commutation of the sentence, in view of the fact that Hickman was convicted of the kidnapping and murder of Marion Parker, 14, and 17-year-old Thomas, a druggist, whose store he robbed.

Thomas Hickman, father of "the fox" planned to leave Los Angeles tonight for Sacramento, where he will interview Young in a last plea.

ROPE IN PLACE

SAN QUENTIN PENITENTIARY, Calif., Oct. 15. (UP)—The rope which the state of California intends to use Friday morning for the execution of William Edward Hickman, cruel slayer of Marion Parker, 12-year-old Los Angeles girl, was in place over the gallows of this prison tonight.

Heavy weights had been placed on the end of it to keep it from kinking, while in a cell nearby Hickman continued to calmly read his Bible and write letters.

Trap Set

The trap had been made ready for the final spring, and nearby lay a black hood and belts to prevent the "fox," Hickman's criminal alias, from fighting off the executioners after he mounts the 13 steps of the gallows, although such opposition was not anticipated by prison officials.

Warden James B. Holohan was still considering the merits of more than 5,000 requests to witness the execution of California's most notorious criminal in this decade. The death chamber would be packed with 200 persons present, and it is doubtful if that many will be "invited."
