

Miami Bout Will Be Fought Under Garden Auspices

NEW YORK, Jan. 12. (UP)—Tex Rickard's wishes will be carried out and the Jack Sharkey-Young Stripling bout will be held at Miami Beach, Fla., Feb. 27.

Through the influence of Jack Dempsey, the Madison Square Garden corporation closed arrangements with Sharkey at Boston today to go through with the bout. It is understood that Sharkey accepted a guarantee lower than \$100,000 Rickard is said to have promised him before the promoter's untimely death.

Up until the time he was stricken, Rickard worked tirelessly planning for the Sharkey-Stripling match, and he talked of it drawing 50,000 persons and a gate of a quarter of a million dollars.

"This bout will be the biggest heavyweight battle staged since the Tunney-Dempsey bout at Chicago," Rickard said at Miami Beach. It will be better than the Tunney-Hooney championship fight.

Rickard believed that out of the Sharkey-Stripling match he would come the next heavyweight champion; Stripling was his choice. From the night he saw Stripling knock out Martin Burke the veteran New Orleans fighter, in Coral Gables, Fla., more than a year ago, Rickard has talked of the Georgia boy as a coming champion.

Gene Sarazen Wins Miami Beach Open

MIAMI BEACH, Fla., Jan. 12. Gene Sarazen, defending champion, came from behind on La Force course this afternoon to win the Miami Beach open championship for the third time, with a score of 286, one stroke ahead of George Christ, of Rochester, N. Y.

Sarazen sunk a 50-foot putt on the home green.

Horse Feed Fight May Stop Races

SAN DIEGO, Calif., Jan. 12. (UP)—Today's race card at the Tijuana track will be run as usual, but Sunday's race program remained in doubt today as horsemen and jockey club officials continued in a deadlock over a feed bill arrangement.

The horsemen contend that a monopoly exists in supplying feed to the horses and demand the right to buy their feed from whom they please. The jockey club officials denied this and the deadlock followed.

An ultimatum was issued this morning giving the jockey club officials until 2 p. m. today to comply with the request. If no agreement was reached by that time, tomorrow's card was to be cancelled and the racing suspended until the club officials agree to the terms.

BRADDOCK TO FIGHT LOMSKI

NEW YORK, Jan. 12. (UP)—James J. Braddock, young Jersey City, light heavyweight, who catapaulted to title fame with his knockout of Tuffy Griffiths, will meet his first major test when he faces Leo Lomski, the Aberdeen, Wash., assassin, at Madison Square Garden Friday night.

The winner will be in line for the light heavyweight title match with Tommy Longhran, the titleholder, who is at present campaigning in the heavyweight division.

Abbott Wins on Foul by Ritchie

Tony Abbott, California heavyweight, won in the fifth round, on a foul, from Earl Ritchie, Klamath heavyweight, in a scheduled two-round main event fight at Eureka, Calif., last night.

There was much argument as to whether or not Ritchie had fouled Abbott, but the referee ruled that the blow was a foul, and awarded the bout to Abbott, according to information received in Klamath Falls last night.

Dempsey Tells Terms of Fight

BOSTON, Jan. 12. (UP)—Plans for the Stripling-Sharkey fight in Florida were announced here tonight by Jack Dempsey after he and William F. Carey, of the Madison Square Garden corporation, had conferred with Sharkey and his manager, Johnny Buckley.

Sharkey's share of the gate will be about \$100,000, while Stripling will receive 20 per cent of the gross receipts. Dempsey announced that 50 per cent of the net profits would go to Rickard's widow.

Sharkey and Stripling must start training not later than February 1.

Pelicans Down Normal Five for Another 43 to 26

PELICAN CITY, Jan. 12.—In a game that was featured more by the brilliant playing of those on the court rather than precision of team work of either squad, the Pelicans of the Pelican Bay Lumber company downed the Ashland normal for the second time in as many days, Saturday night on the Pelican court by a score of 43-26.

While the steady display of smooth teamwork that characterized the first meeting of the two teams was lacking on the part of the Pelicans, the individual flash of the solid-shirted men made down the floor to garner spectacular baskets succeeded in bringing a much larger margin than had been made the preceding night.

Wenner, Anderson, Peterson, Benson and Wakeman engaged in a scoring spree that found Peterson and Benson tied for high point men with 10 counters each. Peterson played the board more in this game and had the normal boys worried. He was able to return the ball to either Wenner or Anderson for a trial shot at the basket. Peterson was guarded by two men all through the game.

Wenner worried his guard and slipped around him for 8 points. Anderson, who did not score in the first half, played a game that would make any forward envious as smooth work on the floor. He got away for 6 counters in the last half. Wenner passed well, shot accurately and managed to be in the open for passes when the ball was coming up the floor. Benson, playing guard position, outscored his man 10-2. Patterson, again going in as guard, played a stellar game and continued to break up play after play. Wakeman was on again tonight, making 7 points and being in every play.

At the start of the battle the visitors went in their second string, planning to wear down the Pelicans. This, however, failed, and when Iverson went out on logs in the first half, Coach McNeil sent in a new team. The score at this time was 15-12, giving the Pelicans a five-point lead. This they increased in a spurt to 16 points, then to 14. Shortly before the whistle blew ending the game, they ran up a margin of 17 points. Iverson, second string center, and Friday night's first string forward, was high point man with five points.

Arthur may continue the changes in the Pelican lineup. Frank Hall returned. Howard was scorekeeper; Moore time-keeper.

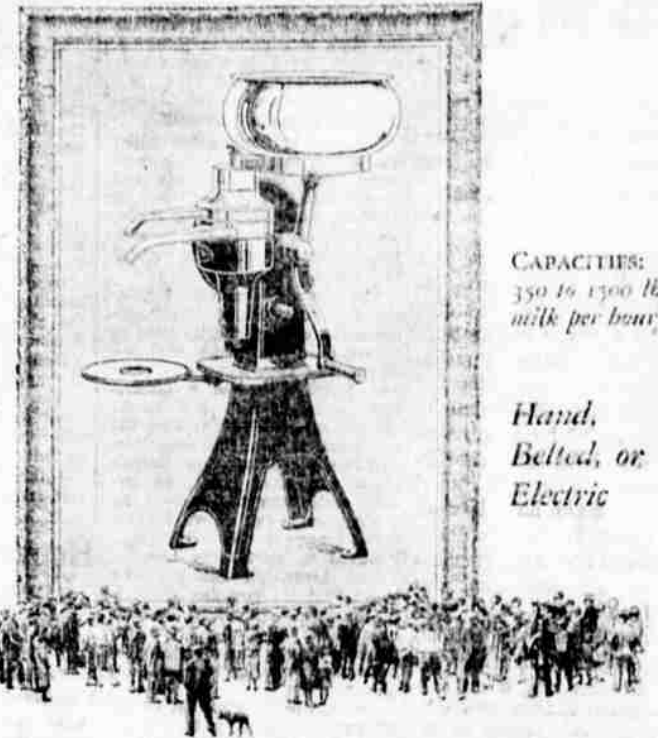
vice president; and W. A. Holt, Pendleton, secretary. The next meeting of the association will be held either at The Dalles or Ontario, to be determined by the executive committee.
