Yanks to Wear Big Numerals

NEW YORK, Jan. 22, (U P)—The old familiar refrain that "you can't tell the players without a score card" will sound through American league ball parks with fresh emphasis this coming season whenever the New York Yankees are to appear.

For the Yankees headquarters today announced an innovation in baseball which can only be ranked with the "ten man nine" proposed by President John Heydler of the National League. The world's champions will take the field April 16 with the backs of their uniforms numbered with figures 14 inches high, just as football jerseys are numbered.

The leadoff man, presumably Earl Combs, will be "No. 1" and so on down the batting order, but each player on the roster will have a number which he will wear throughout the season—provided he stays with the Yankees. This will probably work out so that Babe Ruth's big "No. 3" will come to be as famous as the "77" once worn by Red Grange.

revising the schedule, but there will be soft whispers and palpitating hearts among the senators for fear that they will be like the little boy who takes to pieces the family clock and attempts to put it back together.

In the Governor's office, Isaac Patterson—again I will lay aside the title and call him by his first name for the reason that long acquaintance and friendship permits—sits waiting results. He is not inclined to make a program for this session to follow, but insists that legislators are elected fresh from the people and therefore it is their bounden duty to solve the financial problems of the state.

When I asked him about the deficit he said it would be around two million dollars, and in this statement State Treasurer Tom Kay agrees thoroughly. Just how to raise this tidy little sum is a problem that is hanging over both houses and the third house as well.

I always have admitted that I was not a lawyer, and most emphatically state that I am not a constitutional lawyer. For many years when a bill has been introduced in a session that was displeasing to some of the lawyers they would at once raise the objection that it was unconstitutional. One would think Oregon had a flock of constitutional lawyers all of whom held seats in the legislature. However, I was convinced once more that I know little about the constitution, for when I suggested to like Patterson that the deficit be raised by a poll tax to run two years which would cause the stockholders of Oregon to dig up a special assessment to pay a debt, the same is done in all lines of business, the Governor stroked his chin in characteristic manner and remarked:

"I am just a plain farmer. Trope and metaphor flow not from my tongue. I know nothing about the oratory you hear in the senate chamber, neither do I claim to do anything so well as farming—raising peaches and prunes and pigs and other things to eat—but down in the southwest corner of my mind there is a glint of memory which causes me to believe the constitution of Oregon says something about poll tax. Understand I am no constitutional lawyer like some of the men you know but let us see for ourselves what that document says on poll tax."

The buzzer rang and in came the Governor's secretary with the constitution of Oregon. In a short time we found a passage which read, "There shall be no poll or head tax levied in the state of Oregon."

That settled it. The constitution always settles it—and there will be no poll tax levied this session or any other session until that sacred document has been repealed. You see, some one slipped in the joker in the constitution when the vox populi was excited over "let the people rule" or a fish bill, or some other special matter, and he "constituted" the poll tax off the map.

Discarding all humor or attempts at humor, these boys have a hard job ahead of them. If organization counts for anything the senate is under strict organization and President Norblad should be able to put over any program that he will indorse. But finding that plan is the difficult task.

Should this legislature fail to solve the financial problem—what then?

That is a question often asked. If this session cannot cope with the session, future sessions

will not be expected to do so. It will be like appointing tax committees—there will be confidence lost in the effort. Then what will happen?

Plainly, there will have to be a state gathering of men and women who love Oregon dearly and who will work for days and weeks if necessary to handle the situation.

I suppose should such a condition be necessary there would be a hue and cry up calling such gathering a "convention" and labeling all its acts, no matter how well intended, as products of a great corrupt political machine whose intention was to go back to boss rule.

But, all of these things are political slants—they are a part of the political game. It is interesting and amusing. It is instructive. And in some Oregon will find herself some day, putting her foot on the blatant chap who merely blats, and settle down to good, hard business sense willing to let the wailers wail. The case is not hopeless by any means. The good ship of state will sail on and on, even though she carries a two million dollar deficit as ballast to keep her on even keel.
