TREATED LIKE LADY

Miss Fairchild told with perfect composure how she and James Cline, another investigator, took Miss DeVoe in custody to conduct a roundup of jewelry, letters, telegrams and checks the secretary allegedly took with her when she left the home. All of which testimony, it developed, was to show just how calm officers of the law treated suspects.

"Miss DeVoe asked me if I would let her telephone her mother and tell her she was sending a man out to her house to get a watch and that she was not to ask the man any questions," Miss Fairchild said. "I let her do this and she told me she was glad Mr. Cline and I had been assigned to this case because we had treated her so well."

"I asked her why she had done these things she was accused of," said Miss Fairchild. "and she told me that she just couldn't see her family and herself doing without such things when Miss Bow had so much money and she was so reckless with it. She said that when she first went to Miss Bow's employ she had not taken anything, but that when she had seen how reckless Miss Bow was she realized how easy it would be to take things from her. Miss Bow had a black and white, maintained her usual calm while the policewoman was testifying, at times jotting down notes.

READ CHECK STUBS

In the afternoon, the throng again fought for seats, but Miss DeVoe took her usual seat at counsel table and the monotonous reading of check stub figures into the records was begun. There were 1,562 checks and it was said that an additional 147 checks, recorded & stubs, were missing. The checks were introduced to establish for the jury the amount allegedly taken by Miss DeVoe from the Bow special account, against which she was privileged to draw checks for Miss Bow's current expenses and her salary of \$75 a week. While Miss DeVoe is accused specifically of taking \$16,000, the state hopes to support the statement by the secretary in her confession that she took \$35,000.

Chicago Woman Attacked, Hanged, Hunt Assailant

CHICAGO, Jan. 15. (UPI)—The body of Mrs. Emma Moss, 41, with a rope around the neck and indications that she had been criminally assaulted, was found tonight by police in a North side garage.

Neighbors, who heard glass of a window of the small building being broken, saw a tall youth, about 20 years old, with a light cap and fur overcoat climb out. Mrs. Moss roomed a few doors from the house behind which the garage was located.

Mrs. Moss, worker in a lithographing plant near her home, went to the garage about 5 p. m. to get the car of Miss Bellina Morse, with whom she lived.

When she did not return, Miss Morse hastened to the garage, where she heard Mrs. Moss scream behind the locked door. Miss Morse called a nearby factory worker who attempted to enter the garage with a crowbar.

While he was prying at the door, he and Miss Morse heard the rear window of the garage crash. They ran back to find remnants of the man's fur coat adhering to the shreds of glass.

The body of Mrs. Moss was at the side of the automobile. A rope was wound tightly around the neck twice while her clothing was in disarray.

od, and was a shock to Mr. Selling's relatives and many friends. It was known that he had been ill for the past week, but few persons knew the gravity of his condition. The first indication that Mr. Selling was seriously ill came yesterday, after he was removed from the Portland Medical hospital to St. Vincent's. At that time, a son, Dr. Laurence Selling, reported his condition as "very serious."

Mr. Selling was one of the most widely known and best-loved residents of Portland. He had long acted a leader in public welfare movements, and always took a prominent part in charity drives. Only recently he took part in a movement to relieve the unemployment situation.

In recognition for his many services, the Portland Realty board voted to place Mr. Selling as Portland's leading citizen in 1928—the first time such an honor was conferred by the board.

Funeral services will be held here Sunday, it was announced.
