

THWART REVOLT AGAINST PERU

American Killed by Stray Shot During Battle Between Forces

LIMA, Peru, Feb. 20 (UP)—An attempt to seize control of the revolutionary government was thwarted by loyal troops today in an uprising which began in Lima and came to its sanguinary climax in a sharp battle at the ancient fort of Real Felipe, outside Callao, seven miles away.

Martial law in Lima and Callao, the capital's port, was declared, and heavy patrols to-night in both cities maintained order. Unrest was caused by the fighting but the government issued a communique declaring the uprising quelled and the "situation under control." The city was quiet this evening.

Brisk fighting at the fort, where the rebels sought refuge after failing to capture the palace in Lima, marked the insurrection. The casualties were undetermined. A communique said "all rebels are prisoners."

An American, Reginald A. Skidmore, employed by the Grace company, was killed by a stray bullet during the fighting at Callao. Skidmore of Bethlehem, Pa., was lunching at the Foreign club in Callao, when struck.

The total dead were estimated at 40 by the ministry of interior tonight, although complete official figures had not been compiled. Of those, the communique said about 40 were government troops, and 20 rebels.

Forbids Divorce To Catholics Without Consent

PORTLAND, Feb. 20 (UP)—Archbishop Edward D. Howard, in his annual Lenten pastoral letter, today forbids Roman Catholics living in the diocese of Portland in Oregon to institute divorce proceedings in the civil courts without first obtaining permission from him to do so.

In his letter, the archbishop declared that violation of the mandate would be classed a "reserved sin," and the offender could not be absolved from that sin by a priest—the matter resting entirely with the archbishop.

The letter indicated that Oregon's divorce law was loose, and said that only one state in the union had a worse divorce record than this state.

The letter was headed "Divorce and Birth Prevention in Pope Pius XI's Encyclical," and contained Christ's standards concerning divorce, quoted from the scriptures.

The archbishop charged any violation of Christ's demand as adultery, and decreed that "if any man, acting contrary to law, shall have put asunder, his action is null and void."

The letter asks for the "respectful consideration" of the faithful to that part of the Pope's encyclical condemning birth control. The declining birth rate in the United States is pointed out, and attention is called to the fact that Oregon "has the lowest birth rate in the entire nation."

It was said, however, that Catholics in this archdiocese had not been strongly affected by birth control propaganda, as "the present annual birth rate is approximately 25 for each 1,000 population."

In closing his letter, the archbishop said that "I realize full well that you are surrounded by men and women calling themselves 'progressive' and 'modern,' who laugh at these ideas, but their progressiveness is as old as Lucifer's revolt against God and their principles as modern as original sin. Listen to them and you will build the house of marital happiness upon sand; listen to the voice of the eternal Peter and you will build upon a rock."

The archbishop's letter, which will be read next Sunday at all parish masses in his archdiocese, applies specifically to Catholics in Oregon.

Woodcock said "Courts and agents ought not to be expected to prevent the making of liquor in the home for non-commercial purposes" nor "to stop the consumption of such liquors any more than the courts and police are expected to stop a game of bridge in a private home with no commercial profit."
