

Further Reduction In Wheat Planned

 Limit up to 20 per cent. The exact amount was to be determined later in the summer.
 At the time the plan was announced it was assumed the maximum percentage would be asked. Later, as a result of bad weather, estimates as to crop conditions July 1 showed that not more than 495,000,000 bushels would be harvested this year. This is 105,000,000 bushels less than the demand for normal domestic requirements.
 Had the shortage occurred in the year when there was no surplus bursting the nation's warehouses, the country would have been facing a famine and forced to rely on foreign production. This realization has made an impression on the farm administrators.

Constans Resigns As Laborers Vote To Continue Strike

 answer was expected within the next few days.
 Union, Members Split
 Members of the Mill and Timber Workers Union were in dispute following events of yesterday's strike. The men had been ordered to return to work pending a settlement, but agitators in the organization had upset the agreement.
 The Central Labor Council, likewise, was opposed to Thursday's turmoil out of sympathy with the mass demands for change, according to A. L. Rice, president.
 Rice and Robert Constans, president of the timber worker's union, took no part in activities Thursday after members of the union disregarded recommenda-

tions of the union executive committee which met Wednesday evening and proposed a plan to make the walk-out a legal American Federation of Labor strike. Members of the union joined with non-members in picketing and mass meetings instead of abiding by officials.
 Meeting Sunday
 The next regular meeting of the union is called for Sunday morning at 10 o'clock. It was called upon adjournment of the last meeting Tuesday afternoon, according to Constans.
 In a statement Thursday evening, Constans said:
 "As president of the union which has sympathized with the strike, I will abide by the laws and regulations of the American Federation of Labor in attempting to carry on the strike in a legalized manner. Unless this action is followed by all members it will be unauthorized and open for mob violence and unnecessary trouble."
 Rice and Constans believed influences of L. W. W. workers and agitators had swept into the union causing strikers to follow mass movements instead of organized supervision.
 In explanation of the recent strike action, A. L. Rice gave out the following statement:
 "For the information of the mill workers and the general public, I would like to make the following statement.
 "About a month ago a group of lumber workers, called on me as president of the local Federation of Labor, to organize the timber and mill workers. After giving the matter considerable thought and making a trip to Portland to confer with Ben Osborn, the state president, I decided to help this group organize. And last Saturday, before the local timber union was organized to such an extent that it was able to function, a small group of Weyerhaeuser men

called on the management and demanded a 25 per cent increase in wages. They were told an increase could not be considered at this time, and they then walked off the job. It so happened that they held positions in the mill that made it inconvenient to run without them, and so the mill was shut down, pending further developments.
 "I notified the newly formed timber workers union that according to the by-laws of the American Federation of Labor, that they, as part of that organization, could not legally support an unauthorized strike of this nature. I did, however, tell them that I would be perfectly willing to do whatever I could to help them settle their difficulties. I immediately got in touch with Ben Osborn, the state president, and was able to get him to make a flying trip to Klamath Falls.
 "He met with the local timber workers, and begged with them to go back to work and settle whatever difficulties they had by arbitration and in an orderly manner. This they refused to do, and in the meeting on Tuesday night voted to continue the strike. However, on Wednesday morning all the mills were operating with the exception of Weyerhaeuser. And as near as I can figure, from the sentiment of the Weyerhaeuser mill workers, the majority of them were ready to go back to work."

 agreement to interfere with maintenance of contracts entered into by exercise of collective bargaining. It does not force the breaking of contracts.
 "No contracts are affected by the agreement. If the employer can't adjust his contract, then he can't sign the agreement. The agreement neither authorizes or requires the breaking of contracts. But the employer can not get the blue eagle until and unless he complies."
 He added that public opinion and the influence of labor unions are factors that will be powerful in this situation.
