

CHIEF OF NRA STARTS GREAT BUYING DRIVE

WASHINGTON, Aug. 7 (AP)—The plea to "buy because buying supports your job" that today the recovery administration's attempt to utilize the increased purchasing power it is being created by hour-shortening, wage-raising agreements of the government with business and industry.

Along with that request from Hugh S. Johnson, recovery administrator, went this boycott threat:

"Where should you spend? Can there be any question? You should spend under the Blue Eagle. If you spend there you are spending for increased employment. If you spend elsewhere you are hurting the chance to end unemployment because you are helping to destroy the business of the men who are paying more for help, you are aiding them who refuse to do so."

Five Codes Permanent

The "buy now" campaign had been in contemplation for some time. But for a while the recovery administration feared production was increasing too fast for purchasing power—that more goods were being made than could be bought.

Temporary agreements with the president to raise pay and shorten hours, pending development of permanent codes of fair competition with the same objective, were offered business and industry.

Yesterday, Johnson looked over the score sheet. He found five industries—cotton textiles, coats and suits, shipbuilding, electrical manufacturing and woolen textiles, each employing thousands—operating under permanent codes.

Speakers Carry Word

He found 25 other groups working additional thousands functioning under the temporary agreements. That was enough, he concluded, so he sent his first "buy now" message to a Cleveland mass meeting.

Continuing through the week, speakers will emphasize that same message. Through their pleas will run this line spoken by Johnson:

"Turn your money into things because, almost before you can draw a breath, the things you want will be worth more than the money you can save by not buying."

Meantime, today, the new presidential board named to arbitrate labor difficulties, called into its first meeting, to make preliminary surveys of causes behind various strikes, big and small, and the attempt to arbitrate the causes into nothingness.

Strikes Gain Attention

Such arbitration, by another group, brought officials and to the Pennsylvania bituminous coal mine walk-out, some strikes, stirred by communists and still "scarred, clubbed and wounded," said President John L. Lewis of the United Mine Workers of America, are hanging back. But he predicted that they would return to work.

In today's picture there also was a personal promise by President Roosevelt to businessmen who have contracts with the government that the contracts would be adjusted to allow for rising prices.

"Wherever adjustments can be made under existing law, I shall recommend that they be made," he said in a statement issued through the recovery administration. "In other cases I shall recommend that the next congress, meeting in January, 1934, take action, giving authority to the executive departments to provide for recompensing such buyers who have in good faith and wholeheartedly cooperated with the administration of the National Industrial Recovery Act."

RECORD GOOD

PARIS, Aug. 7. (UP)—The air ministry authorities tonight officially announced that the French fliers, Paul Codos and Maurice Rossi, had set a straight line distance record for airplanes in their flight from New York to Hayaek, Syria. The distance given was approximately 5700 miles.

It was said working out the exact distance might take a little time, but that the record would stand.

Meanwhile, two other Frenchmen, Jean Assolant and Rene Lefebvre, announced they were completing preparations for an attack on the Codos-Rossi record and expected to start shortly on a flight from Calais, France, to Tokio, Japan, over Europe and Asia.

SHORTER BUSINESS HOURS DISAPPROVED

WASHINGTON, Aug. 7. (AP)—The official NRA attitude is that shorter business hours conducted with the president's blanket code.

A. D. Whiteside, deputy administrator, has wired the Indiana Retail Grocers association urging it to "give serious consideration to the fact that in several local communities retailers are making joint agreements to shorten store hours."

"This is not in keeping," he stated, "with either the spirit or the act as expressed in the president's reemployment agreement or in the president's statements regarding reemployment of which the essence is to effect an increase both in reemployment and in wages to those employed."

Capital Guarded

A detachment of 1000 infantry and cavalry troops arrived in Havana tonight at the height of rioting around the presidential palace and took charge of the city under a drastic military rule equivalent to martial law.

The troops rode into the city, torn by a general strike and mobs rioting tumultuously in the main avenues, and took over patrol of the capital. They reformed loyal local police details which sought in vain during a hectic day to maintain order.

Ambassador Sumner Welles, United States envoy, sought to effect political peace. He reported frequently to Washington, where officials quickly relayed his dispatches to President Roosevelt, at Hyde Park, N. Y.

Welles let it be known that oppositionists and all political party leaders, including Machado's own liberals, had agreed to a formula for a truce but remained silent on details. Persons close to the ambassador, however, intimated the terms included Machado's resignation or disappearance from the political scene through a long leave of absence during which a provisional president would rule.

RESIGNATION EXPECTED

WASHINGTON, Aug. 7. (UP)—The resignation of President Machado of Cuba appeared imminent tonight, officials said, as disorders spread throughout the island.

No definite reports have reached them, officials said, of an agreement respecting Machado's resignation. They added, however, that such action was considered impending.

The state department denied reports that Machado's resignation, if it occurs, could be connected with a strike settlement plan said to have been proposed by Ambassador Sumner Welles.

NEW YORK POLICE BATTLE STRIKERS

ROCHESTER, N. Y., Aug. 7. (AP)—Lieutenant Gerald D. Valms in command of the state police in the Rochester area, said today he had been informed of details of a plot to dynamite bridges and culverts on all highways leading into Rochester and stop all milk shipments.

UTICA, N. Y., Aug. 7. (AP)—Guns entered the New York state milk strike. In its seventh day today. Strikers and non-strikers carried them.

From Boonville came the report a caravan of seven milk trucks convoyed by troopers, fired on 25 times between that village and Lowville yesterday, was the target of a machine gun, not of high-powered rifles, as at first had been reported. None of the trucks was damaged.

Tear Gas Carried

A National Guard company at Watertown was equipped with tear gas bombs and gas masks, and was ready for immediate service if needed in the strike zone. The sheriff's deputies were guarding all Jefferson county milk plants.

One man was shot, another threatened with lynching, two women beaten, a state trooper struck with an iron pipe, and several farmers injured by flying clubs and stones yesterday as the strike passed its sixth day.

Clashes Frequent

Most of the outbreaks came when picketing farmers attempted to dump milk of non-strikers, although there were numerous clashes between strikers and state troopers.

KANSAS CITY, Mo., Aug. 7. (UP)—The national recovery act means the end, once for all, of laissez-faire in economics, and if followed wisely will guard against depression in the future.

Communists Accused

BROWNSVILLE, Pa., Aug. 7. (AP)—The federal government today began an inquiry into alleged communist activities in the soft coal fields, as thousands of striking miners refused to return to work under the truce called by President Roosevelt.

Interest centered in the congressional race where three democratic candidates have conducted a bitter campaign for the nomination.

Carried Big Stick

The recovery administration has a very effective weapon. In the case of grocery stores, for instance, it threatens to reduce the maximum hours of work for employees to 40 instead of the 48 now in effect.

General Hugh S. Johnson, national recovery administrator, feels very strongly about such attempts to deprive the "white collar" worker of his benefits under the president's program. He is especially solicitous of this class which has no organization to protect its interests.

The NRA today issued a warning against "rackets" in connection with the recovery program. "Publications using misleading titles, conveying the impression that they are sponsored by the NRA are attempting to charge merchants, manufacturers and others for listing them as entitled to the use of the blue eagle banner," the official announcement said.

A new board was added today to the numerous ones which administer the national recovery act. This is the reemployment agreement policy board. It will pass on all modifications and changes in the original blanket code.
