VIEWS DIFFER ON AMERICA'S SOVIET STAND

Men and nations took a varying view today of developments forecasting American recognition of Russia.

Comment flashed swiftly from the capitals of the world—and from remote corners as well—as the word went out that President Mikhail Kalinin had accepted President Roosevelt's invitation to enter into negotiations looking to possible recognition.

In brief, the reaction was: Senator Borah of Idaho, former chairman of the senate foreign relations committee—praised President Roosevelt's move toward recognition. Titled it "of supreme moment in the cause of peace."

President William Green of the American federation of labor—said before recognizing Russia, United States should insist that U. S. S. R. cease attempts to bring "world revolution through force."

Senator Arthur Robinson, Indiana republican—asserted recognition would be "utterly foolhardy."

London—Political quarters felt American view finally ends Russia's "political outlawry." British business foresees the rise of a new and potent competitor for Soviet trade. Government officials said they weren't surprised.

Paris—Government circles regarded the exchange of messages as solidifying international relations and opening broader trade possibilities for the United States.

Tokyo—Newspapers pointed out that President Roosevelt's note was dated October 10—when Russo-Jap tension was high—but officials professed doubt there was any connection. A spokesman denied reports that Japan disliked the prospect of American recognition of Russia.

Rome—Official quarters withheld comment, but newspapers asserted more correspondence with Mussolini's policy to accord Russia "realistic dues as a great European nation."

Shanghai—Literate public hailed prospect of recognition as promising to result in tempering of Japan's strong policy toward China.

Berlin—The Wilhelmstrasse viewed the possible recognition as making a patching up of the strained Russo-German differences more difficult. One spokesman commenting that "if America were as near, it would perhaps be less inclined to recognize the Soviet union."

Nanking—National government leaders viewed the negotiations as settling up a common front against Japan in the Near East, many of them professing to believe either a Russo-Japanese or a Japanese-American war inevitable.

Peking—Chinese quarters did not believe the Sino-Japanese situation in North China would be affected, believing recognition would be based on economic reasons rather than political.

HANAY DEFENDS WORK OF STATE PROJECT BOARD

LA GRANDE, Ore., Oct. 21.

(AP)—Speaking plainly in commenting on charges that the advisory board of Oregon for the public works administration had delayed acting on projects, Chairman Bert E. Hanay of Portland, here last night said the board had at no time had any projects before it 24 hours without taking definite action. In reference to reports the board had held up approval of western Oregon bridges, Hanay classed this as "nonsense."

Some of the engineering on the bridge projects is not completed, he said, pointing out that the board cannot take action on any project until engineering requirements are perfected.

Hanay urged communities to speed up presentation of their projects. But at the same time he warned them that the projects must conform in every respect with congressional made requirements. "We cannot deviate from them," he said, speaking for the board.

Hanay said of twenty millions of dollars believed available for allocation in Oregon, twelve millions still remained unallocated. Hanay spoke before representatives of Union, Wallowa and Baker counties. He was introduced by Congressman Walter Pierce who predicted the public works bill would be re-enacted at the next session of congress with another large sum appropriated. R. N. Stanfield, member of the advisory board, also spoke briefly.

BORAH ADVOCATES MILD INFLATION

Caldwell, Idaho, Oct. 21.

(AP)—Controlled inflation and restoration of the anti-trust laws are essential to the return of prosperity to the American farmer, Senator William E. Borah told an audience at a grange meeting at Sunnyslope.

"I don't believe the farmer can prosper under NRA," he said at the gathering last night, until those two things have been done. The monopolistic trust must be removed before the price the farmer pays for goods will be equivalent to the price he receives."

FISH CONTROVERSY OPENED ONCE MORE

An agreement permitting whites to fish in streams on the Klamath Indian reservation will be discussed on Monday at a conference between representatives of the Klamath Indian business committee and the Klamath Sportsmen's association.

Sportsmen here believed prospects are good for a settlement of this long-standing controversy. Wade Crawford, superintendent of the reservation, in a letter to the association, said that the Klamath Indian business committee, at a recent meeting, had decided to suggest the conference, to be held at 10 a. m. at the Klamath Agency.

The matter is believed to have been brought to a head by a policy of the association refusing to plant fish in the reservation streams, according to A. L. Crawford, president of the association. Under regulations of the state fish and game commission, the sportsmen's association may designate the number of fish and the places where they will be planted in this region. Because whites are not permitted on the reservation, and because the planting is financed through money paid by sportsmen for angling licenses, it was decided

not to plant more fish in reservation streams.

The sportsmen's committee to meet with the Indian group is composed of Elmer Balsiger, W. C. VanEmon, Barney Chambers, Roy Kennan and Howard Emerson.

GENERAL WHITE OFFERS PROTEST

SALEM, Oct. 21. (AP)—A

charge that World War Veterans' State aid commission securities have been deliberately misrepresented in the bond market to force a high interest yield was made by Major General White here yesterday.

"There has been a vicious and deliberate propaganda in the market against these Oregon securities for the sole purpose of forcing an extortionate interest yield," White said. "At our last meeting, bids were made as high as 5.50 and at that time we made it plain that all such bids would be rejected. The state's credit is basically sound and these securities are intrinsically as sound an investment as government obligations."

White said he thought the \$125 bid accepted for \$600,000 bonds yesterday was "excessive," but "the best we can hope under the circumstances."
