Be on Guard
CONFLICTING reports from North China may leave the outcome of early skirmishes in doubt, but they serve to emphasize that actual war has broken out in that sector between Japan and China. Major fighting is underway there between the troops of those nations.
If it continues, and that appears inevitable at this time, there are strong possibilities that others may become involved. Russia is unquestionably interested in behalf of China. Germany and Italy are friendly to Japan. One may come out openly for either side, and then again, that might happen. No one can predict what ramifications a war can have.
It is reassuring that in America the spirit of neutrality is strong. We don't want to become involved either in the war in southwestern Europe, or in this struggle that appears to be opening in the Orient. Most Americans feel that way about it.
But Americans should be on their guard. Sympathy for one side or the other, in any conflict, is easily aroused among those who look on. There will be plenty of propaganda to do that very thing. It already is well-underway in connection with the Spanish mess. Once sympathy is thoroughly aroused, it doesn't take much to touch off the fires of hatred.
Americans should, individually, accept the responsibility of keeping the spirit of neutrality in this country alive and vigorous. They should remember that keeping out of war is far more important than any sympathetic urge they may feel as others fight.

REACTION of the Bend Bulletin to a report that misinformation had been given out at Bend about roads into Klamath Falls and beyond is disclosed in a Bulletin editorial appearing elsewhere on this page.
The Bulletin's remarks, expressed with characteristic vigor, support our own belief that Bend people, generally, regard their community and ours as partners in the promotion of travel on No. 97. It was for that reason that we were surprised to hear of the incident at Lava River cave, which, incidentally, was reported to us by a reliable and intelligent woman of this city.
On the basis of the Bulletin's editorial, we are led to the conclusion that what happened must have been an isolated incident and not representative of what is done generally at Bend when inquiries are made about roads to and out of Klamath Falls.
It is by motorists, whether they be "sleuthing" or really in need of information, that mis-informants are most likely to be discovered. The suggestion that when such discoveries are made, they be reported, is a good one. If the Bulletin correctly reflects Bend's attitude, and we assume that it does, none are likely to be made again at the city on the Deschutes.

Behind the Scenes in Washington

WASHINGTON, July 29—The president telephoned the vice president and said, in effect: "Jack, you come on back here and help me settle some of this mess you made. A lot of these senators who are agitating for adjournment point out that there is no reason for staying here and passing on legislation since the president of the senate has gone away. Come on back here and help me out of this jam."
Presumably each man had a stenographer taking down the conversation, none of which is available, of course, except to the participants. One can only guess as to what Garner said.
But every insider, Roosevelt and Garner adherents alike, agreed that Roosevelt desperately needed Garner's help at a tight point in the court fight.
Somewhere in the contact between the White House and Garner arose the suggestion that Roosevelt would be willing to make a trade with Garner on certain policies in return for the vice president's support.
One guess, made by a man who nearly always guesses right, was that Garner would win the assurance that wage-hour legislation would not be demanded at a tight point in the court fight.
Recall of Garner, who had walked out from his post while Roosevelt, in effect, had elevated his nose and suggested the vice president would never be missed if that was the way he felt about it, indicated the desperate position in which the administration forces felt themselves to be after Majority Leader Robinson's death. The fact that Roosevelt would have to trade with Garner became obvious at once.
The late Joe Robinson had operated on a personal basis and there was no administration machine in the senate. He had exchanged favors for favors, but these were personal favors and this became obvious after his death to the great demoralization of the administration's court fight. The real Capitol Hill battling had been left to the Department of Justice, which meant, in effect, only Assistant Attorney General Joe Keenan.

HIS LUCK HOLDS GOOD
Some of Roosevelt's closest friends and most influential advisers begged him in vain to go on the funeral train with the body of Robinson to Arkansas, for strategic reasons, of course.
The president's failure to board that train aroused plenty of criticism, not only from the few who felt he should have paid the final tribute to a loyal follower, but also—and perhaps mostly—from political enemies who made the most of it.
Roosevelt's unjustly celebrated luck seemed to hold good, however, when complaints as to his failure to go along became dulled by unvarnished news reports which showed the to-and-fro trip to have been a continuous political conference. Vote canvassing on the senate majority leadership and court bill compromise talk were the outstanding features.
The president of the United States would have been placed in a bad setting. Whether or not the specter of such a spectacle influenced his intention not to ride with the body to burial, he had the memory of the political scandal into which the late Speaker Henry Rainey's funeral was turned to remind him of the possibilities.
The excuse he gave to the intimates who urged him to go was that he was terribly worried about the Chinese-Japanese hostilities and must stay here to follow hour-by-hour developments.

LOADED WITH DYNAMITE
Apparently he meant it. The new neutrality act practically forces the president, in effect, to take sides in any foreign war. Roosevelt could afford to make a grandstand play for neutrality by

his handling of the Spanish situation, privately taking the position that Spanish civil war was primarily something for France and England to worry about.
But the Pacific, from the military and political standpoint, is in this country's back yard. Our traditional attitude toward China is one of friendliness, and the nine-power treaty calls for aid for nations which become victims of aggressors.
Military and naval gentry all regard Japan as the nation which we're most likely to fight. This country is China's base of supply for munitions, which would be automatically cut off once Roosevelt recognized a state of war.
The neutrality act's cash-and-carry principle would give Japan a tremendous advantage on other commodities because she has a merchant fleet and China hasn't.
The situation was loaded with dynamite, and each of the many possibilities through which the neutrality law is sure to make us neutral in a foreign war was painfully obvious.

LAFERRIERE GETS SUSPENDED TERM

PARIS, July 29 (AP)—Three justices in criminal court today gave Mme. Madeline La Ferriere a one-year suspended sentence after a speedy trial on charges of shooting Count Charles de Chambrun, who she accused of breaking up her friendship with Premier Benito Mussolini of Italy.
The judges, who had barred part of the trial to the public and press, also fined the woman 100 francs (\$37.50), then ordered her freed under the suspended sentence.
Crowds jammed the courtroom as the pale, dark-eyed newspaper woman, wearing silver fox fur, a black gown and black hat trimmed with white went to the stand.
De Chambrun told investigators he knew the woman only as a newspaper correspondent and arranged an interview with Il Duce at her request. Later, when she professed infatuation for Mussolini, de Chambrun said he informed the Italian premier of her remarks.

BILLESTER ASSAILS SOVIET COMMUNISM

Interest continues to deepen in the special services now in progress at the First Baptist church, according to the pastor, the Rev. Cecil C. Brown.
The pastor states that a large audience heard Dr. Michael Billester speak on "Communism at the Bar" last night. In this message the missionary called attention to the overthrow of Russia by a small minority, and told how two or three people were largely responsible for the regime of communism. Dr. Billester told the audience of the deplorable condition of his people, and stated that the masses of the Russian people would abolish communism within one day if they were given a voice in the matter. The speaker stated that many of the educators and clergy of America have sold themselves and our country to the reds of Moscow.
Mr. Billester said he speaks from actual experience, and lived in Russia under the czar's regime and saw the revolution and blood of communism suppress the people into slavery. He declared that the CIO organization is communistic to the core and that the revolution in Russia was the fruition of conditions very similar to that of America today. The audience cheered the speaker several times as he emphasized the Christian principles of the United States constitution and pleaded for a return to true Americanism.
Tonight the missionary was to speak on the subject: "Trials and Triumphs on the Russian Mission Field of Europe." Illustrated by stereoscopic slides.
The message for Friday evening is, "The New Palestine," or "Palestine and the Jew in Prophecy." Illustrated by motion pictures. The public is urged to hear these striking messages.

The Family Doctor

Goldberger and his associates, who investigated the prevention and treatment of pellagra, claim that they cured 47 cases by a daily dose of dried yeast, also that other people were cured by being given a daily allowance of fresh lean beef.
In institutions, asylums and homes where the diet is under a centralized control, the prevention of pellagra is not difficult. Here a few simple additions to the diet seem to solve the problem.
Where funds are not available for even these simple additions to the diet, it is customary to add dried yeast as a regular part of the diet and it is believed that an allowance of one-half an ounce a person each day will prevent pellagra.
Most people know that the diet in the southern portions of the United States is restricted, especially during the late winter and early spring. It is not enough to suggest that these diets ought to be improved or varied greatly.
Unless the necessary funds are available and unless specific instructions are given as to just how the diet is to be modified, little is likely to be accomplished.
In some portions of this area, it has been customary to encourage the family to get a cow and to drink plenty of milk. In other places, the situation seems to have been solved by the setting up of suitable meat markets and with arrangements for the purchase of meat by those who require them.
Most leaders in the field of public health prefer to encourage the use of simple additional substances such as yeast as a more certain method of overcoming the incidence of pellagra.
It has been found that cases of pellagra frequently occur after people have suffered with hookworm, amebic dysentery, tuberculosis or late syphilis. All of these diseases tend to multiply and to thrive where people are poor, where hygiene is bad and where sanitation is absent.
In addition to the control of the diet, some patients may be so severely sick that it is necessary to put them to bed and to feed them by the use of a tube. In these cases doctors sometimes administer liver extracts through the tube, since the liver is not only nutritious but helps to overcome the anemia and provide additional vitamins.
Since the skin is sensitive, it is necessary to prevent bed sores and secondary infections. Because of the inflammation in the mouth, it is necessary to keep the mouth clean and to provide suitable washes and lotions to control the irritation.
If chemical studies show that the gastric juice contains an insufficient amount of hydrochloric acid, the doctor is likely to recommend additional hydrochloric acid for such patients.
Pellagra is primarily a disease of the poor rather than of the wealthy. Sometimes when those of greater income are affected, physicians advise that they change their locale and improve their nutrition.
Next: Beriberi or polynneuritis.
