55-Mile Speed Measure Signed By Governor

SALEM, Ore., March 29 (U.P.)—Governor Charles A. Sprague Friday signed a measure putting a 55-mile speed limit on highways, and putting the burden of proof on the motorist to show he is driving safely when he surpasses that figure.

Also signed was the last of the important unemployment compensation bills and one allowing construction of a million dollar office building in Salem.

The unemployment bills establish seasonality provisions of the law and put a top and bottom on the unemployment fund. The office building won't be constructed until the board of control decides it is advisable because of labor and material costs.
