

Edmundson Will Send 1942 Squad to Garden

Washington State Mentor Slates Long Cross-Country Cage Junket

SEATTLE, April 16 (AP)—On the theory that travel broadens one—mentally as well as on the train cushions—Coach Clarence S. "Hee" Edmundson has decided to send his 1942 basketball team on the road.
This departure, both from Seattle and from long standing Edmundson custom, was announced at the annual basketball banquet last night.
For the first time in Washington history the squad will barnstorm before the season opens. Hee listed the following games:
Dec. 27—Temple at Philadelphia; Dec. 30—New York University at Madison Square Garden, New York City; Jan. 1—A still unselected team at Buffalo; Jan. 3—De Paul at Chicago.
Hee explained the decision to make the trip thusly:
"I thought we had a good

team last season, but the fellows didn't have much confidence. Maybe they felt like country cousins or something, when they played against clubs that had made extensive pre-season tours.
"In the old days Washington teams had confidence because of a few inter-sectional games played at home before the season opened, while the other northern division clubs didn't have much opposition.
"But I saw enough of the benefits and advantages of travel while with the Washington State team on its trip to the collegiate play-offs to warrant such a trip for the Huskies next season."
Then he waved a wrist watch at the players and said:
"And I hope each one of you win one of these next year."
The watch was identical with those presented Wisconsin and WSC players for being national collegiate finalists.

Jockey Admits Pulling Four Mounts in 1939 Race Meet

LOS ANGELES, April 16 (AP)—Willis Ward, 19-year-old suspended jockey, told a superior court jury he pulled four mounts in one day of the 1939 Hollywood park season but his fifth horse won despite his efforts to make it lose.
Testifying in the trial of five men on jockey-bribery charges, Ward declared he received \$200 for each race he kept his horse from winning. He said he was paid approximately \$4000 for fixing races at Hollywood park and Del Mar tracks in 1939.
Parents Sue
In one seven-horse race at Del Mar on August 18, Ward testified, every rider but one was fixed, and the horse ridden by the unbribed jockey won.

Ward's parents, Fred and Mae Ward, filed a civil suit yesterday against the five defendants in the jockey bribery trial and 11 other men, demanding \$37,000 damages on the grounds they had ruined his racing career.
On trial are Bernard and William Elstoss, Benjamin Chapman, I. W. Kivel and Sol Greenberg. Named with them as defendants in the civil damage suit are J. J. Murphy and 10 men listed as John Does.
Irving Sangbusch, alias J. J. Murphy, one of the original defendants in the race-fixing trial, turned state's evidence and testified he acted as agent for the other five in bribing jockeys at Hollywood park. Charges against him were dismissed.

Cal, Husky Crews Set For Regatta

OAKLAND, Calif., April 16 (AP)—California and Washington crews added the finishing touches today to preparations for their annual regatta for the Pacific coast championship Saturday on the estuary here.

Varsity, junior varsity and freshman shells from both universities were scheduled to spin through abbreviated time trials over mile-and-a-half distances, then devote the rest of the week to polishing.
Washington raced through its first and last full-length trial heat over the three-mile course yesterday in a time announced as 15 minutes 8 seconds. Coach Al Ulbricksen said he thought the National Champion Huskies' time would be considerably improved under the better tidal and competitive conditions that will prevail Saturday, however.
California's last effort against the clock for the three miles was 14:53, turned in last Saturday. It was 15 seconds faster than the Washington time, but five seconds slower than the Bears' own course record of 14:46.4.

Promoter Hits Hostak for 'Running Out'

CHICAGO, April 16 (AP)—Promoter Bill Rand accused ex-Champion Al Hostak of Seattle of "running out" today on a title bout with hard-punching Tony Zale of Gary, Ind., originally scheduled for May 16 at Chicago stadium.

Zale, recognized by the National Boxing association as the champion, whipped Hostak in a non-title fight last year before wrestling the middleweight championship from the Seattle fighter in their second meeting last July.
Rand said yesterday that he has called off the May 16 bout because Hostak's manager, Eddie Marino, demanded 20 per cent of the "gate." The promoter added that he had previously made a verbal agreement with Marino whereby Hostak was to get 12½ per cent and Zale 37½.
"They know you can't put on a fight with that kind of a 'cut' for the challenger," Rand said.
"Zale got only 12½ per cent when he met Hostak for the title. I'm sure Hostak is just using the purse for an excuse."

Military Uses Take 10 Per Cent of World's Petroleum

Military uses by foreign nations for gasoline and related fuels apparently consumed nearly 10 per cent of the 1940 world production according to information reaching the Oregon State Motor association. Of known production and consumption data for 1940 about 220,000,000 barrels cannot be traced, and petroleum marketing authorities attribute this to use by military organizations for which figures are not available.

In 1940 world production of crude oil amounted to about 2,150,000,000 barrels, and production of related fuels (natural gasoline, benzol, synthetic mineral oils and other fuels) is estimated at 110,000,000 barrels, making a total production of 2,260,000,000 barrels.

Estimated civilian consumption throughout the world and additions to stocks in the United States used 2,040,000,000 barrels. The remainder, 220,000,000 barrels, is presumed to have been consumed in unreported military operations, or added to the unrecorded stocks of foreign countries.

The excess of production over known consumption has been a phenomenon for many years, but the amount has increased steadily in the last seven years—jumping to the present total from 50,000,000 barrels in 1933. Deficiencies in statistics of civilian consumption in many countries doubtless explain some of this excess, but authorities believe that the bulk of it represents military consumption and storage.

REMOTE RESIDENTS AIDED BY NYA PLAN

According to word received from Earl I. Rice, NYA area director, the national youth administration has provided a new plan for employment of young men in Klamath county who live too far from existing project centers to commute daily. This plan provides enough paid employment per month to defray nominal living costs at project centers in Klamath county. Assignments are available which offer work-experience in auto-mechanics, construction trades, radio construction, radio operation, cafeteria work, clerical work, and drafting.

Workers assigned to the radio project engage in the construction of radio equipment 40 hours per month for which they are paid; in addition to this paid employment, they receive 40 hours of vocational instruction in radio operation and theory. Such national defense training facilities for the development of radio technicians, operators, and service men which are being established all over the United States, should lead to definite employment in radio for aggressive trainees of each sex.

A more intensified training for young men and young women is provided at resident or regional projects at Eugene, Salem, and Chemawa in Oregon, and at Weiser, Idaho,

which offers a greater variety of employment and instruction. Resident projects offer a combined total of 40 hours per week of work-experience and instruction where the earnings are great enough to provide board, room, laundry, medical care, tuition, and a reasonable amount for personal expenditures. Citizens age 16-24, who are out of school and in need of work-experience or training, may apply at the Oregon State Employment office, 242 Main street, Klamath Falls, by letter or in person.
