not recognized the combat area defined by the axis and, therefore, was at liberty to navigate such waters.

President Roosevelt told his press conference yesterday that United States naval vessels were not prohibited from entering combat zones by any executive order and that they would operate anywhere deemed necessary for hemisphere defense, but said that did not mean navy units are going or would go into the European combat zone.

"That matter has been taken up by the press and other sources," declared the spokesman. "We made a categorical declaration with reference to combat zones. It was pointed out that it was not a question of whether these zones were recognized or not, but we declared whoever goes therein will be torpedoed. This means any ship under any flag."

At a late hour Wednesday afternoon the bodies of the two men, Theodore "Ted" Walker, and Thomas "Tom" Smith, had not been found despite the efforts of a large party of searchers who were dragging the canal waters with hooks attached to power boats.

The search along the canal was directed by Sheriff Lloyd Low and state police, while city police directed activities at the scene of the accident.

Missed Turn Cause of the accident was given by police officers as failure of Mrs. Duffy to make the turn at the Main street bridge as the car came down the hill from the Hot Springs area.

Florinda Davis, who managed to swim 40 feet down the canal from the submerged car, told the following story from her bed in Lightfoot hospital where she was recovering from shock and exposure:

"I had gone to the police station about 2 o'clock to report the theft of my car keys from my machine parked on Klamath avenue between Tenth and Eleventh streets. Then I walked back to my car and when I got there, a car stopped across the street and Gertie Barkley called to me and asked me if I didn't want to go for a ride. In the car was Gertie, she was in the front seat driving, and Edna George and her little girl. I got in the back and sat between Ted Walker and Tom Smith. They wanted to know if I had anything to drink and I said I hadn't. They had been drinking, I think. Anyway Gertie was pretty drunk, and so was Ted.

"We drove across the bridge and nearly to the top of the hill (Indian hill), and then we stopped up there for a while, maybe five or 10 minutes and talked. When we started down, Gertie was driving pretty fast and I told her—"aren't you pretty drunk to drive your car, and anyway you have a baby with you," but Ted said Gertie could handle the machine alright. And Gertie said she'd never wrecked a car yet and had been driving a long time.

"We came down the hill pretty fast and I guess Gertie forgot to make that turn and kept straight on. I felt the car leave the road—I'll never forget it. Then we hit the water and I felt the door on Tom's side open and the water rush in. Then he must have gone out the door, because the door closed and he wasn't there. My nose and mouth were above the water and I reached over and felt Ted and said—"Ted, are you all right," but he didn't answer and I opened the door and got out.

"I guess I swam quite a ways down the canal, the water was pretty swift and sort of carried me along, then I reached the bank and I was all-in, so I laid there a long time. I don't know how long, and just rested. As soon as I felt better I walked up the bank and came down to the Lightfoot hospital and called to Mrs. Lightfoot to get the officers."

Florinda said she didn't know just what time the accident occurred but thought it was between 2:30 and 3 a. m. The spot where the woman lay on the bank still gave evidence of her

wet clothing and the position of her body.

Officers continued searching for the bodies of Smith and Walker late Wednesday. They considered a slight possibility that the men might not be in the canal, but neither had been reported elsewhere.

The missing bodies had not been recovered by early Thursday morning. Searchers worked until nightfall but abandoned the task until morning, when another boat is scheduled to be launched in the canal for aiding the work.

Both dead women were members of prominent Indian families on the Klamath Indian reservation. Mrs. George is the daughter of Watson Duffy, and Mrs. Gertie Barkley Duffy is the daughter of Mrs. Effie Barkley.

Both city and county officers stated that an intensive drive against the sale of liquor to Indians, both on and off the reservation has been underway, and it has recently been reported that bootleggers were meeting Indians on the hills east of town rather than in the business district. Police said a partially filled bottle of whiskey was found in Mrs. Duffy's car, and a second bottle, containing wine, was found floating in the canal.

Two Indian women, Roselda Jackson Hood, and Agnes Goddard Chocktop, plunged into the canal at the Main street bridge about 3 o'clock Wednesday afternoon and were rescued from drowning by bystanders and police officers who managed, by hook and rope, to get the two ashore.

Bystanders said the girls had stood on the bridge weeping and suddenly ran down the path and into the water. The Hood woman is a niece of Mrs. Dean George, accident victim, and Agnes Chocktop was said to have been engaged to Ted Walker, for whose body police continued to drag late Wednesday.

Officers ordered Indians away from the bank of the stream where operations have been underway since early morning. Both women were lodged in the city jail on a charge of drunk and disorderly.

"According to reliable reports, on April 26 there arrived at the Finnish port of Abo four German transport ships from which about 12,000 German troops landed with arms, tanks, artillery, etc. On April 28, the troops began to move to Tampere."

Germans here asserted the Nazi troop arrival was merely part of the regular movement of troops through Finland to Norway which has been going on for some time under agreement with the Finnish government.

It was the first time, however, that notice of such movements had appeared in the soviet press.

Pravda, in a separate article on "The great force of Stalin's friendship of peoples," referred to the Karelian republic created after the soviet-Finnish war last year.

"The toilers of the Karelian Finnish republic are living in friendship," it said. "Beyond the border in capitalistic countries now as never before are being developed national hatred, beastly chauvinism and the ideology of looting war."
