Political matters are receiving more and more attention as time moves on, and in a month or two we may expect the interest in politics will be equal to what the railroad excitement is now. The republican state and county conventions have not been called yet, but we hear they will probably come off in April. The election in Oregon in June will be the first state election this year, and being thus at the head of the column, it ought to carry, as a good example to the states which follow, the good flag of republican progress and prosperity. And it undoubtedly will. The prosperity which the country has enjoyed under the present republican rule will be continued, and no one can reasonably be so blinded to the true interests of the country or his own interests as to wish otherwise. Under the present administration this country is moving forward with giant strides towards greatness, and there is no nation that is more respected and honored or is entitled to feel prouder than this.

There is a bill now pending before congress, called the Foster bill and which is very liable to pass and become a law, providing for the leasing of the public lands which are suitable for grazing purposes, to stockmen for terms of ten years, with the right of renewals. If the bill becomes a law it may cut little figure in this country for good or ill. But in localities where a large proportion of the land belongs to the government, it might be disastrous. In fact, it is denounced by those who oppose it, as a move on the part of great eastern syndicates to get control of the public domain, the result of which would be to shut out settlers and everybody else who is outside the combination. Nearly all public land may be used for grazing purposes, and what would hinder a combination of speculators from leasing the whole of it? Where would then be land for homesteaders? Such a law, unless it is greatly changed from what it now appears, would shut off the tide of immigration to the west more than could any other cause whatever. People should carefully consider the proposed law and if they deem it will be injurious to the west, they ought to make immediate opposition by petitions to congress.

THE CONGRESSIONAL RACE.

The ambition to be a representative in the congress of the United States is a laudable one, and while we do not by our position attempt to disparage the efforts of any man to be elected to congress from this congressional district, yet we must say in candor that we can see no reason why Hon. Thos. H. Tongue should not be his own successor. He has fulfilled every reasonable expectation of his constituents, he has ably represented Oregon, and has made such an enviable record in congress that to-day he occupies a commanding position in the lower house. His assignment by Speaker Henderson to be chairman of the committee on irrigation of arid lands was a good one, and conferred favor and influence upon Oregon in that body. Besides, as such chairman, Mr. Tongue is in a position to bestow great benefit upon the eastern part of our state and the western states which have so many acres of arid lands which might be reclaimed by proper congressional action.

The reason Iowa has the strongest delegation in congress to-day is because that state makes it a practice to return her congressmen with good records, to our national legislative body. Maine has always been strong in congress because of this same practice, which Iowa is following. The wisdom and advice of her congressmen are always sought in any proposed important legislation, and also, upon important national policies generally. It would be the height of folly for Oregon now to turn down so valuable a man as Mr. Tongue, and we are persuaded to believe that the people of this district intend to do so. We believe Klamath county is for Hon. Thos. H. Tongue for congress unequivocally.
