

LOCAL NEWS.

The county court began its regular session here yesterday.

A son was born to Mr. and Mrs. Robt. A. Hopkins of Ashland, Monday, the 5th inst.

A party of fourteen people from Michigan arrived at Medford Sunday to locate permanently.

Paisley had a series of earthquakes on the 26th, 27th and 28th ult., but all were mild and did no damage.

Ashland authorities are still prosecuting citizens charged with violating the local prohibitory liquor law.

Judge Smith's auction sale at Altamont is in progress today. J. O. Hamaker of Bonanza is officiating as auctioneer.

David McComb arrived here from Pelican bay the latter part of last week, having closed a term of school at that place.

Up to date 763 voters have registered in this county. There should be 1,000 by the time the books are closed on the 15th inst.

We are requested to announce that Rev. J. B. Griffith will preach at the M. E. Church in Klamath Falls next Sunday morning and evening.

The Prineville Journal is filled with timber notices, the result of a numerous lot of individuals filing on claims along the Des Chutes river.

J. F. Adams came up from Merrill Sunday, accompanied by a force of men, who were given employment on the ditch leading from the river near here.

Moore's Comedians were giving entertainments at Alturas last week. A recent letter from Mr. Moore to J. V. Houston reports that they are doing well.

The proposition to issue bonds to the amount of \$20,000 for the purpose of building a sewer system at Ashland was defeated there by a vote of 105 to 295.

J. P. Hagan arrived at Merrill Sunday from Kern county, Calif., with 220 mares, ten stallions and two jacks, all blooded stock. We understand they are to be kept on a ranch near there.

An effort is to be made to raise tea in the Rogue river valley, the experiment being encouraged by the Southern Pacific Co., which has received and distributed a large number of tea plants.

R. M. Ross of Seattle, who has been here several weeks and invested in some town property, bought three lots of Maj. Worden on Monday. Mr. Ross has abundance of faith in the future growth of this place and vicinity.

The Medford Mail reports that Wm. Brown and family have arrived from Del Rio, Texas, and that he will engage in the stock business in Jackson or Klamath counties. Mr. Brown can be safely assured that no spot on earth excels Klamath for stock growing.

Shanko Leader: The Columbia Southern Railway Co's surveyors have finished the preliminary survey to Bend and are now encamped at this place. In a couple of days they will start out again to make the permanent location of the contemplated extension of the road.

Thos. J. Gibson, who killed B. Schonbacher in Josephine county, was tried at Grants Pass last week, resulting in a disagreement of the jury. The ballot stood ten for murder in the first degree and two for manslaughter. The case was continued until the next term.

A. Castel has given us temporary charge of a chair which he values highly on account of its historic significance. It is the chair which was occupied by Capt. Jack, leader of the Modoc war, just before his execution at Fort Klamath. The chair shows age, but was well built and is still solid and serviceable.

O. Short says he intends to devote eighty acres of his Spring lake ranch to potatoes this year. He never fails to have a big crop. If there is a scarcity of potatoes, he will derive good prices. If there is a general abundance, he will feed and fatten hogs on his surplus. Thus he can make the crop profitable whether the season brings plenty or not.

The republican state campaign was opened at Ashland last Thursday night by a large and enthusiastic meeting in Chautauqua tabernacle. Speeches were made by W. J. Furnish, nominee for governor; C. W. Fulton, and J. H. Ackerman, nominee for state superintendent. Other candidates present were A. M. Crawford, nominee for attorney-general, and J. J. Whitney, nominee for state printer.

Lowe's Madison Square Theatre Co., advertised to appear in Klamath Falls this week, canceled the engagement on account of difficulty in getting teams to bring the members here from Medford, where they showed last week. According to all

accounts, the company was much above the average and cancellation of the dates is regretted. J. V. Houston informs us that when he received the telegram announcing the company's decision to not come, all seats in the opera house had been guaranteed to be taken for the opening entertainment.

Alex Martin Sr., who arrived from Oakland, Calif., Sunday, has kept informed as to the condition of B. Van Brimmer, who is under treatment in that city for a cancer which was removed from his face some time ago. When Mr. Martin left Oakland, Mr. Van Brimmer was not feeling so well as usual, but he had merely caught a cold and has since greatly improved, according to a letter received by Mr. Martin after his arrival here. There seems to be good reason to expect Mr. Van Brimmer's recovery and return to Klamath Falls, which is most welcome news to his numerous friends here.

The people of Lake City, Modoc county, have been terrorized lately by a "wild man," who has especially alarmed children by frequently making his appearance while they were returning from school. He is thought to be a man by the name of Wright who many years ago was sent to the insane asylum from that locality. Not hearing from him for a long time, his wife secured a divorce and afterwards married a man by the name of J. F. Cole. At Cedarville, where Wright was seen lately, he is said to have avowed his intention to "kill the man who married his wife." An effort is being made to capture him.


