ELECTED MAYOR OF SPOKANE.
The Oregonian of May 7th has the following:
SPOKANE, Wash., May 6.—L. Frank Boyd, assistant postmaster and ex-city clerk, was yesterday elected mayor by 155 plurality over W. H. Acuff, nominee of the Municipal League, who was his closest opponent.
Mayor-elect Boyd was the nominee of the regular Republican party and is one of the best-known newspaper men in Spokane, is personally most popular and has been a resident of Spokane for 14 years. This is the first time he has been named for an elective office, his other public service being through appointments.
Mr. Boyd is a brother of our townsman, Dr. E. J. Boyd.
