## CONSTRUES LAW OF IRRIGATION

Washington.—The Assistant Attorney General has just rendered an important opinion on the following questions:

First—Whether one who has made a homestead entry, not exceeding the farm unit limit, either under the provisions of the Reclamation Act or under the general law, may obtain water for such a tract and also for one or more other tracts of which he is proprietor, provided the area held in private ownership limit fixed by the Secretary of the Interior.

Second—If the homestead entry was made prior to the Reclamation Act withdrawn and contains irrigable area in excess of the farm unit limit, whether for the purposes under consideration, the excess area is to be regarded as of the same status as land in private ownership.

"A person who has made or may make homestead entry of lands withdrawn for disposal under the act of June 17, 1902 (32 Stat. 229) and subject to the provisions, limitations and conditions of said act, may obtain water for such tract, and may also obtain water for one or more tracts of which he is the proprietor, not exceeding the limit of area fixed by the statute, authorizing the use of water for land in private ownership, or as fixed by the Secretary of the Interior.

"If the entry was made prior to the withdrawal under the Reclamation Act, the entryman may be entitled to the right to the use of water for the irrigable area of the land entered, and also for such area of land held by him in private ownership, which added to the irrigable area of his entry, will not exceed 160 acres.

"While there appears to be no restriction in the act upon the right of a homesteader to the use of water for land owned by him to the extent of area allowed to any one land owner, it has been deemed advisable to administer the law through the instrumentality of water users' associations, which are organized by the owners of land within the project.

"By the contracts heretofore made with such associations by the Secretary of the Interior only those who are or may become members of such associations will be accepted as entrymen or applicants for the right to the use of water which may be impounded or controlled by the works of such project.

"Under the articles of incorporation and by the laws of such associations, which are part of every contract, every member or shareholder of the association, whether he be the owner of lands or entryman of public lands, is restricted in his holding to 160 shares of stock, one share being allowed to each acre or fraction thereof, so that the Secretary of the Interior, by entering into a contract with such associations, has fixed 160 acres as the limit of the right to the use of water by any one person. Whether the land irrigated is entered as public land or is held in private ownership, or under both rights."

## ON THE EVE OF WATERLOO

Unpublished Letter Written by Marshal Blucher to His Wife Is Discovered.

There has just been discovered in the family archives of a landed proprietor in Mecklenburg a hitherto unpublished letter written by the celebrated Marshal Blucher to his wife on the eve of the battle of Waterloo. The letter is couched in the unique style and spelling peculiar to the old soldier, which, however, are partly lost in the following translation from the German: "Comprenez, June 17. Here I sit in the room in which Mary Louisa spent her bridal night. It is hard to imagine anything more beautiful than Comprenez. What a pity that I must part from here to-morrow, because within three days I must be in Paris. It is possible, and most probable, that Comprenez will be handed over to me and Wellington. Do not think I can do anything better than to have him shot. This would be a service to mankind. In Paris he is wholly deserted; everybody hates and despises him. I believe this will be all over in a short while and then I shall hasten home. There are many pretty things here, but I must not take anything away.

## PIGEON CAUSES HER DEATH

Pet Missing Several Months Is Found Blocking Up the Stovepipe in Owner's Room.

In the Wiltshire village of Zeala, England, a death has been caused by a pet pigeon. Two young women living at the rectory were found unconscious in their bedroom on Monday morning. One of the girls, Miss Maud of Southampton, was dead before the doctor arrived, but the other revived after some time. It appears that a fire had been lighted overnight in a small stove which was connected with the main chimney by a flue. The girls retired to rest noticing nothing except that the fire smoked considerably. When the stove was removed for investigation the body of a pet pigeon which has been missing for some months, was found blocking the pipe. The poisonous fumes had thus been driven back into the bedroom. The coroner's jury returned a verdict of death from C. misadventure.
