Suit for divorce.

To Pauline Schmor, the above named defendant:

In the name of the State of Oregon:

You are hereby required to appear and answer the complaint filed against you in the above entitled suit, on or before Thursday the 22nd day of November, 1906, being the last day of the time prescribed in the order for the publication of this summons, the first publication thereof being on the 11th day of October, 1906; and if you fail to so appear and answer, for want thereof the plaintiff will apply to the court for the relief prayed for in the complaint herein to-wit: For a decree dissolving the bonds of matrimony now existing between plaintiff and defendant. The summons was served by publication thereof in the Klamath Republican, by order of J. B. Griffith, County Judge of Klamath county, Oregon, made, dated and filed in this suit at Klamath Falls, Oregon, on the 9th day of October, 1906, which said order requires that summons in this suit be published once a week for a period of six consecutive and successive weeks from the 11th day of October, 1906.

Scardeman, contestant, against the homestead entry No. 3145, of Sarah M. Reasoner, concrete, made August 10th, 1905, for the S E 1/4 of Sec. 15, T. 28S., R. 9 E. W. M. in which it is alleged that said Sarah M. Reasoner died about the month of August, 1904; that the only heirs at law, as successors in interest of said deceased known to this agent, are: Frederick K. Reasoner, Bertha B. Baumgard, Alden E. Reasoner, Charles H. Reasoner, J. Chandos Reasoner and A. Myrtle Ganters; that said Frederick K. Reasoner is also the administrator of the estate of Sarah M. Reasoner, deceased; that said Sarah M. Reasoner never, during her lifetime, resided upon, cultivated or improved said described land, nor any portion thereof; that none of the heirs at law, successors in interest, legal or personal representatives of said deceased, has at any time resided upon said land, or any portion thereof, or improved or cultivated the same or any portion thereof; that said Sarah M. o'clock a. m., on November 27th, 1906, before the Register and Receiver at the United States Land office at Lakeview, Oregon.

The said contestant having, in a proper affidavit, filed September 27, 1906, set forth facts which show that after due diligence personal service of this notice can not be made upon the above named Frederick K. Reasoner, Bertha B. Baumgard, Alden E. Reasoner or Charles H. Reasoner, it is hereby ordered and directed that such notice be given said Frederick K. Reasoner, Bertha B. Baumgard, Alden E. Reasoner and Charles H. Reasoner, by due and proper publication.
