The Merrill bank is now located in its own building which is the first brick structure to be erected in our town.

Merrill is justly proud of this financial institution. It was just opened here the 25th day of May of this year as a branch of the Klamath County Bank of Klamath Falls, one of the strongest financial institutions is the Northwest. At the close of business Wednesday night Cashier Merrill reports that the deposits footed up just \$48,899.47, which not only shows that our people have faith in and appreciate its convenience but that the community is prosperous.

This is certainly a good showing for a new bank and as the deposits in a bank are a sure index to the financial standing of the country in which it is located the standing of Merrill and the valley is obvious. Cashier Merrill says that they had every reason to expect good things of the town but business has been much better than they expected.

An old gentleman named Redmond Joyce was run over by a Nevada and California train a short distance from Wabuska last Sunday. He was a prospector and had made some locations on reservation ground when the reservation took place. Last Sunday he came to Wabuska for supplies. He jumped on an engine that was going the wrong way and when he jumped off was struck by the Mystic Shriners' train which was going in the opposite direction. The injured man was taken to Reno at once and placed in the hospital, where it was found necessary to amputate one of his legs. He is now resting as well as could be expected and will probably recover.

Joyce has been a familiar figure around Merrill for years. He worked for Louie Gerber a long time and was frequently here.

Merrill is to have a direct freight service beginning in the early spring. Such is the information given the Record by Capt. J. M. McIntire, manager of the J. M. McIntire Transportation Co., who was in town Thursday enroute to the falls from the Laird Grass Lake freight line where he has closed down because of bad roads.

Mr. McIntire stated that he has completed arrangements with the S. P., whereby he will take charge of all freight coming to any part of Klamath and lay it down at the consignees door at Southern Pacific rates. The plan is to have all freight billed direct from the wholesaler to the retailer at Merrill or any other place in the county. When it reaches the end of the S. P., which will be at least four miles this side of the Grass Lake station by early spring, the McIntire Transportation Co., will take charge of it, pay all freight, and lay it down to the owner without any bother on his part. The rate will have been filed in advance and each shipper will be furnished a rate sheet the same as is used by the railroad companies.
