PORTLAND—Portland flight fans believe Jeffries will whip Johnson.

PORTLAND—The government is to stock the Columbia river with sockeye salmon.

PORTLAND—The Portland Commercial club offers \$5,000 in prizes for the best essays on Oregon.

OAKLAND—Jack Fleming hurled his Pope-Hartford across the line the winner of the Oakland Portola road race in the world's record time of 64.50 miles an hour for a distance of 258 miles. The races were marred by a number of accidents, two of which may prove fatal.

DALLAS, Tex.—President Taft has been rounding up Texas in fine style and the solidifying of the South goes merrily on. Large and enthusiastic crowds cheered his visit here.

SANTA FE, N. M.—A. M. Jackson of Almagordo, N. M., has filed charges with Secretary Ballinger demanding the resignation or removal of Governor George Curry.

PORTLAND—The milk supply here is becoming cleaner, the death rate among infants has materially decreased on account of the persistent campaign against unclean dairies and tuberculous cows waged by the health officers.

RENO, Nev.—A crowd of university students Saturday kidnaped Clarence H. Mackay, president of the Postal Telegraph company, who has generously endowed the Nevada State university and arrived to visit the school. He was made the guest of honor at an informal celebration by the students.

CALCUTTA, India—Quetta reports her dead at 150, though the final account of the fatalities due to the earthquakes which have been rending Northern India, cannot as yet be estimated.

PORTLAND—Mrs. W. S. Ladd, widow of the wealthy Oregon pioneer, died suddenly at her home, 293 Sixth street, shortly after 2 o'clock Saturday afternoon.

PORTLAND—W. C. Morris, ex-cashier of the defunct Oregon Trust and Savings bank, voluntarily faces his accusers and is ready to answer all questions put to him by a grand jury.

CONNEAUT, Ohio—Eugene V. Debs, three times Socialist candidate for President, said that the arrest of Guiterrez de Lara by United States authorities was an atrocity and that this country is becoming the bloodhound of despots.

BOSTON, Mass.—Lieutenant Holden C. Evans, designer of the giant steel collier, who so recently divorced his wife for allowing "Boy" Osborne to kiss her, has declared his intention of marrying Miss Frances H. Ingersoll of this city when his divorce decree is made final.

PORTLAND—Mayor Simon has ordered the town cleared of gambling and disorderly houses. Bona fide boxing will be permitted.

PORTLAND—Trains are expected to run to Madras on the Deschutes by next June.

NEW YORK.—P. H. McCarren, state senator and Democratic boss of Brooklyn, died October 23 without ever rallying from the effects of an operation for appendicitis on October 13th.

PARIS, Oct. 22.—Count Boni de Castellane has asked the court to force his former wife, Princess de Sagan, who was Miss Anna Gould, to send their children to school.

HOUSTON, Tex.—Ten acres of people gave Taft the most enthusiastic reception he has ever received in his travels through Texas.

ATLANTA, Ga.—Barney Oldfield in his Benz car made five miles in 3:52 2-5, beating his own record at Indianapolis by nearly 19 seconds.

PORTLAND—The missing ship Henrik Ibsen, which is overdue since last Saturday, is causing no little worry here.

PORTLAND—The Columbia river sawmills are now turning out 360,000,000 feet more lumber, owing to several important additions made during the past year.

RACCONIGI, Italy.—Czar Nicholas entered Italy and was given a spontaneous and very cordial greeting as the head of a friendly state.

PORTLAND.—Haywood, former secretary of the Western Federation of Miners, will be called within a few weeks to lead the Socialists in Oregon.

DETROIT, Mich.—Hughes Jennings, manager of the Detroit baseball club, has drawn \$41,500 in three years.

PORTLAND—Gigantic plans are being laid for the development of Central Oregon by James J. Hill. He has bought 3,000 acres already, including the Heryford ranch near Lakeview, and is bringing in settlers every day.

PORTLAND—Circuit Judge Bronaugh quashed the suit against County Judge Webster, who is now free to come and go.

CAMBRIDGE, Mass.—Harvard beat Brown today, 11 to 0, in the first big football game of the year.

ST. LOUIS—Taft, after dedicating the new Federal building in East St. Louis, boarded the Oleander for the river trip to New Orleans. He is very hoarse, and will confine himself to five-minute speeches hereafter.

MADRID—Spain has decided not to push the war against Morocco any further, since it is considered a costly and bloody affair, accomplishing nothing.

MEDFORD—The announcement that John R. Allen, president of the Pacific and Eastern, a company incorporated for \$1,500,000, would soon apply for franchises in the cities of the valley for an electric interurban railroad, was recently received with much enthusiasm by local business men and others. A franchise for an electric road in Medford has several times been asked for, but failed in each instance, since the local people have had little faith in those making the attempt for the franchise.

LITTLE ROCK, Ark.—President Taft's possum dinner was stolen from his special car, but he was quite happy when another was supplied. He can hardly talk, as the demand on his vocal chords has been too much, but his doctor is working hard to get him in condition for the last half of the trip.

CHICAGO—The Chicago suffragists are against the stand taken by Lady Cook, one of England's leaders for equal rights. They maintain that quiet methods will win and want no bomb-throwing, intending to make their appeal to the intellect of Americans.

MEDFORD—Sheer grit alone saved the life of William Cottrell, who resides just east of the city. A horse he was riding fell and broke Cottrell's leg, after which he rode miles until

he arrived at his home, when a doctor was summoned.

OTTAWA, Can.—Sir Wilfred Laurier at the Canadian club banquet made the announcement that the dominion government would send the veteran explorer, Joseph E. Bernier, to take possession of the north pole early next spring.

LONDON, Eng.—Having divorced his wife, J. M. Barrie, with the whimsical tendency often displayed by his stage characters, wants her back, and says he doesn't care to marry Pauline Chase. Barrie is the highest paid living playwright and England's foremost dramatist. His wife before their marriage was Mary Ansell, an American actress, Gilbert Cannon, a young dramatist and critic, with whom Mrs. Barrie is now living, was named as co-respondent.

ELIZABETH, N. J.—Charles M. Fowler, congressman from New Jersey and ex-chairman of the house committee on banking and currency, has challenged Senator Aldrich to a debate on the subject of a central bank.

NAIROBI, B. E. A.—Roosevelt is hunting amid many excitements, having had numerous escapes. It is necessary to stalk an elephant at 20 paces, when, if the shot misses, one is in danger of being killed, and as he is hunting these big mammals, he is having the time of his life.

LOS ANGELES—Five Riedrich sisters here have been married in two days. On March 18, 1902, three of them were married, and two more were married yesterday.

ALBANY, N. Y.—Rufus W. Peckham, appointed by Grover Cleveland and for 26 years a Supreme Court judge, died at his summer home here suddenly at 8:15 p. m., October 24th. He was born in 1838. An upright, pure-minded man, his loss is universally mourned.

BAKER CITY, Ore.—At the close of his revival sermon, Evangelist Shannon asked for signers to a recall petition on Mayor Pollman. Over 200 men in the congregation signed the document. The mayor has taken a stand endangering the city water supply.

ALBANY, Ore.—A big whale washed ashore while searching for candle fish, but after much furious floundering succeeded in getting back into the sea.

Carl Grubb, a nephew of Mrs. Lucien Applegate, has left for his home at Hornbrook, Cal. He is riding his saddle horse over. From there he will probably go to Imperial Valley, Cal., where his cousin, Elmer Applegate, has charge of the experimental farm, 175 acres.
