

FORT TEAM MEETS DEFEAT, 5 TO 3

CLOSE GAME PLAYED YESTERDAY AFTERNOON KEPT THE ROOTERS ON THEIR FEET AND SATISFIED EVERYBODY

By a score of 5 to 3, Klamath Falls Sunday hung one over on the hopes of the fast Fort Klamath aggregation, in a game that furnished all kinds of excitement for the big crowd of fans. As usual, the Fort team was accompanied by a big bunch of rooters, who supported their team as only a Wood River bunch can, and the din raised by the visitors and the loyal Klamath Falls rooters was worth the price of admission.

Klamath Falls started the scoring in the second inning, and Siemens brought in the first run. In the second three more came in, and one was added in the fourth and in the fifth. The Fort team scored two in the fourth, when Mulkey and Willis made the circuit of the sacks, and their final run was made by Bullard in the closing inning. At no time could Klamath Falls claim the victory, as the crowd was expecting every inning to see some of the visitors slip over a bunch of fireworks. Though several errors crept in, a number of brilliant fielding stunts were pulled off to atone for this, and the game was well worth seeing.

BANANAS WILL BE SOLD BY THE POUND

PORTLAND, June 2.—Bananas by the pound, instead of by the dozen, will be the rule among all grocers of Portland after this. When the housewife goes to the corner grocery for the famed Central American product, she will be asked how many pounds she wishes, instead of measuring up the family appetite by the number of bananas that an individual usually devours, calculation will have to be made to determine how many pounds and fractions thereof appear the banana yearning.

A few members of the Retail Grocers' association have been experimenting with the sale of bananas by the pound, and their experience satisfies them that they get a few more cents a bunch when putting the bananas over the counter on a weight basis. These few cents gain is the incentive for the change. Grocers believe that there is considerable variety in the size of bananas, causing considerable difficulty in fixing the price a dozen equitably at all times, but where a weight unit is taken, there should be no more trouble. If small bananas are sold, more of them will have to go into the pound, and the reverse where the fruit is large.

In a bunch taken by one firm to prove the advantage for the grocer in selling by the pound, the following results are given: The bunch weighed 55 pounds 13 ounces, the purchase price of which, at 5 cents a pound, being \$2.80. The stalk weighed 5 pounds 6 ounces, leaving 50 pounds 7 ounces of fruit, which was sold at 8 cents, bringing in \$4.05. There were 13 dozen bananas in the bunch, which, if sold at 30 cents a dozen, would have yielded the grocer but \$3.90.

O. A. C. STUDENT MAKES SHOWING

CORVALLIS, June 2.—Jack Pernot, who graduated from the forestry department of the Oregon Agricultural College last June, has just been appointed to the federal forest service at a salary of \$1,200, with his field expenses paid. In a recent civil service examination he was one of the ninety who passed out of 186 men from Harvard, Yale, Baltimore, Michigan, Minnesota and Washington—a fact which reflects credit not alone upon Mr. Pernot, but on the quality of forest instruction at O. A. C. His first assignment, at Albuquerque, N. M., will be as forest assistant, and will require him to report there July 1st for duty.

His brother, Fred Eugene Pernot, has also received notable recognition recently. He has been named as the John W. Mackey Jr. fellow in electrical engineering at the University of California for next year, and will go to Berkeley in September to take up graduate research work. He was one of the most brilliant members of the graduating class in electrical engineering last year, a fact that was recognized by the O. A. C. faculty by his appointment this year as assistant in electrical machine shop design.

ALLEN PASSES BOGUS CHECKS

With a number of bogus checks, the amounts on them aggregating over \$800, bearing his signature, the authorities are making an effort to find E. Allen, a local contractor, who has disappeared. A number of local

business houses were victimized by Allen's work.

Monday a bogus check for \$20 was cashed by Ed DuFault, but on account of Tuesday being a holiday, it was not presented at the First National bank till Thursday. It was then found that Allen's bank account was not sufficient to meet the face of the check. J. Kent Ballard of the Gem saloon also cashed a \$20 check, and upon his complaint a warrant, charging forgery, was issued.

Allen has been a resident of the city for the past year, and was highly respected, so his checks were passed with ease, no questions being asked. Though a vigorous search has been started, no trace has been found of the absconder.

COFFEE AGAIN BREAKS THE LAW

Frank Coffee, a real estate man of this city, who once before was placed behind the prison bars on account of his financial ventures, is again in wrong, and is being sought by the authorities. He was secretary of Crater Aerie, No. 1616, Fraternal Order of Eagles of this city, and administrator of the estate of J. M. Pine, and it is believed that he derived his revenue from these two sources, though a number of his friends may have suffered.

A few days ago Coffee left the city, and yesterday, Henry Low, Worthy President of the Eagle Lodge, received a letter from him dated at Weed, in which he stated that on account of what he had done in Klamath Falls, he was ashamed to return. Enclosed in the letter were four or five checks, drawn on a Yreka bank, and amounting in all to \$425. As these checks were found to be worthless, an investigation was made into Coffee's career as secretary of the fraternal order, and as the funds entrusted to him are missing, a warrant, charging embezzlement, was sworn out.

Whether Coffee is short in his accounts as administrator of the Pine estate is not yet known.

Earlier in the year Coffee was arrested for issuing a check on a bank in which he had no funds. At this time he was released by friends going on his bond. Sheriff Barnes of this county has taken up the matter with Sheriff Howard of Siskiyou county, and it is believed here that the man will be captured.

WHITMAN NATIONAL FOREST IS DIVIDED

BAKER, Ore., June 2.—Confirmation of the report that the Whitman national forest, with headquarters at Sumpter, was to be divided and a new district to be known as the Minam forest established, was given by District Supervisor George Cecil of Portland, who has been in Baker county investigating the work of fighting the ravages of the pine beetle. The division will be made July 1st, but both forests will be administered from Sumpter this year. It is suggested that Baker will be the headquarters for the new forest when it is finally established.

Several of the largest forests of Oregon are being cut up into smaller ones, permitting better and more effective administration. This division will please Baker sheepmen and cattle men, as it will save them the trip to Sumpter when it is necessary to transact business with the supervisor.

MAIL TO LEAVE BY EARLY TRAIN

Upon the recommendation of Postmaster Robert Emmitt, the postoffice department has just issued an order, whereby two sacks of mail will leave by express on the early train every morning, where they will meet the early north and south bound trains. This order became effective Friday morning.

As a result of this ruling, letters received at night from Lakeview, Fort Klamath, Merrill and other towns along stage routes, leave here with quicker despatch, and any local person forgetting to mail a letter in time for the afternoon train may thus have the missive started without the delay of an entire day. Mr. Emmitt's work in securing this service is being commended by local people.

SAWDUST CAUSE OF TWO ARRESTS

Upon complaint of Game Warden Alva Lewis, warrants were issued Thursday for the arrest of Charles McGowan, secretary of the California Box company, and the Long Lake Lumber company, charging the concerns with dumping sawdust into a stream. Manager W. O. Huson of the Long Lake company appeared in court for his corporation, as did Mr. McGowan for the box factory Friday afternoon. C. M. O'Neill appeared as attorney for the defense, and upon motion the case was postponed till next Saturday, in order to allow the two officials to communicate with the companies and learn in which way they are to plead.

W. F. ARANT AND MOMEYER RETURN

BOTH ARE POSITIVE THAT BAKOWSKI LOST HIS LIFE BY FALLING OVER THE RIM OF THE CRATER LAST WINTER

Superintendent W. F. Arant and H. E. Momyer returned late Friday afternoon from Crater Lake, where they went Sunday to see if any further trace could be found of the body of Bakowski, who is believed to have lost his life last winter by either falling over the rim of the lake or having lost his way and perished in the snow.

Both gentlemen are of the opinion that Bakowski must have fallen over the rim of the lake. They went through his camp, a mile and a half from the lake, and found his clothes, supplies, provisions and money, and from this evidence it is believed that this was the only camp used by the man. At the rim of the lake inside the stone structure of the hotel in course of building, was found the coat near the spot where Mr. Momyer some time ago found the empty camera boxes.

Both Mr. Arant and Mr. Momyer state that snow drifts project out over the rim of the lake in some places as much as fifty feet. A man not acquainted with the exact location of the rim would be very liable to have walked out on the drift, thinking it solid ground, to get a good view of the lake, and disappeared through the snow a thousand feet or more below. Between three and five feet of fresh snow fell during the last storm, and Mr. Arant states that the season at the lake will be very late this year, and he believes that snow will remain there during the entire summer. At Arant camp, five miles from the lake, it was necessary to dig twelve and a half feet to get into the door. The snow had drifted against the building to this height, but Mr. Arant states that the snow is from four to twelve feet deep.

LONG BEACH SOLONS SEE "APACHE DANCES"

LONG BEACH, June 1.—One of the local theaters of this city attempted to produce the "Apache dance," but on learning the nature of the performance the chief of police ordered the feature eliminated under penalty of closing the house.

The performance was given to a crowded house, hundreds of the patrons of the place being winter tourists who had seen the original production in other cities. The orders of the chief created considerable discussion among the patrons of the various amusement places, many censuring the police with being unfamiliar with theatrical productions.

On this account the chief of police requested the police commission, which includes the mayor and the civil service commission, composed of seven representative business men of the city, to witness a special performance of the pantomime this afternoon. The result of the affair was that the chief was upheld in his views, the commission unanimously deciding that the Apache dance was in the same class as the "Angeworm wiggles," tabooed some time ago, and that neither were fit to be produced before a Long Beach audience.

HIS CHILD'S "DA-DA" GIVES HIM FREEDOM

ST. LOUIS, June 1.—When Mrs. Henry Rischard was ordered by Judge Kimmel upon her husband, charged with cruelty and failure to support their little 2-year-old daughter took part in the proceedings and set the head of the family free.

As Mrs. Rischard hesitated in fixing punishment the lapping "da-da" of the child was heard. Rischard hung his head, grasped the child in his arms and strode forward.

"Will you do better by me, Henry?" the wife asked.

"Give me another chance, and I will," was the reply.

The couple left the court room arm in arm.

GARY TELLS OF STEEL CO'S HISTORY

DECLARES THAT SHERMAN ANTI-TRUST LAW IS IMPOTENT, AND TELLS OF 1907 MOVEMENT TO PREVENT BANKRUPTCY

WASHINGTON, June 2.—At the resumption of the steel investigation today, Gary said:

"I think the question is how to protect the people against organization of capital. I believe the Sherman anti-trust law to be impotent. I really think the time is coming when there will be government supervision enforced in the publicity affairs of the big corporations."

"Do you mean governmental control of prices?" asked Stanley.

"Yes," Gary replied. "Prices and everything else. I would be glad if we could go to a responsible government authority and say, 'here, properly, are the facts and costs of production.' We could then be told the prices to be charged, and what to do."

Gary further said that the American Iron Institute was formed after the flurry of 1907, to prevent a probable bankruptcy to which many manufacturers were bound to come unless the steel industry was strengthened.

LIVE NEWS FROM THE VICINITY OF SHIPPINGTON

The big dredge O'Grady has completed the dyke as far south as the Long Lake mill, and yesterday was towed back to Terminal siding by the Oakland.

The Pelican is being overhauled at L. R. McDonald's ship yard. Her pilot house will be raised three or four feet.

It is a very busy place these days at the Pelican Bay Lumber company's yard. The work train stands behind the Hanks house and a large force of men are at work upon the new siding, 1,500 feet long. It will have a 14 per cent curve. In front teams are hauling stone for the mill foundation, which will begin soon. The Eagle today had placed 400 tons of sand upon the site. The office building is well along, the frame being up, the siding begun and the roof will soon be on.

The Hanks house is being repaired. Report has it that it will be used as a boarding house for the mill crew. Two hundred men will be needed for the mill and box factory.

The Crystal, owned by Captain Jones, is on skids ready to load on wagons for conveyance to Tule Lake, there to be used for passenger traffic.

The Eagle and Modoc are very busy hauling logs and sand for the new mill. Until yesterday they were unable to get men enough for their work.

NEWS NOTES FROM MILLS ADDITION

Two new dwellings have started up this week, and a lot has been sold for a Methodist church, one block from the Mills Addition Improvement Club hall.

S. J. Bailey is permanently settled in his new home.

The people of Mills Addition wish to be informed what the city keeps a mounted policeman for. Bands of horses are often running at large. Many of the residents have already taken the matter up with Councilman-elect Ben F. Owens, who will take office next Monday.

MAYOR, DEFEATED, REFUSES TO QUIT HIS OFFICE

OKLAHOMA CITY, Okla., June 1.—Citizens of Oklahoma City today sent a committee to "reason with" Mayor Dan V. Lackey, who has refused to relinquish his office since the election of a new mayor and commissioners.

Lackey was elected mayor under the councilmanic form of government, and says he will not resign until ordered to do so by the court. When Lackey attempted to justify his position before 5,000 citizens he was hooted and jeered.

THE DEMOCRATS ADOPT THE UNDERWOOD WOOL SCHEDULE

WASHINGTON, June 2.—After a caucus lasting for twelve hours, the democratic congressmen this morning adopted the Underwood wool schedule. Today they are planning to try to force the schedule through the house of representatives. Many of

the shrewd politicians regard this action as a direct slap at William Jennings Bryan.

In discussing that matter today, Congressman Oscar W. Underwood of Alabama, author of the schedule, made the following statement: This action demonstrates clearly that the democratic members can handle the matter without any interference. We adopted the revision measure ourselves, despite the strenuous opposition of Mr. Bryan, and expect to pass the measure through congress the same way."

POLICE CHIEF ATTACKS HOBBLE AND PEEKABOO

LOS ANGELES, June 2.—Adios to the hobble skirt, "23" for the peekaboo waist and to the dump with the harem skirt. Police Commissioner John Topham is peeved at the many complaints received against Broadway oglers and has advised the women's clubs to begin a campaign against the hobble, the harem and the peekaboo, which, he says, invite attention and insult.

"Any woman regaling herself in such apparel," said Topham, "should expect to be greeted with 'whoops, my dear,' or similar salutations. Such apparel has a tendency to make a man 'feel frollesome,' for he looks upon the wearer in the nature of a freak. The way some women appear on the street is degrading, and if they would give a little more attention to such matters there would be fewer complaints against mashers. I am heartily in favor of a city ordinance making it a misdemeanor for a woman to appear on the streets garbed in either a hobble or harem skirt."

CARUSO WANTED HER FOR HOUSEKEEPER, NOT BRIDE

LONDON, June 1.—It required some of the highest, shrillest notes that Enrico Caruso could command today to express his indignation for being sued for breach of promise by a "shop girl" of Milan. The tenor was very angry, and explained with much vehemence that the case, in which she asks \$50,000 for breach of promise, was based on letters written which he endeavored to engage her as a housekeeper.

Caruso said the letters were somewhat intimate, but that they contained no promise of marriage, and after he had met the girl in Berlin with some of her family he decided that she was "low and common," and he could not engage her. He said he had asked for his letters, but had not received them.

FINDS \$50,000 IN JEWELS; GETS REWARD OF \$1,000

DETROIT, Mich., June 1.—After two weeks of search, \$50,000 worth of jewelry in a satchel finally turned up through the honesty of Anthony A. Selewsky, a bicycle dealer. The jewels were lost in moving by Waldo A. Avery, one of the leading business men of the city.

Selewsky found the valuable bag, and upon reading the advertisement in the papers offering \$1,000 reward for their return, immediately took them to the nearest police station and turned them in.

ELKS WORKING HARD FOR THE BIG INSTALLATION

Another meeting of the Antlers Club was held Thursday night when matters regarding the founding of an Elks Lodge here were discussed. All are interested, and the affair will be something not to be forgotten in a hurry.

Redmen's hall has been selected by the lodges as the permanent meeting place for the Elks Lodge, and here it will be that the lodge will be founded. F. R. Oida was named as chairman of a committee to attend to the proper decoration of the hall for the great event.

COMMERCIAL CLUB STARTS ON CROSS COUNTRY JAUNT

GRANTS PASS, June 1.—Amidst honk of automobiles and fluttering banners thrown to the breeze, about three score members of the Commercial Club left this morning on the first trip of the season on a cross-country jaunt to the Illinois Valley and vicinity. The itinerary includes all towns in the south end of the county. Other pilgrimages will be taken later in the season to other parts of the county.

CLOSED SHOP FIGHT IS LOOKING SERIOUS IN B. C.

VANCOUVER, B. C., June 2.—Unless some compromise is made in the meantime, 8,000 men will go out with the Unions, and join in the fight for a closed shop.

The printers and bricklayers are waiting for the consent of their international to join, and the street car men and telegraphers are today taking a referendum. If all strike, it will make a total of nineteen unions out.

WILSON SAYS WE'RE ALIKE

FINDS NO DIFFERENCE AT ALL IN THE ADVANCE OF POLITICS IN THE EAST AND IN THE WESTERN STATES

TRENTON, June 5.—Woodrow Wilson, who returned home from his Western trip today, said:

"I am greatly impressed with the similarity of movement in politics on both sides of the continent. The people are everywhere considering principles, not men, and have but little regard for parties."

He declares that there is a real opposition to a reciprocity treaty with Canada.
