

SEVENTEEN WERE GIVEN DIPLOMAS

GRADUATION EXERCISES AT THE HIGH SCHOOL WERE ATTENDED BY BIG CROWD OF INSTITUTION'S FRIENDS

Seventeen students, composing the largest Senior class in the history of the Klamath County High School, finished their high school work Friday night, and were presented with diplomas in the midst of most enthusiastic applause from the large audience assembled in the high school auditorium.

In honor of the occasion, the halls of the school and the assembly hall were tastefully decorated for the occasion. The school colors, red and white, and pennants of the leading Western educational institutions were used with splendid effect in the halls and corridors, while in the assembly hall dark and light green, the colors of the graduating class, were used as a base for decorative work. Streamers of these shades swung from the center of the ceiling to the walls, and evergreen was used in profusion. Over the rostrum an illuminated green sign flashed out the class motto, "Faugh a Ballach." The rostrum was banked with potted plants.

At the hour set for the exercises, the high school orchestra struck up a march, and the seventeen members of the graduating class, together with Rev. C. H. Hilton, who pronounced the invocation, Dr. Todd, who delivered the address to the class and the members of the faculty and county board entered the room, marched through the aisles and took their seats on the rostrum amid great applause. The white gowns of the girls and the bright and happy faces of all the members of the class added much to the beauty of the scene.

Following a short, but appropriate invocation by Rev. Hilton, and a rendition of a selection by the orchestra, Miss Nellie V. Cogswell delivered the salutatory, during which, in a beautiful manner she spoke of the hopes and ambitions uppermost in the minds of her class. Miss Cogswell, who was class poet, has always been one of the leading literary lights at the high school, and her address showed great care in preparation and delivery.

Dr. Todd, vice president of Willamette University, addressed the Senior class on "The World Citizen," impressing upon all the need of a higher education, bringing forth figures to sustain his point, putting the proposition in cold cash. Dr. Todd is a firm believer in the universal government at some time, and he cited great men in the past centuries who have held the same idea. He spoke of the peace congresses, of the arbitration boards, and of other current happenings that are tending to draw the nations of the earth more closely together. "The world needs a leader in this universal movement," said the speaker, "and it looks to America for that leader."

According to Dr. Todd there are four elements today that are gradually binding together the races and nations: The social element, through intermarriage, a feeling of social equality, and a gradual change in the mode of dress to that worn in America and Europe; the commercial element, on account of which nations will protect weaker ones to keep safe the investments of their people in the weaker country; the brotherhood movement, which brought about through the spread of Christianity, is rapidly sweeping the world and uniting mankind; and lastly, the educational element. In the last, he told of the students from other lands who come to this country to study American ways and learning, and of American students who go abroad to study the learning of other lands.

These, he said, returning to their native lands, and teaching what they have learned, tend to place all nations on a similar plane.

In closing, he reminded the class that the movement he spoke of was yet in embryo, and he urged the class to prepare to be "big" to cope with the questions that will arise. "Be true to your government; be true to your conscience; be true to your God," said he in conclusion. "In His name, go forth."

"As the Dawn," was the title of a vocal solo rendered by Mrs. Don J. Zumwalt, and as usual her rich, clear tones captivated the entire audience. Miss Fay Hogue played the accompaniment.

In her valedictory, Miss Jessie Telford paid a glowing tribute to the members of the faculty of the high school, and in a touching manner she bade farewell to the class to the Klamath High School, so full of fond memories to them, and to the student body.

County Judge W. S. Worden, who presented the diploma, reminded the

Seniors that some of them attended school under him. While Judge Worden did not make a long talk, it was none the less forceful, and he concluded with the adage, "To thine ownself be true."

Immediately after the presentation of the great amount of floral offerings received by the Seniors were brought in. Following this, the class formed a line in the hall, and received the congratulations of their friends.

UPPER LAKE IS ADMIRER BY ALL

H. B. Chao of Portland, a retired business man of financial and social standing, is spending a few days in the city. Wednesday he made a trip on the steamer Klamath, as he wished to inform some of his Portland friends of the desirability of the Upper Lake resorts for camping out, and this is what he said to a party of passengers on the return trip:

Several others took an outing on the Klamath, including Herbert E. Barry, Mrs. Robert Clay and Miss Amy Wing. Mr. L. H. Bath, who is connected in business with Col. M. G. Wilkins, accompanied his brother, A. V. Bath, a new arrival, on the trip. The latter is a kodak enthusiast, and occupied every minute of his time, when the stops were made, in snap shooting everything, with the exception of the time he occupied in getting outside of a big dinner at the Tavern, when the attractions of Mrs. Griffith's eatables took up his entire attention. Mr. Bath will mail several hundred cards to his Ohio schoolmates, the result of his own collection.

CONCRETE STARTS ON DIVERSION DAM

The work of building the big diversion dam on Lost River, near Wilson's bridge, has been commenced in earnest by George C. Clark of Everett, Wash., the contractor, and concrete is now being poured in the forms. The work will be rushed along as fast as possible, and Mr. Clark expects to finish by the end of the summer season.

The purpose of the dam is to divert the waters of Lost River into the diversion channel, or canal, through which the water will run for seven miles to be emptied into the Klamath River. The dam is to be of concrete in the form of twenty-one hollow arches, and the dam will be U-shaped. The crest will be 300 feet wide.

For some time past the Clarks have been shipping their machinery, cement, lumber and other supplies to the works, eleven miles from here by means of two large tractors, with especially constructed carriages. In addition to this, the material will be shipped to the works by another method, as the Southern Pacific has just finished a spur track from the railroad yards north of the bridge to the canal. This spur track runs along the canal for about 300 feet, allowing three or four cars to stand on the bank at one time for unloading. From these cars the material is to be loaded on canal boats and hauled down the river with horses as a motive power, to a point within two miles of the dam site, where cargoes will be taken off the boats by means of a derrick and hauled to the camp by wagon. By using both the canal boats and the traction engines, the transportation of necessary supplies can be greatly facilitated.

HOUSE TACKLES WOOL SCHEDULE IN CAUCUS

WASHINGTON, June 1.—The house democrats met in caucus at noon today to struggle with the problem of revising the wool schedule. Underwood predicted the adoption by a two-thirds vote of the ways and means bill, reducing the tariff fifty per cent. The senate considered the Lafollette resolution for another Lorimer investigation. Senator Works of California said he believed that the former inquiry was not properly conducted.

RANCHER ENDS HIS LIFE WITH GUN AT GRANTS PASS

GRANTS PASS, June 1.—Wilbur Mellick, living on a ranch near here, committed suicide by shooting himself through the head with a revolver. Despondency is believed to have been the motive for his act. Mellick and his wife had been working on the farm since last March. His body was found in his bedroom by his oldest child.

SHEEPMEN FEAR THEY WILL LOSE MORE RANGE

BAKER, June 5.—Wool growers of Baker and Union counties are up in arms over the proposed division of the Wallowa national forest and the creation of a new forest of the south half of it, to be known as the Minam forest. They fear that this is a step to still further limit the range on which they are allowed to graze their flocks. They assert that Wallowa county has been favored, and that the sheep from that county have increased in number on the reserve, while the Baker and Union flockmasters have been steadily compelled to reduce their flocks.

They also charge that the forest officials have been guilty of sharp practice in not giving them a hearing before the division was ordered.

The Baker-Union Woolgrowers' association will take the matter up and attempt to secure assurances that they will not be curtailed in the grazing of their flocks in favor of the northern sheep men.

SHOOTS HERSELF AND JUMPS OUT OF WINDOW

SAN FRANCISCO, June 5.—A victim of melancholia since her husband's death two years ago, Mrs. Johannes Wulken, aged 48, shot herself and jumped from a third-story window. Both her arms and her skull were fractured. She died in the hospital.

FERRIS DOES NOT WANT TO BE A PRESIDENT

SAN DIEGO, June 5.—Insurrecto Captain Harry James at Tia Juana today gave out a letter from Dick Ferris, declining the provisional presidency of Lower California.

The letter was accompanied by a new republic flag which was unfurled today. The letter appealed for unity of ideas and patriotism in ambitious and future actions.

LOSES LIFE IN EFFORT TO WIN 50-CENT BET

NEW YORK, June 5.—In trying to win a bet of 50 cents and to prove to friends that he was a daring climber and not afraid to look down from great heights, Forester Anderson of West New York started up a forty-foot flagpole at Bergenline avenue and Eleventh streets.

Anderson, who is married and the father of three small children, laughed when he called to a party of his friends:

"This is the easiest money I ever won."

He reached the top of the pole without apparent exertion, and then to make sure of winning his bet, he stood on top of it. He lost his balance and dived to the street. His death followed a few minutes later.

JOY RIDE IN BUTTE COUNTY, CALIF., ENDS IN THE DITCH

CHICO, Calif., June 1.—Geo. Wickman of Gridley is dead, Frank C. Hackett of Gridley is fatally injured and Thomas Smith of Oroville is badly injured as a result of an automobile accident last night near the Rippey ranch in Eastern Butte county. The only member who escaped unhurt is Neil Dehaven. The auto party was returning to Gridley from Oroville. Wickman, the owner of the machine, was driving. His companions urged him to go faster, and he was soon driving along at the rate of about fifty miles an hour. Near the Rippey ranch, where the road makes a sharp turn, the car skidded and turned a somersault. The men were thrown out, and the car landed on top of all but Dehaven, who was thrown clear of the wreck.

PUNISH REPORTERS FOR NO TELLING OF BRIBERY

COLUMBUS, Ohio, June 2.—The senate today barred a number of newspaper men from the floor of the senate for refusing to testify in the bribery hearing. The George B. Nye bribery case was resumed today, with Archie Kennell, a reporter of a Cleveland newspaper, on the stand. He was called by the state to rebut the testimony of Harry Wilson of Cleveland, a witness for the defense, who testified against the character of Stanley Harrison, assistant sergeant-at-arms of the senate. The grand jury resumed its sessions this morning.

TO OPEN LAW OFFICE HERE IN KLAMATH FALLS

The latest attorney to come to Klamath Falls for the purpose of opening a law office is J. H. Carnahan, who arrived here Saturday from Portland. Mr. Carnahan has engaged a suite of offices in the White-Maddox building, and expects to soon open his office.

Mr. Carnahan is a graduate of the Georgetown University, and for the past two years has been engaged in the capacity of special agent for the General Land Office in Oregon and Washington. During the past winter he worked in Alaska on the coal land cases for the government, and his work took him this spring to Chicago, Pittsburg and Detroit.

Resigning from the service of the government on May 21st, Mr. Carnahan says he cast about Oregon and Washington for a place to locate, and decided that Klamath Falls, on account of its future, was the place for him.

GETS CONTINUANCE IN HALL OF RECORDS CASE

LOS ANGELES, June 5.—Job Hariman has secured a continuance of the arraignment of the three alleged hall of record dynamiters, Conners, Maple and Bender, until tomorrow, when the trial date is to be fixed. The McNamara attorneys will assist in the defense.

PORTLAND IS ASSURED COMMISSION GOVERNMENT

PORTLAND, June 5.—The commission form of government is assured the residents of Portland. It does not matter whether republican-labor candidate, A. G. Rushlight, wins or Mayor Simon is re-elected in the municipal election.

A heavy vote was polled at noon. The business interests are supporting Simon and George H. Thomas, the democratic candidate.

SWAN LAKE VALLEY IS TO BUILD NEW SCHOOL

Two years ago, a strong wind in the Swan Lake Valley blew a tree down on the Swan Lake school house, completely demolishing the structure, and since that time, school has been held in different vacant buildings in the community. Now however, the people of the district are determined to end this inconvenience for the children.

Saturday, County School Superintendent J. C. Swan went out to Swan Lake Valley, where he met with the Board of Directors in regard to the matter. As a result of the meeting, advertisements for bids for the construction of the building is now being published.

SCHOONER CONFISCATED FOR ILLEGAL FISHING

VICTORIA, B. C., June 1.—The gasoline fishing schooner Edrie of Seattle was condemned and confiscated to his majesty the king as a prize by Chief Justice Hunter today for fishing within the three mile limit off Lanz Island at the mouth of Vancouver River, where she was seized in February by the Canadian cruiser Rainbow, which fired a blank shot, causing the Edrie to leave to, and sent an armed party on board, who took the vessel in tow to Vancouver, where she was heard.

The case was remanded to give the chief justice an opportunity to examine the two vessels and inspect the range finding apparatus of the Rainbow.

They Will Return

The ceremony was performed in the parlors of the Livermore hotel, and with the exception of Miss Myrta Carter, the bridesmaid, only the members of the family attended. Arthur

Livermore, a brother of the bride, acted as groomsmen.

Following the ceremony a wedding breakfast was served, and the happy young couple left on the early train for their bridal tour. Going to Portland, they will spend several days at the Rose Carnival, the guests of Mr. McFadden's relatives, who are prominent residents of the Rose City. From Portland the couple will go to Seattle, where they will embark on a steamer for San Francisco. It is their intention to be away for three weeks, and upon their return they will reside in Klamath Falls.

The bride is the only daughter of Mrs. A. B. Livermore, who, with her sons, conducts the Livermore hotel. The king has named Lord Roberts and Lord Kitchener among the boat-ers of the royal regatta.

RECIPROCITY IS ISSUE IN IOWA
