

EXCURSION WAS ENJOYABLE TRIP

THOSE WHO WENT UP THE LAKE ON THE STEAMER KLAMATH HAD A FINE TIME OUT AROUND ROCKY POINT

Sunday morning quite a crowd assembled at the Shippington dock to take in the barbers' excursion, and at a little after 9 o'clock the trim steamer Klamath cast off and started on the run up the lake. After the arrival of the fast boat at Rocky Point, Williams' far-famed resort, the crowd scattered, some parties enjoying picnic lunches and others partaking of the excellent trout dinner prepared at the hotel.

During the afternoon many went fishing, others took advantage of the occasion to tramp through the woods, while a great many others journeyed with Captain Reed of the Klamath to the Harriman Lodge, a short distance from Rocky Point. At 3:30 the Klamath left Rocky Point on the return trip, and arrived at Shippington pier at 6 o'clock.

The Klamath is quite a favorite with excursionists and pleasure seekers, and hereafter it will make the regular Sunday trip to Rocky Point, bringing the Klamath Falls Military band, which organization will give weekly excursions. At Rocky Point the band will give concerts and musical selections will be played while the boat is steaming through the water.

YOUNG LINKENBACH IS GIVEN THE DECISION

In what is declared by all of the fans to be the best exhibition of the manly art ever pulled off in Klamath Falls, Jack Linkenbach, the local youth, was given the decision over his opponent, C. E. Tucker of Portland, in the twentieth round. The bout was hard fought throughout, and both men are deserving of the highest praise for their cleverness and gameness throughout the gruelling contest.

Tucker was the first to enter the ring, and his appearance brought forth great applause. There was some delay before Link appeared, but the crowd by its applause, showed that it had not forgotten him.

There was some discussion as to who was to referee. The articles of agreement specified Billy Hatfield, but it was reported that owing to an injury to Hatfield, he would not be present, so Jack Crawford was summoned. Both men were present, and then the discussion arose, Tucker claiming that Crawford came, as Hatfield was injured, while Linkenbach maintained that he gave the club three days' notice that Hatfield would be there. Hatfield recommended Bob Cooke, for six years athletic instructor of the San Francisco Athletic Club, who knew neither contestant, but in the end Hatfield was chosen.

For the first four rounds, it looked as though Linkenbach had a walk-over, for he plainly outclassed his older opponent, and carried on the fight. Linkenbach shows the effects of his training under Spider Welch already, for the lad was much quicker on his feet, and proved himself to be an artful dodger.

In the fifth Tucker took a brace to himself, and came up strong at the tap of the bell, and for the sixth and seventh he forced a great deal of the fighting.

Commencing with the tenth round both men worked like demons to land, and each took terrific punishment in the hope of being able to land a knockout blow. The gameness of each man was clearly demonstrated, and it did not take the fans long to realize that they were watching the best bout ever staged here. There was much discussion through the audience during the last rounds, as to which man was getting the better of the combat, some declaring that Tucker was stronger than ever and had the Dutchman practically at his mercy, others pointing out that age was telling on Tucker, and that he would not be able to withstand the onslaught of the lad's blows for a round more. In spite of the predictions made every time the bell rang that this would be the last, no knockout came, both men, owing to their clever foot work, keeping on their feet throughout.

At the close of the twentieth, Referee Billy Hatfield held up the hand of Linkenbach as winner of the bout, and immediately there was an uproar in the house, as those who thought Tucker entitled to the bout declared that he had been robbed. No matter in whose favor the bout had been decided, there would have been criticism heaped upon the referee, though both sides would, perhaps, have been pacified with a draw decision.

The crowd was worked up to a great pitch when that prince of ring generals, George Mapleson, introduced Spider Watson of Sacramento and Bobbie Burns of San Francisco, two clever bantamweights, who were matched for a ten-round bout. Frank Williams was introduced as referee of the bout.

This bout went two rounds, and though Burns was given the decision on a foul, Watson had the bout all his own way. In the first round neither man did any damage, the time being spent in feeling the ground and attempting to draw out his opponent. In the second Watson started right in with the bell, and landed to the wind. After a little sparring Burns slipping one to Spider's face, and Watson then cut loose, retaliating with two to the face and body. After this the fight was all Watson, with Burns lingering in the clinches. Toward the end of the round Burns had lost the power of guarding, and was rushed to the ropes. Just as the bell rang Watson had rushed in to finish the fight, and struck one blow after the bell rang. Williams gave the bout to Burns.

George Mapleson introduced Spider, Welch, the veteran lightweight, who is managing and training Jack Linkenbach. The crowd gave the Spider a great ovation. In behalf of Watson, Mapleson announced a challenge to meet Burns in a twenty-round contest for \$250 side bet at 116 pounds, winner to take all.

Shooting affray may end fatally. WALLOWA, June 2.—Lem Graham was seriously wounded in a gun fight at the Joseph school house, three miles above the mouth of the Grand Ronde River. The shooting was done by Loren Hawks, who fired two shots at Graham, one of the bullets entering the stomach and the other the right groin.

According to a report, the shooting occurred over a horse race which took place at the mouth of the Grand Ronde. The dispute was over the merits of the horses owned by the men as to speed. It is reported that the men were somewhat intoxicated, and following a heated altercation Graham fired the two shots.

Hawks is about 35 years old, and has been in that section for about three years, having been employed by R. R. Steen at his Billy Creek ranch for a period. Graham is also well known in the Joseph Creek section. Hawks was one of the men who were riding the outlaw horses at the Grand Ronde picnic, and was thrown from his mount when the horses ran into the willows.

DRIVER COLLAPSES WHEN 500-MILE RACE ENDS

INDIANAPOLIS, June 2.—A nervous wreck after the terrible strain of the 500-mile automobile race, Harry Knight, who drove the Westcott car, has been kept under the influence of opiates. Although Knight was uninjured, the strain on his nerves was too severe for him, and after the race was ended he collapsed. It is predicted that he will never be able to drive another racing car, and his physicians fear he may suffer a permanent nervous breakdown.

The men injured in the race are resting easily. Archie Greiner, whose Amplex was dashed from the track following a tire explosion, is improving, and his physicians believe he will surely recover. The body of his mechanic, S. P. Dickson, killed in the same accident, was shipped to Chicago.

FEDERALS AND REBELS FIGHTING AT CULICAN

NOGALES, June 1.—Two thousand and insurgents and a large force of federals are engaged in a fierce fight at Culican, the capital of Sinaloa, according to word brought here by passengers on the train arriving from Guymas today.

Many men on both sides are reported as killed and wounded. The revolutionists practically controlled the town when the passengers departed, the federals having retreated to an old church for a last stand. An American manning a dynamite cannon of his own invention did hard fighting for the insurgents.

The trouble began when Governor Rede refused to give up his office to Governor Bonilla, who was elected at the request of Madero. When Rede refused Bonilla rushed insurgents troops to Culican, which was defended by the federals commanded by Rede.

\$600,000,000 MORTGAGE IS TAKEN ON HILL LINES

ST. PAUL, Minn., June 2.—James J. Hill has announced the execution of \$600,000,000 first and refunding mortgage to secure bonds for the Great Northern and Burlington.

Mr. Hill in a statement said that the size of the mortgage was explained by the fact that the outstanding obligations of the company, which are to be refunded, amount to \$320,000,000. Financiers seem to think that Hill intends going into railroad operations on the scale of the Northern Securities company.

FOREST FIRE IN BRITISH COLUMBIA

RICH TIMBER REGION NEAR NELSON B. C., IS THREATENED AND THE FIRE-FIGHTING FORCE IS INSUFFICIENT

VANCOUVER, B. C., June 2.—Bush fire, burning near Arrowhead, 150 miles north of Nelson, broke out yesterday, and today it is sweeping that entire section. Fifty firefighters who were sent out from Arrowhead, are unable to cope with the situation.

The flames are spreading, and assistance has been summoned from Revelstoke.

Unless the wind shifts, Arrowhead is not threatened. The district is heavily timbered. No loss of life has yet been reported.

VANCOUVER, B. C., June 2.—(Later)—The winds have shifted, and the flames are sweeping toward Arrowhead this afternoon. The people are panic stricken, and are ready to move. Seventy-five additional rangers are fighting the flames.

FOOD SCARCE, PRICES HIGH, AND RIOTING IN MEXICO

MEXICO CITY, June 2.—Reports from all sections of the country tell of a reign of terror, mobs murdering and plundering in addition to committing other depredations. Governors and other officials who have resigned are abandoning their offices, and anarchy is threatened.

The trouble is reported to be due to the failure of Madero's commands to control their subordinates. The supply of food in many sections is woefully scant, and the prices for necessities is rapidly soaring. Already prices have reached an almost prohibitive point, and thousands of people are starving.

It has been suggested here that the Mexican government negotiate a bond issue, and to devote the proceeds to the assistance of the needy. Thus far no action has been taken in the matter.

RAILROAD OFFICIAL LIKES THIS PLACE

H. W. Wenzell, traveling passenger agent for the Sacramento division of the Southern Pacific, was in this city Thursday from the California capital, calling on local business men and attending to matters of importance to his company. While here Mr. Wenzell took a trip on Upper Klamath Lake, and was greatly interested in the beautiful scenery. Mr. Wenzell states that he is much impressed with the metropolitan aspect of Klamath Falls, and was met with surprises from the time he saw the fine depot till he saw the paving operations and heard of the gas plant franchise and proposed street railway.

WOMEN PAY \$100 FINE TO THE JUSTICE COURT

Bertha Rowe, Edna Rowe and Dolly West, who were arrested in a raid on the tenderloin last week, appeared before Justice of the Peace Graves Thursday and plead guilty to the charge against them. The judge fined two of them \$25 and one \$50, and sentenced all to four months in jail. This sentence was suspended upon condition that the women forsake their male co-habitants.

Mason Buys Machinery

W. H. Mason has returned from Kansas City, where he accompanied his wife and Mr. and Mrs. Burge Mason. While absent Mr. Mason purchased a mammoth dredge with drag line buckets, to be used on his contract of the Lost River diversion canal. Mr. Mason spent Thursday out at the camps, and says that the work progressed nicely during his absence, and is now well under way. He expects his new machinery here about the 20th of the month.

HAWAIIAN-PACIFIC IS DECLARED TO BE FRAUD

WASHINGTON, June 2.—The post-office department has declared the Hawaiian-Pacific Oil company of Oakland, Calif., to be a fraud, and all mail orders are being held. The concern was once known as the Roosevelt Oil company, but the Colonel forced it to change its title.

It is estimated that the company sold \$100,000 worth of stock by mail.

IRYAN SAYS WOOL FIGHT IS ON FALSE BASIS

INDIANAPOLIS, June 2.—Wm. J. Iryan today discussed the wool caucus as follows:

GLANCE OVER RULES OF THE ROAD

MANY DRIVERS AND AUTOISTS SEEM ENTIRELY IGNORANT OF THE CUSTOMS TO BE OBSERVED ON THE HIGHWAY

"Rules of the Road" should be familiar to every person who rides, drives horses or steers an automobile. How many persons who read this know the simple rules that are supposed to govern the conduct of those who travel public thoroughfares?

There is complaint that a great many drivers of teams in Klamath Falls are heedless of the rights of others and entirely oblivious to the existence of the rules referred to. Violation of these simple practices by some drivers and horsemen compel others to take the wrong side to their own annoyance and the inconvenience frequently of other travelers.

"Travel the right hand side of the roadway, pass on the left," in a sentence expresses the chief principle of the rules of the road. Coupled with that regard for the rights of others which should actuate persons on public thoroughfares as well as in other relations of life, observance of these rules would add materially to the pleasures and comfort of all who use the highways.

There is one class of citizens whose violation of the rules is palliated somewhat by early training—British born men and women who have adopted America as their home. In England the rules are reversed. In fact, the American method of keeping the right hand track and passing on the left dates from the use of cattle, the driver of oxen keeping his animals on the right in order to better manipulate his long whip over the plodding animals.

Likewise on the city streets generally now is a good time to introduce adherence to these rules. There is a great deal of traffic on Main street, and with the new pavements doing away with the excuse for following an established track, persons should be careful to keep on the right hand side, and when turning to the curb at the left to do so by making a complete turn, so that all teams and vehicles may stand facing the direction they are to travel when starting again. This is a rule strictly enforced in some cities, as it is claimed most team and auto mishaps in the busy streets are due to sudden turns of teams just starting from a stopping place and coming into collision with some other vehicle progressing along the street.

In case of accident the driver who happens to have been proceeding in violation of the rules of the road is likely to be held responsible for any damage done.

The former charges have been withdrawn and a new resolution has been passed, fixing the date of the trial June 7th.

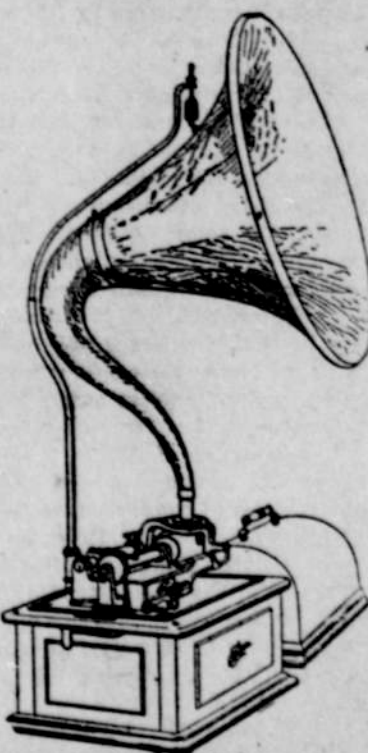
