VETERANS MEET AFTER SEPARATION OF 45 YEARS

The following extract from the Laurel Chronicle, published at Laurel, Jones, county, Mississippi, will be of great interest to the readers of the Republican, as one of the parties to the story is one of the best known citizens of Klamath Falls:

"Colonel M. G. Wilkins and family, consisting of his wife, daughter and son-in-law, of Klamath Falls, Ore., arrived in Laurel Sunday night, and registered at the Southern Hotel, and connected with their presence in the city is an interesting little story.

Col. T. W. Hall Sr., one of Laurel's worthy citizens, in looking over the names on the hotel register Monday morning, noticed that of Colonel Wilkins, and at once requested to be shown to his room. The meeting between the two old men was described as a most affecting scene; they hugged each other, and tears of joy flowed freely down their furrowed cheeks.

In 1861, when the tocsin of war called the brave sons of the south to the tented field, two farmer boys in Choctaw county, Ala., heard the call, "to arms!" and leaving their respective homes, enlisted for the war in Company G, 23d Alabama regiment, Confederate States Army. Loving comrades in youth, the two boys remained such in time of war, and together shared all the hardships of the terrible days from 1861 to 1865, bravely doing their duty in camp and on many a field of carnage. Fortunately both came out of the conflict without a scar, and with the remnant of the gallant host that had battled against great odds for their loved southland surrendered in April, 1865, and went to their homes to begin anew the battle of life. Those boys are now the gray haired men mentioned in the beginning of this story.

T. W. Hall Sr. remained in his native county in Alabama, engaged in farming, married and raised a family, afterward moving to Clarke county, Miss., then to this city.

M. G. Wilkins went to Oregon, then a new country in the great Northwest, grew up with that section, prospered, and is now connected with the Klamath Lake Navigation company.

Colonel Wilkins attended the U. C. V. reunion at Little Rock, Ark., and then started for Laurel via New Orleans, to see his playmate of boyhood days and war comrade whom he had not seen since they parted forty-five years ago. Mrs. Wilkins also met her sister, Mrs. Martha Phillips, whom she had not seen in thirty-eight years, and their meeting was tenderly affecting.

THE WEARING AWAY OF OLD MOTHER EARTH

Investigations by the United States geological survey of the erosion of numerous drainage basins of the United States show that the surface of the country is being removed at the average rate of about an inch in 760 years. Though this amount seems trivial when spread over the surface of the country it becomes stupendous when considered as a total, or even in separate drainage basins. Mississippi River, for instance, carries annually to the sea 136,400,000 tons of dissolved matter and 340,500,000 tons of suspended matter, and of this total Ohio River carries 83,350,000 tons and Missouri River contributes more than twice as much. Colorado River, which has built up for itself a vast delta, brings down more suspended matter than any other river in the United States, delivering annually 387 tons for each square mile of its drainage basin, or a total of 100,740,000 tons.

The rivers of the United States carry to tide water every year 270,000,000 tons of dissolved matter and 513,000,000 tons of suspended matter. This total of 783,000,000 tons represents more than 350,000,000 cubic yards of rock, or 610,000,000 cubic yards of surface soil. If this erosive action had been concentrated on the isthmus of Panama at the time of American occupation it would have excavated the canal for an 87-foot level canal in about 73 days.

BENSON'S ESTATE IS LEFT TO HIS WIDOW

ROSEBURG, June 7.—The last will of the late Frank W. Benson, secretary of state and former governor, was admitted to probate in the county court here Saturday, with the widow, Hattie R. Benson, as executrix. The estate is valued at \$4,500, the bulk of which is bequeathed to the widow, who in addition has already received \$5,000 in life insurance carried by her husband in the Woodmen of the World.
