### JOURNALS OF THE LAND UN- ASKED, FLEW TO THE AID OF THE FATHER OF THE PURE FOOD REGULATIONS

Old Dame Publicity has won another victory, says the American Press, chiefly due to the stand taken by the press of the country, Dr. Harvey W. Wiley, head of the bureau of chemistry of the department of agriculture, has defeated his enemies in trying to

oust him from the government position. The big wind of protest that blew from all over the country when the public received the first inkling of the news more than doubled in force when the newspapers began printing eulogies of the father of the pure food law.

Thousands of telegrams from prominent men all over the country began to pour into the White House protesting very vigorously against those who tried to force the pure food expert out. Many of the big metropolitan papers used the occasion to feature the story or the magazine sections of their Sunday editions, telling of the

benefit Dr. Wiley's fight for pure food had done for the country.

### SAY TAFT WILL VETO THE STATEHOOD BILL

In sending in his veto, Taft, it is reported, will send a statement that he is unalterably opposed to the recall.

It is reported that the house will agree quickly to some slight amendments to the statehood bill, and will put it up to Taft.

### WESTERN EDITORS WANT WOOL SCHEDULE ADOPTED

### BLY HOTEL DESTROYED; LOSS IS FOUR THOUSAND

Fire was discovered at 11 o'clock Tuesday night in the hotel kitchen at Bly by Peter Vogel, the lessee, and although he rapidly spread the alarm, the building quickly went up in smoke, with everything in it. The guests had barely time to leave the wooden structure, and all lost their clothes and effects. The loss is esti-

mated between \$3,500 and \$4,000. The building was the property of Tom and James Edsall. It is not known whether they carried any insurance or not on the hotel.

## CONTEMPT RUMOR DROPPED TODAY

STANLEY COMMITTEE AGREES  
NOT TO TRY TO FORCE PER-  
KINS TO TESTIFY AS TO CAM-  
PAIGN CONTRIBUTIONS

WASHINGTON, D. C., Aug. 9.—The shadow of the jail bars was lifted from George S. Perkins this afternoon when Stanley decided not to attempt to force him to answer the steel committee's questions regarding his personal contributions to campaign funds. It was decided best that the matter be dropped. Perkins will resume the stand late this afternoon.

After two hours of heated argument the Stanley steel investigators failed to reach a decision regarding the contempt charges against Perkins. Stanley and the democrats were insistent that Perkins answer, while the republicans opposed the rest of the committee. When a recess was called for lunch no conclusion had been reached.

## MRS. NAPOLITANO RETURNS TO JAIL

APPEARS IGNORANT OF THE  
FACT THAT TODAY WAS THE  
DAY SET ORIGINALLY FOR HER  
EXECUTION

SAULT STE. MARIE, Aug. 9.—Today, the day originally intended for her hanging, Mrs. Napolitano was removed from the hospital to the jail. Apparently the woman did not recall that this was to have been her execution day. The jailers are not mentioning the fact.

Mrs. Napolitano frequently kissed her cooling girl baby, which remains with its mother till the latter is removed to the Kingston penitentiary, for which no date has been set. The child will be placed with the Children's Aid Society.

### SHIPS STRIKE IN FOG; MANY PERISH AS RESULT

GIBRALTAR, Aug. 9.—The French mail steamer Emir collided with the British steamer Silverton in a fog this morning in Gibraltar straits. The former sank in five minutes. The Silverton rescued some of the passengers and crew and brought them to Gibraltar.

Ninety-three passengers and members of the crew perished on the Emir. The Silverton lowered all of her boats, but was only able to rescue twenty-three. The bow of the Silverton was stove in, and only the hardest kind of pumping enabled her to reach the harbor.

### MAUS COMPLETES INSPECTION LEAVES FOR HEADQUARTERS

Accompanied by Major Harry C. Cabell, his chief of staff, Brigadier General M. P. Maus, commanding the Department of the Columbia, arrived in this city Tuesday evening in B. St. Geo. Bishop's launch, returning from a visit of inspection to the territory near the Klamath Agency which may be used for a maneuvering grounds. This morning they left for Vancouver Barracks, headquarters for General Maus' department.

As was expected, the officer, aside from saying that there were many fine features in favor of the territory adjacent to Klamath Falls being used for a maneuvering grounds, he would express himself no further. Lieutenant Whitby and a detachment of men from Company M, United States Engineer corps, is now engaged in making a preliminary survey, and General Maus' recommendation in the matter will undoubtedly be governed largely by the report of his subordinate when he has completed his work.

There are several sites in the Northwest that are being considered as possible maneuvering territory to be used in place of the grounds at American Lake, and after reports and recommendations are received on all of these the war department will make its final selection. Until this is done nothing definite can be said regarding the site to be chosen for use in playing the war game.

Monday evening General Maus and his aide were entertained at "The Cedars," the home of B. St. Geo. Bishop on Crystal Creek. Remaining over night at the Bishop home, they were brought to Klamath Falls Tuesday by Mr. Bishop.
