NO TRACE OF THE MERRILL MAN

FACT THAT NO DEAD BODY HAS TURNED UP MAKES FOUL PLAY THEORY SEEM UNTENABLE—POLICE ARE PUZZLED

No trace has yet been found of James A. Thompson of Merrill, who came to Klamath Falls August 15, and for whom his brother, Edgar L. Thompson of Grants Pass, has been searching in this city and at Merrill. The man seems to have dropped completely out of sight since the date he left Merrill and came to this city. While he is supposed to have stayed at the American House that night, there seems to be no real certainty that he did, as the people there can remember nothing of him. The searching brother is still at the American House.

If the Merrill man did get into the hands of wicked and unscrupulous companions who did away with him for the comparatively moderate sum of money he had with him when he came here, it seems strange that no news has been heard of his body. Comment is made on the fact that although it has been almost two weeks since his disappearance no clue has turned up to even his remains. Some people think he may have turned right around after he arrived here and returned to his old location near Seattle and Tacoma.

"It seems hardly reasonable to suppose that crooks would give foul play to a victim in a case such as this, and then go to the trouble of disposing of the remains so that no trace would arise within a fortnight, for \$50 or \$60, if that is the amount the man had," said a local man, who has been watching the case.

"Thompson came here from his home at Merrill, announcing to the people there that he had to return at once to that town because he expected his brother to be there from Grants Pass. There is not even any absolute certainty that he stayed in Klamath Falls over night. He was a man 50 years of age and a bachelor, who had apparently been about the country considerable, living first at one place and then another. He had been at Merrill not a very long while, and it is not out of reason to presume that he might have desired to change his location and go somewhere else.

"He told people there that he was coming back to meet his brother, but the fact that he collected money owing to him just before he came to this city makes it look as though he might have anticipated being away for some time or taking a long journey. It's true, too, that he said he was going to file on a claim when he got to Klamath Falls, and that he may have wanted the money for fees, but he might also have wanted it to have a good time with.

"There are all sorts of theories that one might advance regarding his seemingly strange disappearance, but at the same time we might as well remember that when we don't know anything we can just as well guess that he is alive at a distance as to fear that he is dead at our door. The fact that no trace of his dead body has been found since the day he was last seen seems to make the foul play theory seem untenable. 'No news is good news' in a case like this."

MAY HOLD FARMERS' INSTITUTE DURING FAIR WEEK

In addition to a baseball tournament, poultry show, wild West show and other features, the latest event to be talked of in connection with the coming Klamath County Fair is a farmers' institute. Nothing has been done definitely in this respect, but those to whom the proposition has been broached are unanimously in favor of such a scheme.

Secretary C. T. Oliver of the Klamath Chamber of Commerce is warmly endorsing such an addition to the events of fair week, and advocates the holding of a meeting on each evening the fair is in session. He also suggests that the Granges of the county take charge of this feature and carry it out to a success, as members of the P. of H. order usually do.

Though nothing definite has been decided in the matter, it is more than likely that the talked-of plan will be carried out. A number of new crops have been experimented with by different farmers in the county, and the tillers of the soil in other sections are anxious to learn of the success of this or that crop. An "experience meeting" one evening, when the farmers could meet and tell of their success with Aislyke clover, Turkey Red wheat, or any of the other new crops, would therefore be largely attended. A great deal of interest would be added to this meeting by the explanation of methods used, while a comparison with those used by others would be of mutual benefit.

It is the general opinion that for one night at least members of the faculty of the Oregon Agricultural college would be present at the institute in response to an invitation. Knowing the conditions existing all over the state, and being acquainted with all of the work performed by the experiment stations with new products, they would be able to help the local farmers not a little. The illustrated lectures on the different phases of agriculture, horticulture, stock raising, etc., would also prove of great interest to all.
