

PELICAN BAY MILL BEGINS WORK

OVER ONE HUNDRED AND THIRTY MEN EMPLOYED IN MILL AND WOODS BY NEW LUMBER COMPANY

The new Pelican Bay Lumber company's saw mill at Terminal City tried its machinery Monday morning, and expects to be running with full force tomorrow. For the present the mill will employ a crew of about fifty men, but by the first of June it is expected to run a day and night shift. The mill has a capacity of 150,000 feet in twenty-four hours.

The new saw mill at Terminal City will create quite a little settlement at that place. Seven cottages for employes have already been completed, and more are to be constructed by the company. There is also room in the boarding house to accommodate from fifty to seventy-five men, but more accommodations will have to be furnished when the mill begins working double shift.

The company now has 800,000 feet of lumber in the booms near the mill ready to be sawed into lumber, and a logging crew of eighty men are now in camps in the woods near the Harman Lodge on Pelican Bay. These men are engaged in falling timber, building roads and getting ready to begin hauling to the water, which is expected to start in about a week. The company has its own railroad for hauling the logs from the woods to the lake, where they are towed to the mill by steamer. One engine and sixteen logging cars now constitute the railroad equipment, but a new McGiffert loader has been ordered from the east, and is expected to arrive here soon. This will be used in loading the logs on the cars from the ground. It is self propelling, and is run on the railroad track.

The company recently purchased the steamer Klamath, which will be used exclusively by the company for conveying freight to the camps and for towing the logs down the lake.

A box factory is to be erected in connection with the sawmill later in the season, but for the present all of the commons have been contracted for by the local trade, while the upper grades will be shipped to the markets of the East. The entrance of this company in the lumber business of Klamath county will mean much for Klamath Falls. It adds a large sum to the weekly pay roll, which will benefit not only every business man in the city, but will enlarge the market for the products of the farmer.

A very interesting talk and discussion was had on Tuesday morning by some influential men at the high school, for the purpose of acquainting the students with the fact of the worth of the lecture course. The gentlemen were Captain O. C. Applegate, Nelson Rounsevell and Attorney E. L. Elliott, and the question as to whether they ought to continue the present lecture course that has been taking place at the opera house about once every month, was broached for discussion.

It was held that much benefit was derived from this source of instruction, in so much that the student became more familiar with people who had visited many parts of the world, and could be well enlightened on many subjects that they would not otherwise have done. In a town of this size it is hard enough matter to get the right kind of speakers to come here without a good sized bonus, and this opportunity of hearing talented people who are not only up in the walks of life, but can dispense with accuracy the real things that it has been their privilege to hear and see. The only way that these courses can be maintained will be for the student to get all his friends and acquaintances to attend them.

The much talked of lecture which the high school expected to have the pleasure of hearing Mr. Collins of the Episcopal church deliver was given Monday at the high school. The subject that Mr. Collins took was along the lines of progression and activity of the ancient country of Egypt. His subject was profusely illustrated with slides on his lantern, and to say that they were very instructive can be judged by the amount of interest that the students displayed. Mr. Collins also touched on the subject of the rise of Colonus and its place in this world of ours. On the whole, the lecture proved to be very interesting, as well as instructive.

OREGON HERD OF ELK ON WAY TO PASTURE

JOSEPH, Ore., March 18.—Crated and loaded on wagons pulled by four-horse teams, the famous Oregon herd of elk started from this place Saturday morning on the last lap of their 750-mile journey from Jackson's Hole country, Wyoming, to the Billy Meadows in this county. For thirty miles the animals will be hauled through mud on wagons. Then when the snow is too deep, the wagons will have to be abandoned and the transfer made to sleighs. A great "go-devil" has been rigged up between

two monster pine trees, and the crates with the elk inside will be lifted from wheels to runners.

As difficult as the first part of the road is, the last twenty miles will be still worse, for the snow is already four feet deep on the level, and it is said to be still snowing. Drifts will probably be found mountain high in places, despite the fact that a crew of men has been at work for a week in an effort to break out roads. It is expected that at least four days will be required to make the trip.

While the crates were being built on wagons Game Warden Finley was taken to the head of the lake to investigate recommendations made by Joseph Rod and Gun club, relative to the steps deemed necessary to prevent the extermination of "Yanks." This is an exceptionally good game find, with many peculiarities, and is found only in one or two other places in the world.

CONFESSED ROBBER YET CANNOT BE PUNISHED

The district attorney there finds that the statute of limitations protects Copeland, who committed his crimes when a very young man and under the thrall of the deeds of Jesse James. Copeland confessed to the robbery of a Northern Pacific train and a National bank at Moorhead, Minn.

INSTRUMENT IS LARGEST YET FILED

TRUST DEED BY CALIFORNIA-OREGON POWER COMPANY CONTAINS 39,000 WORDS, AND COSTS \$78 TO RECORD

Monday there was filed with the county clerk the largest instrument that has ever been recorded in Klamath county. It was a trust deed given by the California-Oregon Power company to the Mercantile Trust company of San Francisco, and contained 39,000 words. The filing fee was \$78. On Saturday a deed was filed for record by the Oregon Power company, which transferred all of the property in Klamath county owned by the company to the California-Oregon Power company, the new corporation.

FIRST ARIZONA LEGISLATURE CONVENES TODAY

PHOENIX, Ariz., March 19.—Arizona's first legislature, overwhelmingly democratic, convened at noon today. Governor Hunt's message to the body said that the first act should be a move for a reincorporation of the constitution, with the restoration of the identical judicial recall plank which President Taft rejected. He also demands immediate action on woman suffrage, and also advocates a law compelling every newspaper in the state to publish a complete list of its owners and stockholders.

CONVICTS MAKE GOOD THEIR ESCAPE FROM PENITENTIARY

LINCOLN, Neb., March 18.—When Convicts Taylor, Morley and Dowd slipped into the blinding snowstorm last Thursday and faded from sight, they seemed to have slipped into a mysterious hiding place which may never be discovered. Not a trace has been found of the desperadoes who shot and dynamited their way out of prison after the triple murder of Warden Delehanty, his deputy and one of the ushers.

Governor Aldrich has arrived, and is conducting an investigation, which, it is hoped, may disclose the means by which the friends of the fugitives were able to slip the revolvers and explosives in to them. Trustees are believed to have aided, while some suspicion points toward a prison guard.

All ex-convicts here who were recently released have been arrested and questioned. The officers refuse to make public the information they may have obtained. Two convicts, Burns and Riley, have been closely connected with the affair, and are believed to have been instrumental in smuggling the weapons into the prison, but both have disappeared.

Burns accompanied a party of Lincoln "prison reformers" to the penitentiary about two weeks ago, and at that time smuggled some opium into the prison.

CONVICT MURDERERS CAPTURED AT LAST

Later—(1:20 p. m.)—Cornered in a barn between Gretna and Springfield, the Sappy county convicts, Gray, Dowd and Morley, who slew the warden and two guards at the penitentiary, were captured after an hour's

battle, in which the posse fired from two sides. Gray and Dowd were killed and Morley was wounded and Jay Blount captured. A farmer was accidentally killed during the fight.

FOURTEEN KNOWN DEAD IN EXPLOSION

SAN ANTONIO, Texas, March 18.—A locomotive exploded in the Southern Pacific yards this morning, and six men were killed and twenty injured. The roundhouse was completely wrecked.

List of Dead Increases

SAN ANTONIO, Texas, March 18.—Fourteen are known to be dead in the explosion in the Southern Pacific shops. Parts of bodies were blown several hundred feet. Southern Pacific officials admit that fourteen are killed. Other estimates place the dead at from twenty-five to thirty. The shopmen were mostly strike-breakers. The cause is unascertained, but it is charged that dynamite was responsible. Most of the dead are horribly mangled, and probably never will be identified. Fragments of the bodies were found blocks away. Not one whole body was found.

Later—(2 p. m.)—Twenty-seven bodies have been recovered from the round house. Men are still searching the ruins in the belief that more will be found.

SACRAMENTO, March 18.—A. T. Howe of Mendocino county has been named as Deputy Clerk to succeed Pendergast, who will be dismissed April 1st.

CANDIDATE LIST STILL GROWING

THREE MORE ENTER THE RACE TODAY FOR COUNTY AND PRECINCT OFFICES—SEISEMORE FILES FOR CLERY

Three petitions were filed Monday with the county clerk by candidates. Lindsey Sisemore of Fort Klamath filed his petition as a candidate for the democratic nomination for county clerk. This makes one candidate only on each ticket for this office, and it is not probable that here will be any more entries, so that C. R. De Lap and Lindsay Sisemore will be the two men to make the fight for clerk at election in November.

E. B. Ramsby has filed for justice of the peace on the republican ticket. He will be opposed for the nomination by W. H. Shaw and E. W. Gowen, who filed some time since. It is the general opinion that this office is becoming an important one from a financial standpoint, and for this reason the position is hotly contested.

John Schallock, who filed today, is as yet the only aspirant for constable of Linkville district.

GENERAL VILLA PROBABLY SHOT

EL PASO, Texas, March 18.—Colonel D. Ponce, telegraphed to General Orozco for confirmation of the reported capture of General Villa. On Saturday night he received a telegram signed "Orozco" declaring that Villa would be shot on Sunday. Nothing further has been heard.

OUTLAWS SURROUNDED BY DETECTIVES IN DEVIL'S DEN

HILLSVILLE, Va., March 18.—Forty detectives are surrounding Devil's Den, where it is believed that Sid Allen and his gang of outlaws are entrenched. A cordon of detectives are closing in on the stronghold, and a desperate fight is expected.

ELLIS MAKES GREAT MANY FRIENDS

HIS PLAIN TALK TO THE PEOPLE AT THE COURT HOUSE MEETS WITH FAVORABLE APPROVAL OF CITIZENS

Hon. W. R. Ellis, candidate for the republican nomination for congress in the Second Oregon district, left Sunday morning, after a visit of several days in Klamath county.

Mr. Ellis gave a very interesting talk at the court house on Saturday evening, in which he plainly stated just what were his qualifications for the office he is seeking. No unfavorable comments were made on the other candidates for the office, but he showed what he expected to be able to do for the great new empire of Eastern Oregon if he was successful in being elected to congress. As this was Mr. Ellis' first visit to Klamath county, the knowledge of the needs and resources of this county shown by him was surprising, and proved that his long experience has fitted him as a most desirable representative of the people at the nation's capital.

He made a strong plea for harmonious action and co-operation, and argues that only in this way could the best results be obtained in the district, in the county and in the city. He made no promises of what he would do if elected further than that all of his time and all of his experience would be given to secure those things needed by the people of his district. He asserted that every man of power and influence must be a progressive, and stated that he was a progressive in its true meaning. Simply because some new fad might be popular was no reason why a man should discard that which had been proven to be best, even though it was a little old fashioned.

Church Improvements

The congregations and attendants at the Grace M. E. church Sunday were very much pleased with the appearance of the interior of the church since the improvements have been made. The plaster on the ceiling had become loosened, and caused a great deal of annoyance, and this has been removed and replastered. The ceiling and walls have been retinted, and the interior now presents a very agreeable appearance.

WILL PLAN TO DISPOSE OF LANDS

WASHINGTON, March 18.—What shall be done regarding the railroad grant lands for which the government is now suing is a question which has been discussed to some extent by the Oregon representatives and officials of the department of justice. It is probable that the senators and representatives will begin soon to consider the form of a bill to be introduced after it shall have been submitted to the attorney general. In a general way, although subject to revision and amendment, the bill is likely to provide:

First—That the suit brought by the attorney general is ratified by congress and declared to be equivalent to forfeiture of the railroad's grant by congress.

Second—That the persons who bought railroad lands prior to April 30, 1908, shall be permitted to confess judgment of forfeiture and sale, and have preferential right for six months to buy the same lands from the government at \$2.50 per acre.

Third—That no further suits shall be brought against innocent purchasers unless they be filed within one year.

Fourth—That the 32,000,000 acres of unsold lands shall, when the decree of forfeiture is ratified by the supreme court, be opened to actual settlers under the rules and regulations of the interior department, which means the drawing system, also that no lands shall be disposed of through scrip applications.

The state delegation will also probably discuss what shall be done in view of the adverse report by the department on Senator Bourne's innocent purchaser bill.

LA FOLLETTE SIZZLES

TAFT AND ROOSEVELT MANDAN, N. D., March 18.—Hot shot for both Taft and Roosevelt for their failure to cripple the trusts in their formative period is being poured out through this state by Senator La Follette of Wisconsin in personal speeches which are a feature of a sizzling fight for the Republican delegates, which is at its height.

La Follette made two speeches at Jamestown and one here. Generally La Follette is attacking both Taft and Roosevelt on grounds of their failure to hit the trusts and to revise the tariff downward. The campaign is the fiercest the state has ever seen. Roosevelt speakers are flooding into the state and the La Follette men are fighting back tooth and nail.
