

FOURTH WILL BE GORGEOUS SHOW

WATER CARNIVAL WILL SURPASS ANYTHING SEEN HERE

Big Delegation Coming From Every Lodge in Oregon and Northern California—Montague Band and Ball Team Are Coming—Early Reservations Being Made for Hotel Rooms by Visitors Coming

The people of Klamath Falls are just beginning to awake to a realization of the gorgeousness of the big Fourth of July stunt which is to be pulled off here by the Modoc Tribe of Redmen. The water carnival alone will surpass any exhibition ever attempted in this section. This evening pageant will be put on by the Pano Fireworks company of New York, one of the most celebrated spectacular display concerns in the United States. One piece alone will consist of 1,000 square feet of fireworks. There is another piece representing Niagara Falls, a flowing current of fire 150 feet long by 25 feet high. The discovery of the south pole by Amundsen will also be depicted, showing dogs drawing sleighs and drivers.

Positive assurance has been received that a degree team will be here from Weed to take part in conferring degrees, and also ten Redmen will come from McCloud. Letters have been received from every lodge in Oregon as far north as Umatilla, stating that there will be from one to five representatives from these lodges in attendance.

The following letter has been received from W. L. Schultz, who is here from Weed, assisting in planning the celebration. The letter is from the Yreka Tribe:

"Dear Sir and Brother—Ieka Tribe accepts the invitation of Modoc No. 59 to put on the Adoption Degree on the 4th of July.

"We have also interviewed the Montague band and baseball team in regard to accepting your proposition for the 4th, and express themselves as willing to play providing they hear from you as to the division of the gate receipts, and the number of games to be played. Will do all we can to help matters along.

"Will you please give us the names and prices of the different hotels at the Falls, as there are a good many of us wish to make early reservations for rooms for the 3d, 4th and 5th, and if it is not asking too much, would greatly appreciate an early answer.

FORT COUNTRY IS PROSPEROUS

WOOD RIVER VALLEY FAST DEVELOPING INTO GREAT DAIRY-DEVELOPING SECTION—NEW CREAMERY WILL SOON BE READY

J. L. Fielder returned Friday from the Wood River country, where he spent several days on business and on a fishing trip. Mr. Fielder states that things are looking fine around the Fort, and the area of land that was plowed by the large caterpillar plowing outfit, belonging to Utter & Burns, and planted to timothy and oats, has reached a height of eight inches, with good heads.

A new creamery is now under course or construction, which will be ready to receive the ranchers' supply of cream in a few weeks. The new enterprise is situated in the town of Port Klamath, and will be of sufficient capacity to handle the output of 500 milch cows. Already several of the ranchers have signed up to furnish cream for the plant, and others will do so as soon as their young stock is ready for dairying purposes. It is the intention of the creamery incorporators to interest as many of the ranchers as possible in dairying, and thus add largely to the financial success of the new enterprise.

CAMPAIGNING WITH TAFT IS VERY DUSTY WORK

WASHINGTON, D. C., June 15.—Campaigning with a president, especially with the present president, is dusty work, as the three secret service men, James Sloan Jr., Lucien C. Wheeler and Richard L. Jarvis, known familiarly as "Jimmie," "Jack" and "Dick," who continually guard Taft, can testify.

That is because President Taft loves to campaign in an automobile. The three secret service men always follow in a car immediately behind the president's. FAMOUS ARLINGTON HOTEL DISMANTLED

WASHINGTON, D. C., June 15.—The Arlington hotel, whose corridors have echoed to the steps of countless celebrities during its half century of existence, is being dismantled to make way for a gorgeous new hostelry—and as a sort of "wake" to the obsequies politicians and public men are recounting a new crop of reminiscences about the old hotel.

Also, second-hand dealers and a few wise collectors are reaping bargains in the furniture and decorations. When the Arlington was built every stick of furniture came from the other side, and it was of the solid black walnut so much in vogue in those days. Half a dozen great paintings were imported, and artists called on for special canvases to decorate the corridors and lobbies. These priceless souvenirs have been eagerly sought, and brought astonishingly low prices. A wonderful glass chandelier, for instance, went for a little over \$200. It cost nearly five times that much.

The Arlington used to pay its waiters 85 cents a day wages, and the waiters in turn had to pay a "bus boy" 75 cents per day. At that it was said the waiters paid for the privilege of working at the hostelry, because of the abundant tips they received.

J. Pierpont Morgan always had a suite reserved on the second floor, overlooking a park. He wanted the same location in the new Arlington, and so purchased some of the stock in

Barlow, Townsend, French, Evans, Slough and Delzell.

Mark Hanna died in the little annex to the hotel—a small, ivy-covered brick house connected with the main hotel, and fronting on La Fayette Park. The Metropolitan Club formerly had its quarters in the same place. President McKinley came to the Arlington just before his inauguration. He had always stopped there. Through long years, the old hotel has held a sort of coterie of public men, in much the same way as New York's famous hostelry sheltered the "Amen Corner." There were no flashy ginger-bread modern fixtures at the Arlington—the service was recise and formal, the wines the most exquisite to be obtained, the food above reproach, and about it all was the hallowed air of age.

CROSSES DIVIDE BY CRATER LAKE HORSEBACK

Bill Watkins, a well known mountaineer of Southern Oregon, arrived in Medford this morning, says the Medford Mail Tribune, from the Klamath country, by way of Arants Camp, Union Creek and Prospects, being the first man to cross the mountains this year by way of the road to Crater Lake.

According to Mr. Watkins the road will not be opened for automobile travel until July. The snow on the summit is from six to eight feet in depth. It is now possible to get as far as Whiskey Creek easily with a team, but from there to Arants Camp the going is very hard. Mr. Watkins

CROWDS GATHER FOR FINAL SHOW

STREET CROWDS ARE INCREASING IN CHICAGO—BIG DEMONSTRATION MEETING AT AUDITORIUM MONDAY NIGHT

CHICAGO, June 15.—The street crowds are increasing. The big Roosevelt meeting at the Auditorium will be held Monday night, Roosevelt starring.

CLEVELAND, June 15.—Three extra cars bearing delegates and others were added at Buffalo to the Roosevelt train. Three hundred were at the Syracuse station at 2 o'clock this morning.

CHICAGO, June 15.—A special train carrying Californians, including delegates, arrived this afternoon.

Mrs. Porter and Mrs. Blaney, delegates, climbed to the driver's seat of an old-fashioned stage, and led the parade to the hotel. Johnson was at the reception, and said: "California will not be disfranchised by the action of the national committee. All delegates favoring Roosevelt will be seated." Bander carried a banner in the procession bearing the words: "California refuses to try title to stolen property before men who stole it."

Borah said, "The sight of the Colonel's fighting face will be the last straw needed to complete the route of the Taftites."

STEAM ROLLER WORKING FINE

CHICAGO, June 15.—The committee seated eight Taft delegates at large from Texas.

Despite the fact that Committeeman Lyon insisted that the Taft delegates at large were not contestants, having failed to file their contest twenty days before the committee met, the committee voted to seat eight Taft delegates at large from Texas. Taft briefs were filed yesterday.

The Taft delegates seated were from the Fourth, Fifth, Seventh and Eighth districts.

Despite the arguments advanced by Roosevelt's attorneys and contest managers, the committee also seated the Taft delegates in the First and Second districts.

The first victory for Roosevelt in the Texas contests was scored when the committee seated the Roosevelt delegate in the Third district, the Taft men offering but little evidence.

NO U. S. CASH TO MOUNT TEDDY'S HUNTING SPOILS

WASHINGTON, D. C., June 15.—The house has refused to appropriate \$250,000 for the preparation and the mounting of skins collected by Colonel Roosevelt on his African hunting trip.

The Rucker-Pitts case, which was argued on demurrer in circuit court chambers, will probably be decided by Judge Benson during the forthcoming week. The closing argument in the case was made by Judge Thos. Drake, who argued that a resulting trust was created.

ORGANIZE A BAR ASSOCIATION

JUDGE DRAKE IS ELECTED THE FIRST PRESIDENT

Twenty-Eight Attorneys of the City Unite in Association to "Maintain the Honor and Dignity of the Legal Profession and to Prevent Unprofessional conduct and Promote Administration of Justice."

The organization of the Klamath Bar Association was completed at a meeting held Friday night in the circuit court room, and presided over by Judge Henry L. Benson. Twenty-two of the twenty-nine attorneys in Klamath Falls were present at the meeting. Two sets of constitutions and by-laws were presented for the consideration of the members, and it was voted to adopt the shorter of the two constitutions and amend it later if it was considered necessary.

Following the adoption of the constitution the following were elected as officers of the association, to hold office until the annual meeting of the second Monday in January: Thomas Drake, president; D. V. Kuykendall, vice president; J. C. Rutledge, secretary; John Irwin, treasurer.

The various committees are to be appointed by the president within two weeks, and will be reported at the next meeting, to be held on June 29th.

The membership roll of the new association was signed by twenty-eight members of the profession practicing in Klamath Falls.

The constitution provides that "The object of the association shall be to maintain the honor and dignity of the legal profession, to promote social intercourse among its members, to prevent unprofessional conduct, and to increase its usefulness in promoting the due administration of justice."

"A committee of five members shall be appointed by the president, and shall be charged with the investigation of all complaints against officers or members of the association, members of the bar and officers of the court, and also of all complaints which may be made to them in matters affecting the interests of the legal profession, the practice of law and the administration of justice. Complaints may be made to this committee by any member of the association, of the bar or any one affected. All complaints must be signed by the person making them. Upon a receipt of a proper complaint it shall be the duty of the committee to investigate the same and take such action thereon as may be advisable. The action of the committee shall, however, be subject to approval of the body of the association, and such approval shall be evidenced by a majority vote of the association."

BIG LUMBERMEN HERE ON VISIT

Fred Weyerhaeuser, son of the multi-millionaire timber king of the United States, Mr. Thatcher and Geo. S. Long, Western manager of the Weyerhaeuser syndicate, arrived in the city Friday evening on a tour of inspection of the timber holdings of the Weyerhaeuser company, which are the largest of any concern in this section of the coast. Next morning, accompanied by J. F. Kimball, local representative of the company, the party made a trip to the Upper Lake.

"We expect to spend several days here," said Mr. Long last evening at the White Pelican hotel, "looking over the timber of our company in Klamath county. We have some local matters to attend to, and Mr. Weyerhaeuser wants to see what the timber of Klamath county looks like."

Mr. Weyerhaeuser was not disposed to discuss the timber business, but paid a high compliment to the unexpected excellence of the hotel accommodations at the White Pelican, and the taste and beauty of the finish and decorations.

The visit of the Weyerhaeuser party at this time is considered quite significant in view of the reported entrance of the Hill lines into this territory. It is generally conceded that lumber manufacturing on a large scale will not be fully developed in the Klamath section until there are competing lines of railroad to furnish shipping facilities. It is believed that the Weyerhaeuser company contemplates, when the time is ripe, to establish one of the largest lumbering mills in the world on the Upper Lake for the manufacture of their immense holdings of standing timber. Since the abandonment of the Pokegama road it is believed that the company decided to haul their logs this way, and manufacture them at some point on the shores of the Upper Klamath Lake. Whether this is to be done in the near future is only speculative, as the officials do not make a practice of giving out their plans in advance.
