

KLAMATH LAND IS THROWN OPEN

THE INTERIOR DEPARTMENT VACATES FORMER ORDERS OF WITHDRAWAL FOR KLAMATH RECLAMATION PROJECT

LAKEVIEW, June 22.—Notice is hereby given that under date of May 22, 1912, the honorable first assistant secretary of the interior vacated former departmental orders of withdrawal for Klamath reclamation project, California-Oregon, affecting certain lands in Township 49 S., Range 8 E., Township 40 S., Range 9 E., Township 41 S., Range 10 E., Township 39 S., Range 11 E., Township 40 S., Range 12 E. and Township 40 S., Range 12 E., Willamette Meridian; thereby restoring said lands not otherwise withdrawn, reserved or appropriated, to settlement under the public land laws of the United States on and after July 22, 1912, but they shall not be subject to entry, filing or selection until August 21, 1912, at the Lakeview, Oregon, land office at 9 a. m.

FALLER RULERS' END NOT FAR OFF

PEKIN, June 22.—Nobody has yet been arrested for the attempt made fully a month ago, to assassinate the baby ex-emperor of China, and so far as any appearance of police activity is concerned, it does not look as if the authorities have ever tried to find the culprit. This indifference on the part of the new government is being generally attributed today to a belief among its leaders that the deposed ruler will be a menace to the republic as long as he lives.

In a country so large, so poorly supplied with means of communication and in so confused a state as China, it is not surprising that the would-be assassin should be hard to find after once getting safely away from the Chang Chun palace, through a window of which he fired at the little ex-ruler, playing inside. But it is difficult to understand how he managed to approach so close to the palace or to escape after his attempt, without the collusion of the numerous guards which swarm that neighborhood.

The popular judgment now is that the circumstances of the recent attempt to bear out the accuracy of the forecast made when the baby emperor was allowed to retain his title at the time of the Manchu abdication. At this time it was predicted that an emperor in a republic was too much of a paradox to last, and that the little ex-monarch's death by violence is a matter of only a few months at most, though poison is looked on as a much likelier means of eliminating him than the bullet.

WOUNDS HIMSELF WITH BOWIE KNIFE

Word has been received in this city by friends of George Stevenson, a student of the University of Oregon at Eugene, that during a class play, "As You Like It," Mr. Stevenson accidentally wounded himself with a bowie knife which he was handling.

It was at first thought that the wound was very serious, as the knife had apparently entered his abdomen, but upon examination the physicians found that none of the intestines were injured, and the wound would soon heal.

Mr. Stevenson graduated with a class of eight from the Klamath County high school in 1910, and the following year entered the University of Oregon. His many friends will be pleased to learn that the accident is not so serious as was at first thought.

CONVENTION ENDED SATURDAY NIGHT

JOHNSON ISSUES A STATEMENT AFTER WALKOUT

Says That All of the California Delegates Are in Accord With His Action, But That He Requested Them to Stay to Carry Out the General Plan of the Roosevelt Delegates, as Outlined by the Colonel

CHICAGO, June 22.—The convention was called to order at 10.44, with prospects of Taft being renominated, his running mate selected, the adoption of a compromise platform with concessions to progressives before adjournment, which is expected about midnight.

The Roosevelt delegates are expected to offer but a passive resistance.

It is believed certain that Roosevelt personally will not appear, and that his name will not be presented.

The Roosevelt delegates plan that no prospective member of the coming "National Progressive party" will accept any nomination by the present convention. There is still the possibility of an open bolt, in which, if it comes, Roosevelt is expected to have the same strength, as shown on the California bolt.

Committee's Report Completed

CHICAGO, June 22.—The report of the credentials committee was completed at 2:45. The Taftites were seated in every case. The temporary convention officials were made permanent.

Then Governor Johnson walked out, declaring that he "did not care to see a continuation of the outrage being perpetrated."

After his walkout from the convention, Johnson issued the following statement through Lissner:

"I shall not sit in this convention during the nomination of a president, nor consider myself bound by its acts. Not only was a fraudulent roll call foisted to defeat the people's will, but the law of the state of California, acquiesced in by the president and every faction in California, has been nullified. As California's governor, I feel my duty is plain to no longer remain in the convention. All the California delegation is in accord, but I requested them to remain to carry out the general plan of the Roosevelt delegates."

A Roosevelt demonstration came when Henry Allen of Kansas announced that he wished to read a brief statement from Roosevelt.

The Roosevelt delegates leaped to their feet and with shouts drowned Allen. After the turmoil was quelled Allen read the statement previously given out by Roosevelt.

Cheering for Roosevelt was strongest since the convention opened. Kansas lead a standard parade with all the Roosevelt states behind, chanting, "We want Teddy." The demonstration lasted twenty-one minutes. Then Fairbanks, chairman of the resolutions committee, was recognized, and began his report.

BRADBURY WINS SUIT AGAINST CONTRACTOR

After about a half of an hour's deliberation last Saturday the jury in the case of C. J. Bradbury vs. George C. Clark brought in a verdict for the plaintiff in the sum of \$116.25 on the first cause of action, and \$201.25 on the second cause of action.

The second cause of action was an assignment of a claim which amounted to \$194, something over \$6 having been deducted from the total bill. The judge instructed that on the second cause for action the jury could not find for a greater amount than \$194, but the verdict brought in was for the full amount. W. H. A. Renner represented the plaintiff and Noland & Crane appeared for the defendant.

PRINCE OF WALES IS 18 YEARS OLD

EDWARDS, SON OF KING GEORGE, UNDER BRITISH LAWS, WILL BE QUALIFIED TO ASCEND THE THRONE

LONDON, June 22.—Tomorrow morning Edward, Prince of Wales, King George's eldest son, will be a man. Actually he celebrates only his 18th birthday, but under British laws relating to the royal family he will attain his majority, and be fully qualified to ascend the throne.

The birthday celebration, which will be held at Windsor castle, will be of the quietest possible character, but what young Wales will probably care most for is that henceforth he will be treated as a man, and will have his own rooms, secretaries and equerries at Windsor, Buckingham Palace and elsewhere. In addition, when one of the royal palaces becomes vacant it will be allotted to the prince. This will probably be Marlborough house, London, or York house, Norfolk, or both, when the Queen Mother Alexandra dies.

On Tuesday next the young prince will accompany his father and mother on their state visit to Cardiff, thus affording such Welshmen as desire the opportunity of wishing their prince "happy returns." Prince Edward will then go to Paris to resume his studies. Next year he will go to Oxford and Cambridge universities to graduate. Before graduating, however, he will be appointed to a cavalry regiment, and there is great excitement and rivalry among the officers of the various leading regiments over the possibility of placing the name of "Second Lieutenant His Royal Highness the Prince of Wales" on their muster rolls.

NAME CHAIRMAN OF NEW PARTY

ROOSEVELTERS TO MEET AFTER ADJOURNMENT

Temporary Chairman and Other Officers of National Progressive Party Will Be Chosen at Meeting in Chicago—Followers of Roosevelt Declare That the Nomination Has Been Stolen.

CHICAGO, June 22.—The Roosevelt forces made no serious objections to the adoption of the report of the credentials committee seating the Taft delegates, except in the case of the Washington delegates, when a great deal of bitter criticism was voiced.

All the Taftites were seated by a viva voce vote, marked time, howled catcalls and frolics.

The action of the Rooseveltites in the Washington case was a bit of a surprise, as they had agreed last night that the vote in the California matter reach the "high water mark," and they saw no reason to further force the issue.

The followers of Roosevelt have issued a long statement, declaring the nomination stolen, the text of the statement being, "Shall the people rule. It concluded: "We do not bolt, we merely insist that you, and not we, are making the record, and we refuse to be bound by it. We pleaded for ten days we fought for five days for a square deal, and we will fight no more, plead no longer. We shall sit in silent protest, and the people who sent us here shall judge us."

If refused permission to read the statement to the convention, the Rooseveltites will circulate it throughout the country. It is expected that Roosevelt will remain in Chicago after the convention to confer with his associates in the new national progressive party.

It is planned that all Rooseveltites in Chicago will meet after the adjournment of the convention to choose a temporary chairman and other officers of the national progressive party.

"We are going to make them nominate Taft," said Dixon, but he refused to explain how.

It is reported that Crane asked Hadley if he would accept the presidential or vice presidential nomination. Both men refused to discuss the report.
