### CENARAY LAW LIBRARY DISCUSSED BY ATTORNEYS

That all the local lawyers are in favor of a central law library was proven beyond all doubt at Monday night's meeting of the Klamath county Bar Association, which proved one of the most enthusiastic ever held. Out of deference to Judge Benson, who was unable to attend, the lawyers did not take up the matter of court rules.

A discussion of the proposition for a central library brought a big vote of approval, and a committee will be appointed to work with Rollo C. Groesbeck in connection with the matter. This committee will choose a suitable location and ascertain the cost of collecting and maintaining a library.

When the library is opened, local attorneys will have access to the most complete collection of books in the state, as it is the intention to secure every possible text book. The library will also contain all the American Reports, including Northwestern, Pacific, Southeastern, Northeastern, Atlantic, Southern and Southwestern Reports, and the English and Canadian common law reports. In addition, the volumes listed will include a full set of the West Digest System, L. R. A., the codes of the neighboring states, Federal Reporter, bankruptcy statutes, "Cyc.", text books and a number of special books.

The library will be a co-operative enterprise, and all the members of the Association will be stockholders, paying their share of the expense. Wherever possible, books that are little used by local attorneys will be purchased for the library.

The library will be in charge of a competent librarian. In case a suitable public library is secured for Klamath Falls, the Bar Association may arrange for space for its books and pay a portion of the librarian's salary for the care of the library.

The Bar Association also discussed the matter of suitable rooms for attorneys and for witnesses to use during recesses at trials in the new court house. This matter will be taken up with the county court.

Resolutions endorsing the bill passed by the house for the creation of clerk of the circuit court of Klamath county were drawn up and forwarded to Senator W. Lair Thompson and Governor West.

### LOT CHOSEN FOR HOME BY LODGE

### MASON'S SELECT SITE AT CORNER OF SIXTH AND KLAMATH AVENUE—BUILDING PLANS NEXT IN ORDER

The lot at the corner of Sixth street and Klamath avenue, belonging to Mrs. Fred Melisse, was decided upon as the location of the Masonic Temple at Monday night's meeting of the local A. F. & A. M. order. The lot is offered for the order for \$10,000.

Following the acceptance of the committee's report regarding the selection of a site, the matter of raising the money with which to purchase the property was discussed, and a ways and means committee was appointed to circulate a stock subscription to secure the \$10,000. The subscribers will pay a fourth of their subscription as soon as the lodge accepts the subscription and appoints a building committee.

Much enthusiasm was manifested by local Masons in the plan. It is the intention of the lodge to erect a building at least three stories high, of fireproof construction.

### EVEN OUR BUD GETTING THE GAFF

### FISTIC SCRIBE OF THE LOS ANGELES TIMES CLAIMS NORTHERN LAD CAN'T TAKE THE HOT STUFF AND IS SLOW ON FEET

A sure sign that Bud Anderson of Vancouver, Wash., of Medford, Ore., of Klamath Falls, Ore., and now of Los Angeles, Calif., is coming to the fore in fistic circles in that section is shown by the fact that he is sufficiently far enough up the ladder in the opinion of at least one sport scribe to deserve a panning.

This scribe is DeWitt Van Court of the Los Angeles Times, and among the things he says about Anderson are the ones in the following paragraphs:

"Bud Anderson, the Vancouver light weight, has surely started the fight fans' tongues a-wagging in this town. The slam-bang fighter always makes them sit up and take notice. I do not mean by this that Bud is a slam-bang fighter, but it was Sammy Trott, the slugger, that made them take notice of Bud.

"I had the pleasure of seeing Anderson box three exhibition rounds last Wednesday with his sparring partner, George Memsic. It is impossible to judge a fighter's ability in exhibition bouts, but enough can be seen to get a fair knowledge of his cleverness. George was one of the toughest lightweights in the country in his day, and a good man to draw line from on any man he boxes with.

"Bud is the most powerful lightweight I have ever seen. He is well built from his feet up, very strong, a hard hitter, cool, and a fine looking fellow in every way. He may be the champion some day, but until he learns many things that there is to learn he will never win on his cleverness. He is neither a straight hitter nor a swinger. His blows are delivered more as hooks. He is not good on his feet, neither is he fast.

"I believe boys like Rivers and Ritchie would beat him. But he would have a better chance with Wolgast. Wolgast is easier to hit, and anybody Bud can hit he should easily lick. His judge of distance is not of the best, and a good fighter would keep him on his toes and off his balance most of the time. He is also open in the in-fighting and clinches.

"If I am not much mistaken, within another year Anderson will be in the welterweight class. He and Memsic are built much alike and the weight question was always a trouble to George in the last couple of years he was fighting. Anderson claims to have had over forty fights. If this is true he should show much more cleverness."

### STONE TELLS OF CLANTON'S WORK

C. F. Stone, member of the state fish and game commission, expressed great surprise when he was informed that charges had been made in the state legislature against Master Fish Warden Clanton. Incompetency is charged, and an investigation by the legislature is demanded.

"Mr. Clanton was appointed by the commission after his recommendations had been carefully considered," said Mr. Stone. "He has devoted the greater part of his life to the fishing industry, and we regarded his ability very highly."

### WILL BE ADVISED BY HIS UNCLE

### SUCCESSFUL REBEL MAKES PLAN FOR THE FUTURE

Fighting Is Reported to Be in Progress in Mexico City—Madero Has Left Capital With a Few Hundred Men—Chance Will Be Given Him to Resign the Office of President, Says Diaz.

MEXICO CITY, Feb. 11.—Porfirio Diaz will return here to become Felix Diaz's confidential adviser. He has cabled his nephew that he is ready to start for here as soon as he is notified that the revolt has been a success.

"I will wait a reasonable time for Madero to resign," said Felix Diaz today. If he will not quit I will bombard the national palace, the Chapultepec castle, or wherever he may seek shelter."

WASHINGTON, D. C., Feb. 11.—Ambassador Wilson officially reported today that Madero had left Mexico City and had gone to Cuernavaca, 25 miles distant, with several hundred soldiers.

Peace negotiations with Diaz are progressing. The Zapatistas are marching to the capital to join Diaz.

NEW YORK, Feb. 11.—Felix Diaz today sent the following message to the United Press:

"There is no reason at all for intervention. I am strongly of the opinion that there is no necessity for foreign aid."

WASHINGTON, D. C., Feb. 11.—It was officially announced today that the policy of non-intervention in Mexico would be adopted. However, the army and navy will be ready to move on short notice if necessary.

Capitalists and financiers are bringing pressure to bear on President Taft and Secretary Knox to intervene.

### FRAKES RECOVERS FIRE INSURANCE

Frank N. Frakes, a local contractor, is in receipt of a check covering 50 per cent of the loss he sustained when several houses owned by him at Globe, Ariz., burned up a short time ago.

The houses were not occupied at the time of the fire, and upon this ground the company at first refused to pay Frakes the insurance. The compromise was made through Attorney W. H. Shaw of this city.

### TAXES NOW DUE: AN INDUCEMENT

Taxes for the current year are now due, and are payable at the sheriff's office, beginning Saturday.

As an inducement to property owners to pay their taxes early, the law provides for a 3 per cent discount on all remittances received before March 15th, provided the sum tendered is the full amount of the assessment on the particular piece of property charged to the individual. If the taxes are not paid on or before the first Monday they become delinquent, and interest and penalties are added. The law provides, however, that the first half payment may be made before the first Monday in April, in which case the last half does not become delinquent until after the first Monday in October.

### NEIGHBORHOOD ROW IN COURT

A controversy which was reported to have been the subject of a grand jury investigation Thursday was taken into the court of Judge Gowen this afternoon. It finally developed into an action to replevin, and is entitled Otto Hoppe against Mrs. Jones.

It appears that some time ago Mrs. Jones sold Hoppe a bull. Later, it is claimed, the animal either returned or was driven to the Jones place. Mrs. Jones, on demand, declined to return the bull to Hoppe.

Mrs. Jones resides in Langell Valley. Hoppe lives near the Clear Lake dam.

### OREGON'S NAME OF IRISH ORIGIN

To those people who are not familiar with the word "Oregon" it might be well to quote the following from a letter written recently by L. Whitman Clark O'Regon, a present resident of Albany, this state:

"The word Oregon is of Irish origin, and in its present form is another example of the tendency of the English language to deteriorate in the process of time. Oregon was named after one of my ancestors, an Irish lord, who came out with Me-Loughlin. Practically all the Pacific Northwest was called after him, and was known as the 'O'Regon country.' In time the apostrophe was lost and the 'R' dropped to a lower case.—Irish News.

### HEROES OF SOUTH POLE HONORED

### ARRANGEMENTS UNDER WAY FOR CEREMONIES

Families of the Scott Party Who Lost Their Lives Will Be Cared for by the Nation—Details of the Hardships Endured Are Given to the World—Mrs. Scott Ignorant of the Tragedy

### Bodies Are Aboard

WELLINGTON, Feb. 11.—The Terra Nova is proceeding to Port Lyttleton. All are well aboard. The bodies of Scott and his companions are aboard.

LONDON, Feb. 11.—Captain Scott's last message was found in his clothing. In it he said that terrific cold had caused the disaster.

"We arrived within eleven miles of our old camp, with fuel for one hot meal and food for two days. For four days we have been unable to leave the tent, and a gale has been blowing about us. We are very weak, and writing is difficult.

"We do not regret this journey, which has shown us that Englishmen can endure great hardships. We will help one another to meet death with as great fortitude as ever in the past. Things have come out against us, but we have no cause for complaint. We bow to the will of Providence, and are still determined to do our best to the very last.

"These rough notes on our dead bodies must tell the tale, but surely a great, rich country like ours will see that those who depend upon us are properly provided for.

### Premier Speaks

LONDON, Feb. 11.—When Premier Asquith rose in the house of commons to speak of the Scott tragedy the galleries were packed. The premier declared that Scott's appeal shall not fall on deaf ears.

LONDON, Feb. 11.—Relatives are today trying to notify the wife of Captain Scott of the death of her husband. She is aboard the steamer Aorangi, bound for New Zealand, for the purpose of meeting her husband. So far communication with the vessel by wireless has not been established.

The effect of the publication of Captain Scott's final message is marked. The heroic deeds of the party are arousing the patriotic spirit of the public more than anything in recent years. A great memorial service will be held in St. Paul's cathedral.
