

KUYKENDALL IS RETAINED IN CASE

BOOTH ACTIVE IN BEHALF OF THE INDIAN

Head of Big Lumber Company, Who Formerly Conducted Trading Post at Yoncalla, in the Umpqua Valley. Having in Mind the Interests of Alien Tribesman Accused of Murder, Gets Local Attorney to Appear

Chenoweth Umpqua, Indian, will be the defendant in one of the most unusual criminal actions ever tried in Klamath county. Former acquaintances, prominent white men, are determined that, if guilty, he shall be punished to the full extent of the law, but, if innocent, he be acquitted.

D. V. Kuykendall, former district attorney, has been especially retained by former acquaintances of the Indian to appear in court during the entire trial of Chenoweth and see that every possible point for and against the defendant is brought out.

"We do not desire that the Indian be shielded," read Mr. Kuykendall's instructions, accompanied by a liberal retainer, "but we want to be sure that he gets a square deal. We want to feel sure that if he is acquitted, it was because he was not guilty, or that if he is convicted he was guilty."

The men who subscribed to the fund which will cause Mr. Kuykendall to appear in court June 23 as amicus curiae in the case in which Chenoweth Umpqua is charged with the murder of Frank Jack, are residents of the Willamette Valley, and are wealthy. Notably among them is R. A. Booth of the Booth-Kelly Lumber company, who formerly conducted a store at Yoncalla, headquarters of the Umpqua Indians. He knew Chenoweth when the redskin was a papoose, and since has followed the career of the aborigine.

"I want to see that the Indian gets a square deal," Mr. Booth is reported to have declared when he induced other prominent men to subscribe to the fund. "It does not make any difference to me whether or not he is acquitted. All I want to know is that he is not 'jobbed'."

Chenoweth is an Umpqua Indian who several years ago came into the Klamath country and affiliated with the Klamath Indians. He was employed on the reservation in different capacities, but prior to the murder of Frank Jack he worked as a carpenter.

On the night of the murder of Frank Jack a number of Indians had been in Fort Klamath, and had been drinking. Chenoweth Umpqua has been declared by his companions as having fired the shot which took the life of Frank Jack.

There have been many rumors current of sensational developments which would involve others, but no one but Chenoweth has been placed in custody.

Mr. Kuykendall's duties at the trial will be unusual. He will neither be associated with the defense nor the prosecution. His status in court will be more or less problematical. It will be his duty to his clients to insist that a fair and impartial jury be secured. Then every point favorable to the prosecution will be insisted upon. Later every point in favor of the Indian will be sought to be brought out. Messrs. Manning and Shaw will appear for the defense of the Indian, and District Attorney Irwin will prosecute.

SECOND UNIT WORK IS ALMOST COMPLETED

Work of excavating the main canals and sub laterals of the Second or Poe Valley unit of the Klamath project is rapidly nearing completion. Most of the sub contractors working under Maney Brothers will be finished the 1st of July.

Work on the Griffith lateral will be completed in ten days, according to officials of the reclamation service.

On the North and South Poe Valley laterals on the Nuss Lake lateral the same progress is being made. It is the belief of Maney Brothers that on the 1st of July seven of the nine outfits at work now will complete their schedules. The two remaining schedules will be completed in ten days' longer time.

WELL KNOWN BONANZA WOMAN PASSES AWAY

The many friends in this city of Mrs. William Goss of Bonanza were deeply grieved today to hear of her death at her home at 11:30 o'clock Friday morning.

On the evening of May 23d Mrs. Goss suffered a stroke of paralysis, and since that time was confined to her bed, the entire right side of her body becoming paralyzed. Her condition was such that her entire family was at her bedside almost constantly. On the evening of June 19th she suffered from another stroke, and from that time until the last it was apparent that her demise was but a matter of hours.

Gathered at her bedside at the time

of her death were her husband, Wm. Goss, their two sons, Robert and James, and four daughters, Mrs. Harry Nichols, Miss Dora Goss, Mrs. John Chastain and Mrs. Christ Heidtman.

Mrs. Goss was born in Tennessee in 1854, and came to this country about seventeen years ago, settling in the Bonanza country, where she has since resided, and where they have resided, and where she has made the entire community regard her as a valued friend and neighbor. Ever ready to assist in the time of need, her many friends are now giving testimony of her worth by their willing assistance to the bereaved family and their words of comfort to the distressed.

AUTO RULINGS TO BE ENFORCED

POLICE WILL SEE THAT EVERY PROVISION OF ORDINANCES ARE OBSERVED HEREFTER IN KLAMATH FALLS

According to Chief of Police Smith the automobile regulations are to be strictly enforced in Klamath Falls. All of the members of the force have been furnished with stop watches by the city, and arrests will be made of all parties exceeding the speed limit, which is ten miles per hour within the limits of the city.

All autos must carry a license number both in front and rear of the car, and front and rear lights must be carried at night. Cars must stop on the right side of the street, and all automobiles must run to intersections of streets before turning. Arrests will be made of drivers turning their car midway between blocks. All chauffeurs of hired or rented cars must have a license, and these must be displayed in plain sight on coat or cap.

The secretary of state has compiled a synopsis of the motor car laws, which is published in pamphlet form, and it is suggested that all auto owners and drivers secure a copy of these regulations, so that they may inform themselves on the law.

SIEMENS ORDERED TO PAY COURT HOUSE WARRANTS

County Treasurer J. W. Siemens must pay all warrants on the special county court house fund that are presented to him.

A peremptory writ of mandamus, ordering him to honor the warrants on the special fund, was signed Friday by Circuit Judge Benson. A copy of the writ was served on Siemens.

The peremptory writ comes as a result of the mandamus proceedings instituted against former County Treasurer Claude H. Daggett about a month ago by the county court. At that time Daggett refused to honor the checks on the court house fund.

At the time the proceedings were instituted, County Judge Worden and Attorney Drake journeyed to Lakeview, where Judge Benson was holding court, and secured his signature to an alternative writ of mandamus.

Since that time attorneys for both sides have appeared on the case, and there have been several motions argued. This morning Judge Benson signed an order making the alternative writ a peremptory writ.

Since the suit was instituted Daggett resigned as county treasurer, and Captain Siemens was named in his place. Thursday Judge Benson issued an order of revive, substituting the name of the present county treasurer.

As a result of the refusal of Daggett to pay the court house fund warrants during the litigation regarding the legality of the issue, the payroll for work on the structure has been held up for several months.

Work will be resumed in a few days on the court house construction, and the writ issued by Judge Benson today makes it positive that the workers will receive cash for their warrants without delay.
