

WEST TO REMOVE BAKER CO. SHERIFF

MISS HOBBS TO APPEAR AS THE GOVERNOR'S SPECIAL COUNSEL IN THE CASE

Girl Was Admitted to the Bar a Year Ago—Removal of the Sheriff Will Be Started Under the Statute Providing for the Removal From Office of Any Official Who Is Not Attending to His Sworn Duties.

COPPERFIELD, Ore., Jan. 3.—Copperfield is being run by the military authorities today, aided by a special committee of citizens appointed by Colonel Lawson, in charge of the detachment of militia here.

Lawson called a meeting of the citizens, and at this he issued a special order appointing the committee, which he hopes to leave in control of the situation when he departs on Monday.

S. T. Grimm, a carpenter, was chosen chairman. He will be acting mayor. There are six others on the committee.

For the time being Copperfield will continue under martial law. Should there be any disposition on the part of the saloon men to oppose the new officials, a part of the national guard will be left here.

SALEM, Jan. 3.—Governor West is making preparations to remove Sheriff Rand from his office of sheriff of Baker county and supplant him with a special officer until the situation at Copperfield is settled.

Once more will Miss Hobbs play an important role as the representative of the state's chief executive.

Governor West has wired Judge Anderson of Baker county, asking advice as to the earliest day on which a hearing can be held and the removal of Rand effected. He has advised Judge Anderson that Miss Hobbs will represent him in the proceedings as the special counsel to present the state's case.

West has also wired Miss Hobbs to remain in Baker county to attend to the matter for the state.

Miss Hobbs is qualified to represent the state in this affair, as she was admitted to the bar about a year ago.

This action of Governor West is taken under the provision of the law providing for the removal from office of any officer failing to perform his sworn duty. The sheriff can be temporarily supplanted or permanently removed under this law.

MOREY APPLEGATE WRITES OF CONDITIONS IN MEXICO

The ravages being made by Mexican bandits and the feelings toward Americans are described in a letter received here from Morey L. Applegate, son of Captain and Mrs. I. D. Applegate of this city. Mr. Applegate has been located near San Blas on the coast of Mexico for several years. He is general manager of two large banana plantations for the Pacific Fruit company. He says:

"San Blas is entirely besieged by land, and we are camped on an island out from San Blas, waiting for the town to be taken, which may occur at any hour. Both of our plantations are in the hands of the bandits. At the Canada plantation they have taken over a hundred saddle horses, and are killing all our cattle.

"They told our foreman that Americans had no right to own property in this country, and that we ought to be thankful to get away with our lives. They are sleeping in our beds, and looting the hacienda from day to day. "At Santa Cruz they have only made raids, taking arms and ammunition and robbing our foreman. He is still on the plantation looking after the bananas. We are shipping today on the Newport.

"There are three of us camped on the island: J. Perrin Kent, exporter of limes; L. L. Gates and myself, and Mr. Kent's Korean servant, besides several Mexican Mazos and their families. The United States cruiser Raleigh is anchored here for our protection, and will remain here until the trouble is over, so we are as safe as anyone could be."

SWITZERLAND WOULD BE VAST WORLD HOSPITAL

BERNE, Switzerland, Jan. 12.—In the near future Switzerland will very likely present to the powers a request that in the event of a great European war all of Switzerland be constituted into a Red Cross camp for the care of the wounded of all the nations involved. This, Switzerland is now convinced, is the only way that not only her neutrality, but her very existence could be preserved.

Although the neutrality of Switzerland is guaranteed by the leading powers, the Swiss government has recently become convinced that unless she has some actual way of insisting on the respecting of this neutrality, that in a war between any of the four great powers surrounding her this guarantee would amount to very little. In addition, she is also convinced that the first step in any European war would be the prohibition by all the powers involved of the exports of coal and provisions which they would need for their own armies. As Switzerland is entirely dependent on the surrounding powers not only for her coal, but for her grain and practically all of her food supply, the cutting off of these imports would reduce the entire country to starvation within a few weeks.

It is in the hopes of exacting a guarantee from all of the four powers surrounding her not to interrupt these imports in case of war that Switzerland is considering the project of having the entire country declared a great international Red Cross camp, and to undertake the care of the wounded of all nations in the event of any general European war. Members of the Swiss government who are backing the movement declare that this would not only insure for Switzerland the neutrality and all of the protection that is accorded by international agreement to the Red Cross camps in time of war, but it would also insure that her industries would not be ruined by the cutting off of the coal supply and her population reduced to starvation by the stopping of food imports.

The treaty to be submitted to the powers will provide that as fast as the wounded are cured they will be returned to their respective countries. This, Switzerland is convinced, would be of enough importance to any of the powers engaged in a European war to make certain that none of them would violate her neutrality by crossing the boundary with one of its armies or interfere with her food supply.

HAMMOND FACES UGLY CHARGES

In addition to threatening to kill the family of his father-in-law, S. Flescher, Charles E. Hammond committed a statutory crime upon one daughter and attempted to on another, according to testimony brought out at his preliminary hearing Friday evening. He was bound over to the grand jury.

Hammond lived in Langell Valley, and it is said that a few days ago he boasted of improper relations with the Flescher girl, following which he made his threats to kill. He was arrested and brought here, but as the information was sent by telephone, and there was no complaining witness for the preliminary hearing, he was released on this charge.

On Friday he was arrested on two separate charges, made by the two girls. Both swore that he threatened to kill them if they told of his actions. During the hearing Hammond chuckled repeatedly, and was reprimanded by Justice of the Peace Gowen.

TWO SUITS ARE FILED IN COURT

Two suits to recover money were filed in the circuit court Monday by J. H. Carnahan as attorney.

W. C. Ball has brought action against W. I. Clarke to recover \$50 alleged due for the services of the steamer Canby, and for \$96.50, which his complaint alleges is owed for towing.

In the second suit R. O. Vincent is plaintiff. He seeks to recover \$224 from J. W. and Mary DePuy.

HUERTA MUST GO IF RECOGNITION IS TO BE GIVEN WILSON'S ATTITUDE IS LEFT THE SAME

According to Executive Conference With Lind Was to Clear Up Some of the Points Left Unsettled—The Fighting at Ojinaga Is Fiercer than Ever Today, and Loss of Life Is Steadily Growing Bigger

GULFPORT, Miss., Jan. 3.—President Wilson's Mexican policy has not been modified. Huerta must go.

Until he does, the attitude of the administration will remain unchanged.

Ambassador Lind will return at once to Vera Cruz.

President Wilson is authority for the above statements. These put an end to the stories that he had finally decided to use force.

Concerning the conference aboard the Chester with Lind, Wilson says the talk was much ado about nothing. He says it simply cleared up a question over which otherwise there would have been necessary a great exchange of messages and letters.

Aside from this, according to Wilson, there was nothing talked.

PRESIDIO, Texas, Jan. 3.—The fighting at Ojinaga is fiercer than ever.

The rebels increased the fury of their assault shortly after midnight, and appeared to be gaining ground. The defenders of the town, however, are holding out gamely.

The rebels are said to be in the outskirts of the town. There are stories here of hand to hand encounters with knives, bayonets and clubbed guns.

The latest estimates place the federal dead at 400, with 450 wounded. The rebels are said to have lost 300, with 600 wounded. These figures are said to be conservative.

WOMEN'S VOTES MAKE CITY OF SAN LUIS OBISPO "WET"

SAN LUIS OBISPO, Jan. 3.—Under a ballot decision offering an interesting commentary on woman's suffrage in one California city, San Luis Obispo began today its 143d consecutive year as a "wet" center.

Two years ago, after a desperate fight, the "wets" carried the city by the narrow majority of 86 votes.

Since that election women in California have been enfranchised, and the prohibition element approached the polls December 9th confident that women voters would put an end to the "wet" ascendancy that dated from the Spanish days of California.

The count of the votes, however, provided a surprise for both factions. Not even the most sanguine liquor supporter expected the overwhelming defeat of the "dry" forces, which was accomplished with a margin of 400 votes.

AUTOMOBILE SHOW STARTS IN N. Y.

NEW YORK, Jan. 3.—Under the auspices of the Automobile Chamber of Commerce, the fourteenth automobile show opens here today in Grand Central Palace, with seventy-two makes and nearly 400 cars on view. All of the exhibits were passenger vehicles, no commercial cars being shown at the request of the manufacturers.

Exhibits took up four floors of Grand Central Palace. One of the main features of the show which opens today was the exhibit of motorcycles, or "the little brother of the automobile" as they were designated. The accessories took up nearly 20,000 feet of floor space. There was a greater display of electric vehicles than at any previous show. The exhibit will continue through January 10th.

DR. SCHAFER IS TO LECTURE HERE

EUGENE, Jan. 5.—Dr. Joseph Schafer, professor of history and head of the extension division of the University of Oregon, will deliver a free lecture on "Education as Social Adjustment," in Klamath Falls on January 17th.

Dr. Schafer maintains that the history of the world has reached a great turning point. Human society, once almost unchanging in its organization, at least when viewed by short periods, has become dynamic and subject to rapid flux and change.

Education, says Dr. Schafer, used to be for the purpose of teaching the young people the things their elders knew, of passing down to the coming generation the wisdom of their ancestors. Now, however, he maintains, this is not enough.

The young people are going to live in a world that is different from anything their parents or their teachers can possibly know about. Therefore, the schools must aim to give the student the power of recognizing and understanding strange changes as they occur, and the ability to adapt themselves to states of society about which we know little except this one thing—that they will not be like the present state of society.

FIRST SWISS GIRL TO BECOME LAWYER

BERNE, Switzerland, Jan. 3.—Switzerland today has its first woman lawyer, Fraulein Lili Zraggon, the daughter of a Bernese solicitor, who was formally admitted to the bar today, after passing all the necessary qualifying examinations, under the provisions of the new civil code. This code, recently enacted, although it does not confer the right of suffrage, has immensely improved the legal status of the Swiss women, who are now admitted to all of the professions except the ministry on the same terms as men.

After lingering at the point of death for two weeks or more, Mrs. Addie Morine was summoned beyond by the Grim Reaper Monday morning. She has been a sufferer from varicose veins for several years, and recently underwent an operation at the Blackburn hospital, where death occurred.

The funeral service will commence at 2:15 at Whitlock's undertaking

parlor tomorrow afternoon. At 2:30 the remains will be conveyed to the Presbyterian church, where Rev. Stubblefield will have charge of the services.
