RENTE FARMS PAY POOR RETURNS ON INVESTED CAPITAL

WASHINGTON, D. C., March 25.—Popular belief that the farmer who lives in the city and rents his farm is in the class with precarious plutocrats was given a severe jolt in a bulletin just issued by the department of agriculture, which shows that the average return from rented farms is but 3 1/2 per cent on the investment.

The bureau of farm management which developed these facts studied several hundred farms in Indiana, Illinois and Iowa. States in the corn belt were chosen because they excel almost all other regions in wealth of farm products.

The average labor income of the farm owners operating their own farms was \$468 for the year studied, and \$570 for the tenants.

Strangely enough, the farmers making the lowest labor incomes are on big farms, but they fall through inefficient management.

The income of the farmer who owns his farm is in direct proportion to his capital and the size of his farm.

On the cash rent basis his income is greater in a good year and less in a poor year than when he rents on the share basis.

"Egg powder" and "egg substitute" have been branded as undesirable by Dr. Carl Alsberg, chief of the bureau of chemistry, and he has refused permission for manufacturers to put such articles on the market.

Chemical analysis showed that the proposed "substitutes" were only cheap baking powder containing a considerable excess of ground rice as a filler and colored yellow with powdered tumeric.

"Pigs in clover" is more than a figure of speech, says the bureau of animal industry—it's a good investment, and the pig that shared red and white blossoms with the bumblebee is going to put more gasoline in the farmer's runabout than a less favored rooster that never stuck its snout outside of a pen.

Too often the hog is considered a scavenger, and his ability to use waste is regarded as his chief value. According to department of agricultural experts, however well he serves this purpose, it is pointed out that it will pay to give him good care, feed and housing.

The crops best adapted to grazing

with pigs are alfalfa, rape, clover, blue grass, Bermuda, rye, oats, soy beans and cow peas. The selection depends on the nature of the soil, the climate and the rain fall.

SAYS FARMER WHO SELLS ALFALFA HAY IS BIG LOSER

CORVALLIS, March 25.—The farmer who sells alfalfa hay from irrigated lands gets for it just one-half the actual value of the fertility elements that it contains, according to investigations carried on by Professor Scudder, agronomist at the Oregon Agricultural College.

"It is thus seen," says Mr. Scudder, "that the common practice of selling alfalfa and clover hay from irrigated fields is ruinous from the standpoint of fertility."

"Alfalfa and clover are raw products which the cows and pigs convert into finished form, leaving valuable by-products to enrich the soil.

MUCH RED TAPE
LETS TOWN BURN
BRUSSELS, March 25.—The Belgian customs officers on the French frontier to use more common sense and less red tape in the future.

While they were arguing the fire, which was only 100 yards from the frontier are to use more common sense the officers compromised by allowing them to string a line of hose across the border, the engine remaining on French soil.

CAN SEND PRODUCE BY PARCEL POST
WASHINGTON, D. C., March 25.—An order permitting the shipment of eggs, poultry, butter, vegetables and fruit by parcel post has been signed by Postmaster General Burleson.

While commenting on the new order, Mrs. Elliott Logan, president of the Federation of Women's Clubs in the District of Columbia, said: "The postmaster general's order has struck the high cost of living a terrific blow."

ENGLISH CABINET CLOSE TO A FALL

SEELEY SENDS IN HIS RESIGNATION TODAY

Premier Asquith, Though, Refuses to Accept the War Minister's Resignation, Saying the Cabinet Must Stand or Fall Together—Fight Is Carried to Floor of Cabinet, and Hot Words Are Used.

LONDON, March 25.—As a result of the recent upheavals over the Ulster affair, Premier Asquith's cabinet is on the verge of a fall.

War Minister Seeley has tendered his resignation on account of the stand taken by Asquith, and it is understood that Lloyd George also plans to retire.

Late this afternoon Asquith announced that he would not accept the Seeley resignation. He indicates that he intends to have the whole cabinet stand or fall together.

Seeley, before the house of commons, hotly denied the rumor that the king interfered with the army row. Asquith placed the blame on Seeley, and he accepted it.

After Minister Churchill had admitted that battleships were sent to Irish waters as a precaution, he was asked by L. A. Amery if he "hadn't hoped this precaution would lead to bloodshed."

Churchill advanced toward Amery, shouting: "I will repudiate this hellish insinuation."

The speaker rebuked Churchill, and the house of commons was thrown into an uproar.

START CONCRETE ON LIBRARY JOB

Work on the Carnegie Library being erected on the new court house block, is progressing more rapidly than expected this season.

It was thought that cement work would not start until April 1st. The library will cost \$24,000.

SCHOOLS HOLD PEACE MEETING

Before the debate Tuesday night, or rather, before Principal Faught of Klamath high school and Principal A. L. Barker of Marshfield high school compared letters and telegrams from the state chairman of debating committee, a feeling far from friendly existed between the two schools.

The letters and telegrams sent by Chairman Prescott to Mr. Barker at Marshfield were so worded as to leave the impression that Mr. Faught was taking every advantage of a delicate situation. On the other hand, the state chairman worded his letters and telegrams to Mr. Faught in a way that left no room to doubt that Mr. Barker was trying to have everything arranged to suit Marshfield.

Naturally each was suspicious of the other. When the letters and wires were placed side by side, matters looked different, and the two principals immediately expressed mutual regrets for the misunderstanding, each admitting that the other was perfectly justifiable in forming the opinions that had been expressed.

Mr. Faught declares today that Mr. Barker is one of the fairest men he ever met, and that the difference in the wording of the letters caused all the trouble.

K. C. H. S. WINS FROM MARSHFIELD

The Klamath county high school debating team, Forrest Piel and William Hagelestein, is still a factor in the contest for the state high school championship. In fact, since Tuesday night, it is a still stronger factor, for the debate with the Marshfield high school team was decided in favor of the local men.

This eliminates Marshfield from the race and strengthens Klamath high. It is understood, though not definitely known, that following the defeat of Marshfield, Klamath high will debate Oregon City high at Eugene for the state championship.

"Resolved: That the general welfare of the United States would be fostered by a complete application of the policy of tariff for revenue only," was the question argued. The local men supported the negative.

Forceful arguments were made by Piel and Hagelestein, and by Chester Isaacson and Cecil Robertson for the visitors. The judges were J. B. Wells, W. J. Douglas and E. J. Kaiser of Ashland, while Judge Benson acted as referee.

TWELVE OREGON CITIES PREPARE TO FIGHT FLIES

EUGENE, aMrch 25.—Twelve Oregon cities are pioneering in the spring anti-fly campaign. A fresh city writes for instructions to the State University extension division almost every day, but in the original twelve the campaigns have been arranged for. The twelve are:

Salem, Portland, Roseburg, Forest Grove, La Grande, Pendleton, Medford, Eugene, Monmouth, Astoria, Drain and Creswell.

In about a week the University will have ready for distribution 10,000 bulletins. These bulletins will tell Oregon communities how to proceed in fly campaigns. Meanwhile, Dr. Clifton F. Hodge, professor of social biology, who is originator of the idea in this state, is giving directions to Eastern Oregon towns.

Women's organizations are commonly first to take up the fly campaigns. Immediately the organization tries to enlist the city officials. Appointment of a deputy with police authority, who is expected to see that places where flies breed are cleaned and kept clean, is next sought. In Roseburg the women's auxiliary of the Commercial Club is leading the fight.

The bulletin will contain specifications for the easily made and inexpensive fly trap that has been such a factor in making campaigns elsewhere a success. Use of traps early in the fly season is essential. One such trap will frequently catch all the early flies in a small neighborhood, if properly baited.

STARR CONVICTED OF ARSON CHARGE

Joe Starr was late Tuesday afternoon convicted of setting fire to the E. E. Byers house on Ninth street last month. He will be sentenced tomorrow morning by Circuit Judge Henry L. Benson.
