

Seaside man gets probation after June standoff

A Seaside man will serve probation following a standoff with police in June.

Shaun Mitchell Scarborough, 28, pleaded no contest to one count of felon in possession of a firearm and will serve three years of probation. A plea agreement with the Clatsop County District Attorney's Office stipulates

that he serve more than 3 1/2 years in prison if he violates probation.

Scarborough allegedly held a kitchen knife to his throat for nearly two hours in early June as Seaside police attempted to arrest him at an apartment on South Columbia Street. After a standoff lasting more than an hour, he eventually was struck by a stun gun and arrested.

Police initially responded to a report of a physical disturbance be-

tween Scarborough and his mother at the apartment. But Scarborough was gone when police arrived, and no charges resulted from the original report.

After neighbors reported seeing him drive recklessly, officers located a silver Audi that Scarborough had been driving. A handgun was allegedly found inside, and Scarborough is a convicted felon.

Scarborough was then seen fleeing

back toward the apartment on South Columbia Street. Police located Scarborough in the kitchen as he held the knife to his throat, taking cover outside the entrance to the room. Following a lengthy conversation, police were able to get close and use the stun gun.

Scarborough also faced interfering with a peace officer and reckless driving charges before agreeing to the plea deal.

Two people, pets evacuated from burning home

A man, woman and two pets were evacuated from a home on Lewis and Clark Road following a three-alarm fire early Saturday, Nov. 4.

Fire personnel responded to the home on the 87000 block of the road shortly after

2:15 a.m. When they arrived, firefighters evacuated a man from the balcony of the home and a woman who slipped and fell as she ran inside to collect belongings. Adding to the challenge was a steep driveway on the property and a lack of a nearby water source, Gearhart Fire Chief Bill Eddy said.

Firefighters were finally

able to contain the fire after roughly two hours.

"It was a very, very tricky one," Eddy said.

No injuries resulted from the fire. The damage to the structure and other items in the homes is estimated to be between \$90,000 and \$120,000.

Eddy said a wood stove chimney was the likely cause.

Nona Jane Johanns passed away Sept. 10, 2017, in Glendale, Arizona. She was born in Mitchell, South Dakota, April 18, 1921, to Glenn and Mary Smith. Nona and her identical twin sister, Zona, grew up with their older brother, Richard. In 1951, Zona passed away at 30 years of age.

Nona married Lawrence (Larry) J. Johanns, Oct. 20, 1994. Mr. Johanns owned and operated the Seaside bumper cars. She continued to enjoy her life as the two families blended together. Larry passed away in 2006, and in 2012, Nona moved to Phoenix, Arizona.

She is survived by her two daughters, Jacqueline (Jackie) J. Olson of Wilsonville, Oregon, and Susan K. Sands of Phoenix, Arizona; her son, Mitchell (Mitch) K. Mooney of Frisco, Texas; one stepdaughter, Kristin Futter; 13 grandchildren; 23 great-grandchildren; six great-great-grandchildren; and two nieces and two nephews. She left a legacy of faith, love and integrity to those who survived her.
