Jerry Bowman, Curator of the Northwest Carriage Museum will be the featured speaker at Seaside Museum's History and Hops at 6 p.m. on Feb 27 at Seaside Brewing Co. Bowman, known for his vast knowledge of horse drawn vehicle history and restoration will talk about 19th-century transportation and share stories about the museum's collection. The Northwest Carriage Museum in Raymond, Washington, boasts one of the finest collections of 19th-century horse-drawn vehicles: including carriages, buggies, sleighs, wagons, and historical artifacts. The museum was opened in 2002. Bowman and his wife, Laurie — the museum's executive director — moved to Raymond 17 years ago and joined the museum
