New 74 unit development receives approval Business Directory

Pedestrian, traffic safety measures required

A 74-unit apartment complex received conditional approval from the Seaside Planning Commission last Tuesday.

The property comprises about 4 1/2 acres and is located near the TLC Fibre Federal Credit Union building near Neawanna Creek. Neighboring businesses include Randall Lee's Flooring America, Ticor Title and Seaside Car & Boat Wash.


Lots would be sold to builders, with apartments anticipated to be leased at \$1,200 to \$1,400 a month. The facility will include nine six-unit buildings and five four-unit buildings.

In addition to the original staff report's findings, the Planning Commission added additional conditions.

The examples of pedestrian safety measures that were provided by the applicant's traffic engineering firm must be incorporated into the access at North Roosevelt Drive.

Commissioners asked for improved lighting at the north and south ends of the crosswalks, flashing crosswalk signs and reflective thermoplastic in pedestrian right-of-ways. A warning sign could be installed on a northbound turn lane of U.S. Highway 101.

In a separate condition, the owners are asked to approach nearby property owners to rename the private access road for fire department identification. The road could be named Cross Creek Lane, Way or Drive, subject to the approval requirements of Clatsop County's

surveyor and acceptance by the other abutting owners. If this name is unacceptable, the alternative name must be approved by the Planning Commission at the time the final plan is reviewed.

The site is zoned residential high density, which allows the development, according to the transportation impact study prepared by property owners. Owners received an approval letter from the Department of State Lands for the wetland delineation, according to the developer.

The complex would use the existing, shared driveway serving the nearby commercial spaces, according to the study. The study also says the site access and sidewalk configuration provides efficient access and circulation for anticipated pedestrians, bicycles and vehicles. In July, commission-

ers sought details about the impact to traffic and pedestrians at the Highway 101 intersection. Signage, lighting and

striping could enhance pedestrian safety, said engineer Adam Dailey, including a 9-foot-wide crosswalk at the intersection or slow or right-turn arrows.

"It gives the driver kind of a visual cue," Dailey said. "They subconsciously even tense up and slow down."

Lights that are 50 feet off the crosswalk could be moved closer, he said. Maintenance of the vegetation around the area could also improve safety.

Owners must also provide short- and long-term bike parking. They will have to determine the planned drainage, sewer and water systems for review by the Seaside Public Works director.

Commissioners Jon Wickersham, Kathy Kleczek, Christopher Rose and Robin Montero voted for the conditional approval. Seth Morrisey and Lou Neubecker abstained; Teri Carpenter was absent.


