

Get out of jail free? No, but a pass is inexpensive

If you want to stay out of jail August 5 during Jamboree, you had better buy your insurance policy before that date. Your policy, otherwise known as your Get Out of Jail Free card, will be sold around town by the Vernonia High School cheerleading squad.

The cards are available for \$1 from any of the following members of the squad: Julie Parrow, Jamie Stacklie, Jessica Stacklie, Erin Davis, Sarah Lynch, Pearcia Blum, Amy Vandehey or Stephanie Squires. If you are "arrested and jailed" during Jamboree, bail will be set at \$3. If you have no card and no money

to bail yourself out, your maximum jail time will be a half hour.

On the other hand, if there is someone you would like to put in jail, you can report to the posse at the jail, located in the Scrub Tub on Bridge Street next to Jamboree Committee Headquarters.

Incidentally, in the hard-nosed attitude of the old West, there will be no refunds on unused Get Out of Jail Free cards.

Appropriate jail attire will be provided.

Those who will not be arrested include children under

the age of 12 years.; Police and Jamboree officials; anyone suspected of intoxication.

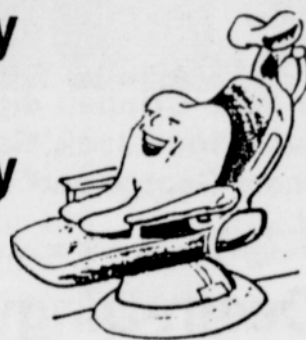
