

## Vernonia Police report

Abbreviations: MIP, Minor in Possession of Intoxicants; DUI, Driving Under the Influence of Intoxicants; CCSO, Columbia County Sheriff's Office jail; OSP, Oregon State Police; MVA, Motor Vehicle Accident.

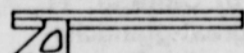
