### Two injured in collision on Hwy. 47

A sleepy driver apparently caused a glancing head-on accident about 3-1/2 miles south of Vernonia on Nehalem Hwy S., Feb. 7, sending both drivers to the hospital.

Shortly after 6:00 a.m., Alaeeta Uerling, Vernonia, apparently fell asleep while driving south in a Geo Metro, and drifted across the center line, hitting a northbound Ford F250

pickup driven by Gerald Witham.

Witham was taken by Metro West-Vernonia ambulance to Emanuel Hospital. Uerling initially declined medical attention and went home. Later she called and was taken by ambulance to Emanuel. Both drivers were released the following day.

The accident closed the highway for about 25 minutes.
