

### Students invited to submit art work

Artwork, poetry and essays by local students are being sought for display with an upcoming exhibit on Martin Luther King, Jr. The exhibit will be held May 2 - May 24 at the Columbia Center in St. Helens.

Martin Luther King, Jr. and the civil rights movement of the 1950s and 60s is the subject of the exhibit, which consists of black and white photography, facsimiles of landmark documents, quotations from the speeches and writings of Dr. King, and brief narrative texts. A companion exhibit, "The Road To The Promised Land," describing the political legacy of the 1960s by facing the issues of labor struggle, feminist activism, Native American activism and the continued struggle against race-biased culture, will be shown at the same time.

The exhibit is free and open to the public.

Columbia County students are invited to submit artwork or written pieces on any aspect of the civil rights movement. The deadline for submissions is April 21. For further information, contact Abby Dawson at 397-5406, or Columbia County Citizens for Human Dignity, at 543-8414.
