Teens will need proof of schooling to obtain Oregon driver's license

Proof of school attendance, completion, or exemption will be needed by youths under the age of 18 who apply for driving privileges starting Sept. 1. Various documents can confirm compliance with the law, including a diploma or GED certificate, or a Statement of Enrollment from the school showing the student is making satisfactory progress toward a GED or high school diploma. Those who are home-schooled or exempt from attending school must get a written statement from their local school district or county Educational Service District. The form will be needed only for the initial permit or license unless the license is


cancelled, revoked or suspended for non-attendance in school. Oregon school districts also have the option of having a student's driving privileges suspended if the student has withdrawn from school.
