States, it is not covered by U.S. regulations of 900 numbers, which require that you be notified and warned of charges and rates involved when you call a "pay-per-call" number. Furthermore, 900 number blocking will not block 809 phone calls.

"We recommend that no matter how you get the message, if you are asked to call an 809 area code, investigate further or disregard the message," said Walters.

Be wary of e-mail or calls asking you to call an 809 area code number. It's important not to make these calls to begin with, because the charges are almost impossible to fight. Since the billing comes from a foreign company, little can be done to eliminate the charges.

Michael W. Reed, 26, Vernonia, found guilty of interfering with officer and disorderly conduct; 240 days jail suspended, 18 months probation, no alcohol, \$2000 fine suspended, \$272 fees.

Grace V. Ray, (no age given), Vernonia, found guilty of criminal

trespass I and criminal mischief III; 270 days jail, suspended, 1 year bench probation; alcohol evaluation, no possession or use of alcohol for 1 year, \$372 fines. An additional charge of criminal trespass I will be dismissed when above terms are met.

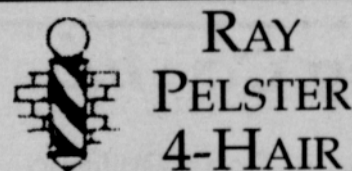
