Antonio Martinez-Recendiz, 32, Banks, entered no plea to harassment charges; will consult court appointed attorney.

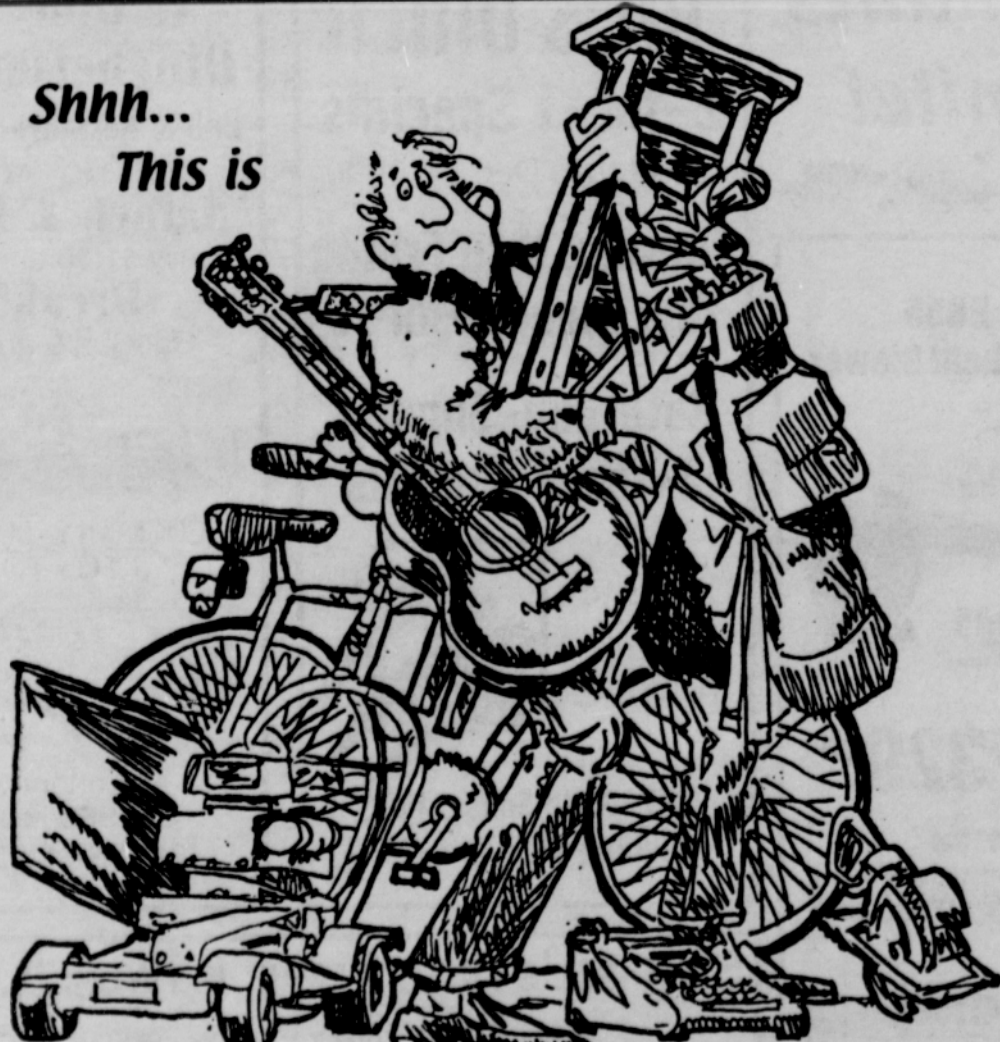
Jeffery Wilkerson, (no age given), Vernonia, pled no contest to contempt of court charges; sentencing on Dec. 5.
