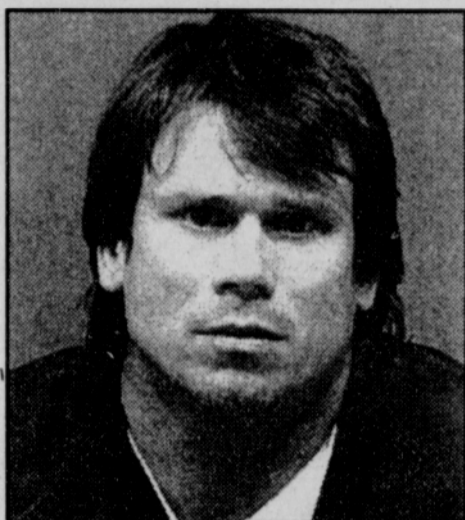
morning hours.
