

Notification of Vernonia man on sex offender list

In accordance with state law, the community is being notified by Columbia County Community Corrections that Stanley Smith, 43, 1182 Cherry Street, Vernonia, is on probation for sex offenses. He is 6'1", 175 lbs., has black hair, and brown eyes. According to Columbia County Community Corrections, his target victims are minor females.

Smith is allowed no contact

with minors or where they congregate, must undertake sex offender treatment and polygraph testing, is not allowed pornography or sexually explicit material. He may not possess or consume alcohol, or be present at bars, taverns, OLCC outlets or any place where the sale of alcohol is the primary business.

Smith is allowed contact with children, Christina and Sarina
